#### **IMPORTANT INFORMATION ABOUT THIS YEAR'S REPORT:**

We are currently in unprecedented times with education navigating the health and safety components of COVID-19. In August 2020, the legislature passed SB-820 which provided guidance regarding Williams Case legislation (signed by Governor Newsom in September, 2020). SB-820 waived the requirement to monitor and inspect in person the identified schools while in-person instruction was not being offered. It allowed county offices of education to collect the required information through documents and surveys. The legislationIt also waived the requirement to have unannounced visits for 25% of the school sites on the identification list. The Williams team at Santa Clara began making plans in July 2020 to accommodate these changes during school closures in Santa Clara county schools. Our team worked closely with district and site administrators to gather all the information needed to create this report to you.

#### Introduction

Williams v. California was a class-action lawsuit filed May 2000 claiming the state's poorest children were being denied equal educational opportunities. The suit alleged that public school students lacked equal access to instructional materials, safe and decent school facilities, and qualified teachers. Settlement of the lawsuit in August 2004 resulted in a package of laws — known as the "Williams legislation" — ensuring that all students have the basics of a quality education.

This report summarizes the 2019-20 findings of specific monitoring responsibilities of the County Superintendent of Schools as identified by the Williams Settlement and subsequent legislation in four key areas:

- 1. Instructional materials Students must have sufficient access to standards aligned materials or textbooks;
- 2. Facilities maintenance Schools must be in "good repair" (safe, clean, and functional);
- 3. **Teacher credentialing** Teachers must have proper certification or training, especially for classes with 20% or more English Learners (EL); all classes must be assigned a permanent teacher of record; and
- 4. **Public reporting** School Accountability Report Cards (SARC) must include information on Williams; non-compliance with Williams must be incorporated in Uniform Complaint Procedures and classroom posting of notices.

### Instructional Materials: Students must have sufficient access to standards aligned materials or textbooks.

All Decile 1-3 schools must be visited within the first four weeks of the school year. A sampling methodology is used, in which at least one in every five classes in every section, by grade and/or by subject, is visited by a Williams monitor to determine that each student has a district adopted, standards aligned textbook for use in class and at home. Facilities Maintenance: Schools must be in "good repair" (safe, clean and functional)

All Decile 1-3 schools are subject to facilities inspection by staff from the SCCOE. The inspections are conducted by teams using the Facilities Inspection Tool (FIT) developed by the California Department of Education's Office of Public School Construction to determine if a school is in "good repair" as defined by Education Code Section 17002(d) and to provide a rating of its condition. The FIT was first used in 2007 and was revised in 2009. The FIT evaluates school facilities in 15 areas and an overall "good repair" rating is determined according to the following standards:

#### **Teacher Credentialing**

Teacher credentialing is monitored during the 2019-20 school year and teacher vacancies is monitored during the first semester of the 2020-21 school year.

\*\* **NOTE:** CCTC is in the process of switching over to a new system and credentialing reviews are in process for determining mis-assignments and vacancies. <u>AB 1219</u> changed the reporting requirements to CCTC. Now, all schools are monitored, not just Wiliams schools. Credential information for 19-20 is still being analyzed by the CCTC under the new process for collecting data through CALPADs and then transferring into CALSAAS. The 2019-2020 Assignment Monitoring began on October 2, 2020 and will be reported in Spring 2021 by CCTC.\*\*

# **Summary of Findings**

Based upon the 2013 Base API results, there were 44 schools in 10 school districts that were selected for instructional materials and facilities monitoring that required physical inspections. Two of those schools closed in June 2018, reducing the number of schools to 42 in 10 districts. The 42 schools had a combined 2019-20 enrollment of 26,959. Instructional materials and facilities monitoring was conducted during fall 2020 based upon a list of Deciles 1-3 schools according to 2013 Base API scores as provided by the California Department of Education.
