She also asked if the allocation for Mental Health Services in the Budget Allocation Plan was increased due to the current COVID-19 pandemic. Mr. Leo Mapagu responded to say that the dollar values on the report is a set amount that the SELPA receives, and the allocation is just how it is distributed between San Jose Unified SD and SCCOE SpEd. The report only outlines the allocation, and it is not a determination of service provision.

The public hearing was closed at 1:38 p.m.

Note: An amendment to the Public Hearing was made at 1:54 p.m. It was re-opened to allow additional public comment from Ms. Kristen Brown who was unable to speak earlier due to technical issues during the online meeting. Ms. Brown commented that the percentage of State and Federal funding is not reflective of what was promised by both sources. She admonished council members to support Sen. Kamala Harris in her efforts to make public education more equitable.
