Dr. Teresa Shipp, Assistant Superintendent of Educational Services, Dr. Jennifer Ann, Executive Director of Special Education, and Dane Caldwell-Holden, Executive Director of Alternative Education presented the mid-year report on the Local Control Accountability Plan.

#### 10.BOARD COMMITTEE REPORTS

Dr. Mary Ann Dewan, County Superintendent of Schools, provided an update from the February 7, 2024, Budget Study Committee meeting. The Committee heard presentations on the Governor's January Budget Proposal, SCCOE's budget development and financial planning process, and Special Education enrollment and program cost trends.

President Berta reported that the Warmenhoven Advisory Committee met on January 12, 2024. At the meeting, Inclusion Collaborative introduced new staff and reviewed

their statement of purpose. Participants shared community and program updates. Student presentations included those by Parvin Balasingam (Special Needs Awareness Program) and Rhea Sandir (Snowflake Learning). The Inclusion Collaborative Annual Report, data on warmline usage, upcoming events, and updates on a recent grant award were shared. The next Advisory Committee is scheduled for May 3, 2024.

## 11. COUNTY BOARD OF EDUCATION MEMBER REPORTS

#### Trustee Lari

• Reported working on a public health series with the League of Women Voters. The next event is *Death vs. Dollars: How Can We Deal with Chronic Disease – Long COVID, Lyme & Tick-Borne Diseases, Asthma?* The event will be hosted via Zoom on February 12<sup>th</sup> at noon.

### Trustee Sreekrishnan

- Met with the Santa Clara Reading Coalition on Friday, February 2, 2024.
- Met with student Thy Hope Luong to discuss the Doxxing Resolution that the Board approved earlier in the evening.
- Reported ongoing conversations about the possibility of a Student Advisory Board with Dr. Dewan, her staff, and students from the community.

• Provided a keynote address at the Santa Clara County Service Center's Annual Board Member's Dinner.

### 12. SUPERINTENDENT'S REPORT

- On February 5, 2024, Dr. Dewan presented at Children and Youth Behavioral Health Initiative's kickoff webinar for School-Linked Partnerships and Capacity Grants. The Santa Clara County Office of Education, in partnership with the Sacramento County Office of Education, will oversee fund distribution to all 58 county offices of education (COEs) and will provide training and technical assistance to help COEs successfully implement a statewide multi-payer fee schedule for school-linked behavioral health services.
- On February 5, 2024, Dr. Dewan participated in an Educational Revenue Augmentation Fund (ERAF) Call to Action Info Session hosted by County Supervisor Cindy Chavez and County Executive James Williams. This was to address a consideration in Governor Gavin Newsom's January budget proposal that could impact the County of Santa Clara's budget and the budgets of 15 local cities and 11 special districts. It would not impact the SCCOE's budget, but

SCCOE will continue to monitor it as it may impact services on which our families rely.

- Reported working with a local student, Anushka, to conduct research on student advisory councils and commissions. Based on this research, staff are exploring the possibility of establishing a student or youth advisory council during the 2024-25 school year. Dr. Dewan thanked Anushka for her research and partnership in this work and Trustee Sreekrishnan for making the introduction.
- As a follow-up to an inquiry from the Trustees about the use of SCCOE facilities, Dr. Dewan shared the Conference Center's brochure on the SCCOE website with information about available spaces and the process for submitting a request. The link will be included in the weekly.
- Requested that Board members save Tuesday, April 2, 9-4 p.m. as a possible SCCOE Sacramento Advocacy Day. During SCCOE's Advocacy Day, we will advocate on legislative budget issues, connect with elected legislators and highlevel education staff, as available, and emphasize the relevance of key legislation.
- Requested the Board Members save the date for the upcoming SCCSBA
   Legislative Brunch on Saturday, March 9, 8 a.m. 12 p.m., at Fremont Union High
   School District.
- Reminded the Trustees that they are cordially invited to join us at this year's
   Asset Champions Breakfast. The event will occur on Friday, March 15 at the
   Santa Clara Convention Center and RSVPs are required by Friday, February 9th.
- Dr. Dewan shared that she has been in ongoing conversations with Amanda Hawes from the Safe Jobs Coalition. Together, we are developing a communication plan to raise awareness about this research initiative.
- The California Teacher Credentialing Department conducted a successful site visit of SCCOE's Educator Preparation Programs, which is done periodically.
- Reported a successful Silicon Valley Reads Kick-off and provided a reminder that Silicon Valley Reads continues through March.
