8. INFORMATION ITEMS

A. Annual Training: Brown Act

Marcelo Quiñones and Mary Hanna-Weird from the Office of County Counsel provided training to the Board Members on Government Code Section 54950 (the Brown Act). This annual training is provided in accordance with BB 9005 (Code of Conduct) and BB 9240 (Board Training).

CHANGE IN AGENDA ORDER

Dr. Dewan requested a change in agenda order to allow the staff from the Workability 1 and Environmental Literacy programs to present before the presentation on Educare.

C. Workability 1 and Environmental Literacy Presentation

Roan Louie, Program Manager – Vocational Education, presented on the Workability I program funded by the California Department of Education. This program provides comprehensive pre-employment skills training and employment placement for high school and post-secondary students in special education. Annie Wulczynski, Gardening Instructor, presented on the Special Education Environmental Literacy Program located at seven sites for students ages three (3) through twenty-two (22). Ms. Louie and Ms. Wulczynski also presented on the collaboration between their two programs with respect to the Hester's Helping Hands student-run business.

B. Educare California at Silicon Valley (ECSV) Reimagining and Role of SCCOE

Dr. Teresa Shipp, Assistant Superintendent of Educational Services, and Shawn Gerth, Executive Director of Educare California at Silicon Valley (ECSV), provided an update on changes at ECSV and the reimagining of SCCOE's role. Since 2019, ECSV's leadership has been engaging in a long-term strategic planning process which has led to the decision that a partner organization would be selected to operate the Educare site, while ECSV shifts to a low footprint "Friends Of" role. Through a rigorous process, SCCOE has been selected to be that operator beginning July 1, 2024.

D. Charter Schools Update

Dr. Dewan announced that a three-year \$8.25 million grant was awarded to Rocketship California, which operates Rocketship Public Schools in Santa Clara County. The Stronger Connections Grant is from the California Department of Education and will help students and families meet their wholistic needs. Rocketship has identified social emotional learning, mental health and wellness services, family engagement, and efforts to address absenteeism as a focus for this funding. Dr. Dewan congratulated Rocketship on this news.

E. Overview of Budget Development and Fiscal Planning

Stephanie Gomez, Assistant Superintendent of Business Services, presented on SCCOE's budget development and fiscal planning process. She focused on some of the factors and assumptions SCCOE uses when developing the budget, as well as the timeline.

9. BOARD COMMITTEE REPORTS

Trustee Mah provided an update from the February 13 Head Start Policy Council meeting. She reported being in another meeting also via zoom at the same time but was able to report that as one of the first meetings of the year, introductory topics were covered for the benefit of new members.

Trustee Lari provided an update from the February 13 Strong Start Coalition meeting. Members heard a presentation by Amanda Dickey, Executive Director of Governmental Affairs at SCCOE, on the Governor's January Budget Proposal and SCCOE's legislative priorities and sponsored legislation. Attendees also heard from Anna Powell, Senior Research and Policy Associate at UC Berkeley's Center for the Student of Child Care Employment, on the center's research into family, friend, and neighbor care. Dr. Matthew Tinsley, Manager of Early Learning Initiatives at SCCOE, invited members to thank the Governor for the proposed extension of the increased reimbursement rate for childcare providers in his January budget. The next meeting is scheduled for March 10, 2024.

10. COUNTY BOARD OF EDUCATION MEMBER REPORTS

Trustee Lari

 On February 12, Trustee Lari organized and co-moderated a panel on Infection Associated Chronic Conditions. The panelists discussed long COVID, Lyme disease, and other conditions, and noted the risk to children.

- On February 21, Trustee Lari was a team lead for Lyme Advocacy Day with legislators. The effort is seeking more funding for therapeutics and diagnostics.
- On March 9, the League of Women Voters is hosting an event that will cover the intersections of Health and Education, Health and Housing, and Health and the Environment. Dr. Dewan will be speaking on Education and Health.
- Trustee Lari noted that March 8th is International Women's Day and the theme is "Inspire Inclusion." She also acknowledged the upcoming start to Women's History Month.

Trustee Mah

- Trustee Mah attended the Silicon Valley Community Foundation Child Advocacy Network (CAN) meeting. Participants discussed legislation and the candidate forums that have been held to reinforce the importance of early learning.
- On February 9, Trustee Mah attended the Challenge Team meeting in north county. Ted Lempert, President of Children Now, presented on the organization's legislative work and handed out copies of the California Children's Report Card.
- On February 15, San Mateo County Office of Education hosted a Summit for Partnership in Education called *Elevating Racial Justice in San Mateo County*. There was a focus on Pacific Islander groups and existing efforts on equity.
- Trustee Mah also recommended the Library tab within BoardDocs which has some useful resources.

President Berta

• On February 10, President Berta served as a judge at East Side Union High School District's STEMpalooza! 2024 event. The event was a success with nearly one thousand students, staff, community members, and industry partners participating. She expressed her gratitude to all the participants as well as Vanessa Vitug, ESUHSD's Science Coordinator, and Sergio Diaz-Luna, ESUHSD's Director of Communications & Community Engagement.

11.SUPERINTENDENT'S REPORT

On February 10th, SCCOE held the Step into an Education Career event from 9 a.m. to 1 p.m. The event supplied information about the various credentials and child development permits and how to achieve them. Information was shared about

financial aid, compensation, retirement, and benefits; and an opportunity to hear about the various university, community college and teaching programs available to the attendees. The attendees had the opportunity to speak to credential experts and talk with the eleven community colleges and universities along with our EPP program to answer personal questions. There were 136 attendees (121 registered & 15 walk-ins). Dr. Dewan thanked Michelle Fine in SCCOE's Human Resources department and all the volunteers and participants for a great event. The next event will be on August 17, 2024.

Dr. Dewan reminded Board Members that SCCOE is making preparations for Sacramento Advocacy Day on April 2, 2024, from 9 a.m. to 4p.m. All Board Members are invited to participate. RSVPs are needed soon so that the day can be properly agendized if more than a quorum plans to participate.
