President Berta reviewed the livestream details for the April 17, 2024, Board meeting and explained where to call to listen to the meeting in Spanish or Vietnamese or view ASL interpretation.

2. SPECIAL RECOGNITION

Trustee Di Salvo introduced Nathan as the Student of the Year in the Alternative Education Program. He noted Nathan's leadership at the school, his perseverance, and dedication to others. Nathan received a plaque signed by the Board President and County Superintendent of Schools, as well as an iPad.

Trustee Mah introduced Emma Shenefiel as the Santa Clara County Office of Education Volunteer of the Year. Emma was honored for her dedication to helping youth succeed at our Walden West Outdoor School Program. She received a plaque signed by the Board President and County Superintendent of Schools.

Trustee Lari introduced Juvencio Montiel as the Santa Clara County Office of Education's April Employee of the Month. Juvencio is the Lead Custodian in General Services and was selected as the Employee of the Month for his professionalism and commitment to service. He received a plaque, a cross pen, and reserved parking space.

3. STUDENT BOARD MEMBER REPORT

Student Board Member De La Rosa Aguilera shared the following updates:

- In the past month, he has initiated college coursework, started working toward the State Seal of Civic Engagement, and earned Student of the Month at Osborne School. He expressed his gratitude for the individuals who have supported him in these achievements. He thanked Principal Santillán for his support of athletics at Osborne.
- The cheerleading squad from Blue Ridge recently performed for parents and school staff. Student Board Member De La Rosa Aguilera thanked Mr. Camilleri, Ms. Law, and Ms. Enqueros for their support of the program.
- At Blue Ridge, the LiUNA program completed another cohort in March. Eight students were able to earn CPR/First Aid, OSHA 10, MC3 and other certifications.

- Student have also been working on a fire suppression project that involves learning about and implementing construction techniques taking into account ADA compliance, water drainage, and other factors.
- The Pro-Com Athletics League has reached the end of the basketball season.
 The championship game is schedule for April 18, 2024, between the San Jose
 Job Corps vs. Mt. Monguna at Willard gym in Gilroy. At the semi-final game,
 South County Community School put up a great effort against the team from
 San Jose. Thank you to Assistant Superintendent Shipp for her attendance and
 support.
- Osborne students recently took part in a national program that teaches students about the importance of clean water, air, and the environment. Retired Santa Clara County Justice Wong introduced the program to Osborne school.
- Through Trout in the Classroom, students at Osborne were responsible for hatching trout eggs and raising the young fish until they were ready to be released. Osborne teacher Ms. Hernandez received a specific certificate from the State of California allowing them to raise the trout eggs. Last week, Mr. Santillán and the Sunol Community School students released the eggs in Sandy Wool Lake in Milpitas.
- Student Board Member De La Rosa Aguilera thanked the Santa Clara County Office of Education for supporting all of these programs which support students academically, socially, and emotionally.

6. ACTION ITEM

A. Request Approval of the Budget Revisions for the Month of March

Stephanie Gomez, Assistant Superintendent, Business Services, presented on March 2024 budget updates. During the month of March 2024, expenditure budgets were increased by \$2,375,125; revenue was increased by \$2,235,125; and fund balance was decreased by \$140,000. She highlighted the increases in restricted revenue in the amount of \$1,300,585 which was allocated to support the following initiatives:

- \$600,000 for the Teacher Residency Implementation and Expansion (TRIE) Grant to support a collaborative partnership with one or more Commission-approved teacher preparation programs offered by a regionally accredited institution of higher education (IHE) to implement a new or expand an existing current residency program.
- \$431,921 Tobacco Grant Program to implement restorative practices at all Santa Clara County schools by providing countywide trainings, media awareness campaigns and public education outreach to families on underage tobacco use.
- \$268,664 CalFire Department of Forestry and Fire Protection Green Schoolyard Planning Grant for SCCOE's South County Annex and Sunol campuses to create green schoolyards to protect the health, well-being, and

provide educational opportunities to children most vulnerable to increasing temperatures and extreme heat across California.

7. INFORMATION ITEMS

A. Board Priorities Update

Dr. Dewan introduced the Board Priorities Update item as an opportunity for members of the Superintendent's Cabinet to update the Board on some of the activities from the first quarter of the 2024 calendar year that align with the six Board Priorities. Cabinet members presented as follows:

- Associate Superintendent Bonduris presented on SCCOE's efforts to support
 child wellness through the implementation of s fee schedule that would
 allow for billing of mental health services provided at schools. A student and
 member of the Student Wellness Advisory Group (SWAG) also presented on
 SWAG's work to raise awareness and destignatize mental health treatment.
- Assistant Superintendent Gomez presented on the Board Priority of Early Learning and Care. She shared two important areas of work: the continued support of the early learning workforce through the Educator Preparation Program and the construction of the Early Learning Center at Ridder Park set to open Fall 2024.
- Assistant Superintendent Gorgulho presented on the Board Priority of Literacy and Academic Achievement. She highlighted SCCOE's work as one of the lead agencies for the California Collaborative for Learning Acceleration.
- Assistant Superintendent Shipp presented on the Board Priority of Special Education, Court, and Community Schools. She featured SCCOE's work to expand access to career pathways and the State Seal of Civic Engagement.

- Head of Technology David Wu presented an update on the Board Priority of Environmental and Climate Literacy. He presented on several initiatives including a National Oceanic and Atmosphere Association grant which provides three years of funding for professional learning and student outdoor experiences.
- Assistant Superintendent Oshodi presented an update on the Board Priority
 of Workforce Pathways and Diversification. His presentation highlighted the
 Step into an Education Career event on February 10, 2024, which drew more
 than 130 participants interested in exploring education careers. Three
 speakers from the Educator Preparation Program, Bryan Panuco, Hairl
 Maggee, and Urmi Dutta, shared their experiences in the program.

Dr. Dewan concluded the presentation by sharing some of the grant awards and intent to fund letters that have were received in the first quarter of 2024.

B. Charter Schools Update

There was 1 public comment for item 7B.

Executive Director Mefula Fairley, Charter Schools Department, provided an update on three items:

- On April 11, 2024, DCP Alum Rock submitted a charter petition and request for a material revision to reflect the reduction of grades from 6-12 to 6-8. Staff are currently working on their analysis and staff report. The decision hearing will take place on either May 15 or June 6, 2024.
- Executive Director Fairley provided an update on ACE's response to the arrest of a former ACE Empower Academy teacher.
- Annual Site Visits to SCCBOE-authorized Charter Schools have been completed. Staff are in the process of drafting reports based on these visits. This year, the reports will have a more user-friendly format with data visualizations. Reports will be available in late April or early May.

8. PUBLIC HEARING

A. Public Hearing on the Material Revision of the Downtown College Prep Alum Rock Charter Petition

President Berta opened the public hearing on the petition for material revision to the charter for Downtown College Prep Alum Rock to reduce the grades served. Staff from the Charter Schools Department presented a report. Pete Settelmayer, CEO, and Ruth Wamuyu Schriver, COO, of Downtown College Prep made a presentation on the considerations that informed the material revision. There was board discussion. President Berta closed the hearing.

Dr. Dewan provided an update from the April 17, 2024, meeting of the Joint Legislative Advisory Committee. The Committee reviewed current legislation in alignment to the Board Priorities and the Early Action on the State Budget. Dr. Dewan distributed a handout on the bills the SCCOE is currently co-sponsoring. Regarding Advocacy Day, Der. Dewan thanked Trustee Mah for her participation and congratulated the staff and partners responsible for organizing the event.

Trustee Lari provided an update from the monthly Santa Clara County School Board Association Zoom meeting on March 27, 2014. The guest speaker was County Superintendent of Schools Dr. Dewan. Presentations were also made by Chris Norwood, Trustee of the Milpitas Unified School Board, and Maryela Martinez from CSBA Legal on the topic of significant disproportionality in special education. The Hoffman Awards Dinner is scheduled for May 8, 2024.

Trustee Lari shared that the Strong Start Coalition met on April 9, 2024. Members heard a presentation by Christine Thorsteinson, Silicon Valley Community Foundation about Choose Children polling results. Dr. Amal Syed from the California Environmental Protectional Agency also presented on the negative impacts of wildfire smoke on children's health. Dr. Matt Tinsley from SCCOE shared advocacy information related to AB 1930 (Reyes) which is related to Child Development Associate teacher permit renewals.

Trustee Mah shared that the Silicon Valley Reads Committee gathered and heard a report of all the activities from the 2024 program year. The Committee also began brainstorming ideas for the 2025 theme.

Trustee Mah provided an update from the April 16, 2024, Head Start Policy Council meeting. She reported that members of the Head Start Policy Council expressed concerns about a personnel matter. Assistant Superintendent Shipp and County Counsel were in attendance to field questions about employee confidentiality related to the personnel matter.
