Executive Director Mefula Fairley, Charter Schools Department, provided an update on two items:

- As reported at the April 17, 2024, Board Meeting, Charters Department staff have completed site visits to all 21 SCCBOE-authorized charter schools. Since that meeting, Charters Department staff have completed four (4) additional follow-up visits—3 visits to recheck personnel files and 1 visit to recheck special education files. Charters Department will staff will also be adding a presentation on personnel records management best practices to an upcoming charters leaders meeting.
- Charters Department staff have completed their analysis of the DCP Alum Rock petition for a material revision. The analysis was posted on the SCCOE website on April 30, 2024. The material revision decision will come before the Board on May 15, 2024.
