7. INFORMATION ITEMS

A. Charter Schools Update

Executive Director Mefula Fairley, Charter Schools Department, provided an update on two items:

- Transitional Kindergarten (TK): Charter School Violations and Fines
 Three SCCBOE-authorized charter schools recently received notice of fines
 for violating at least one of two requirements for TK classrooms: 1) average
 class sizes at or below 24 students, or 2) adult child ratios at or below 12:1.
 The fines were for the following schools: Rocketship Alma Academy
 (\$16,484), Rocketship Mateo Sheedy (\$35,048), and Voices College-Bound
 Language Academy at Morgan Hill (\$4,469).
- Bullis Charter School (BCS)
 The BCS renewal petition was submitted on June 3, 2024, and is posted on the SCCOE website. There will be a public hearing on this petition on July 17, 2024. The staff analysis will be published on August 16, 2024. Staff will conduct a site visit on a date to be determined. If a three-day extension is granted by the leadership from Bullis Charter School, the second hearing and action on this petition will take place at the September 4, 2024, meeting of the SCCBOE.

B. Charter School Spotlight

Dr. Dewan stated that, in response to a request from the Board, the Charters School Department will be facilitating charter school spotlight presentations featuring the SCCBOE-authorized charters. This item marks the first of those presentations.

Representatives from Sunrise Middle School, including Director/Principal Teresa Robinson, Assistant Principal Jessica DeAnda, Math Director Ruben Gozman, and three students, provided an overview of the school's operations, it's successes, and opportunities for future growth.

A. Conduct a Public Hearing on the 2024-25 County School Service Fund Budget

President Berta opened the public hearing on the 2024-2025 County School Service Fund Budget at approximately 8:26 p.m.

Stephanie Gomez, Assistant Superintendent, Business Services, presented the 2024-2025 County School Service Fund Budget of the County Superintendent of Schools. She reported that the SCCOE is maintaining a positive certification despite the challenges created by declining student enrollment and lower average daily attendance in districts and SCCOE programs.
