A. Recognition of the Santa Clara County Office of Education Substitute of the Year for 2024

Trustee Sreekrishnan introduced Rosalia Zuniga Torres, a substitute teacher assistant in the Early Learning Services Head Start program as the 2024 Substitute of the Year. She noted Rosalia's strong work ethic and commitment to collaboration. Ms. Zuniga Torres was presented with a framed certificate of recognition.

B. Recognition of the Santa Clara County Office of Education Student of the Year

Trustee Lari introduced Donovan as the Student of the Year from the Opportunity Youth Academy. She noted Donovan's positive attitude, dedication to his studies, and support of his peers.  Student Board Member De La Rosa Aguilera reported that 28 graduates were recognized at the Alternative Education Graduation Ceremony. In total, 74 students completed the requirements for high school graduation this past school year. He expressed his congratulations to all graduates, his gratitude to President Berta and Dr. Dewan for attending, and his appreciation of staff for making the graduation possible.

- Student Board Member De La Rosa Aguilera shared that a new student space at the James Ranch Youth Center (Blue Ridge) is having its grand opening this week. With support from Probation and SCCOE staff, youth were able to submit artwork to be considered for a mural in the space.
- Student Board Member De La Rosa Aguilera shared that on June 11, two graduates from Osborne School attended a carpentry program where they learned new skills and safety protocols.
- Student Board Member De La Rosa Aguilera reported that Sunol students recently volunteered at a local native plant garden. They helped harvest food for an upcoming farmer's market.
- Student Board Member De La Rosa Aguilera indicated that the Osborne garden is thriving with flowers and vegetables after expanding the garden by eight beds this season. Students also made improvements to the irrigation system.

B. Charter School Spotlight

Dr. Dewan stated that, in response to a request from the Board, the Charters School Department facilitates charter school spotlight presentations featuring SCCBOE-authorized charters. This item marks the second of those presentations.

Representatives from ACE Empower Academy, including Principal Michelle Williams and Chief Executive Officer Kennedy Hilario, provided an overview of the school's operations, its successes, and opportunities for future growth.

C. Charter Schools Update

Executive Director Mefula Fairley, Charter Schools Department, provided an update on four items:

- Summit Tahoma: On June 6, Charter Schools Department staff attended the graduation at Summit Tahoma, which included many students who formerly attended Summit Denali prior to its closure.
- Opportunity Youth Academy: On June 6, Charter Schools Department staff attended the OYA graduation ceremony. There were 68 graduates. An Alumna from the program delivered the commencement speech.
- Bullis Charter School (BCS): The BCS renewal petition was submitted on June 3, 2024, requiring the SCCBOE to make a decision on the renewal on or before September 1, 2024 (90 days from submission). The request for a three-day extension to hold the decision hearing on the previously scheduled September 4, 2024, meeting was declined by BCS. As a result, an additional board meeting will be scheduled for late August.
- 2023-2024 Annual Charter Schools Data Book: The Charter School
 Department has completed the digital version of the data book which
 features information on the 21 SCCBOE-authorized charter schools. When
 the California Department of Education updates the teacher credential data,
 the data book will be updated and re-released in digital and print versions
 in English, Spanish, and Vietnamese.

A. Staff Presentation: Head Start Policy Council

Assistant Superintendent Teresa Shipp and Interim Head Start Director Reyna Dominguez provided a brief overview of the Head Start Policy Council and its role in the leadership of the Head Start Program.
