Dr. May Ann Dewan, County Superintendent of Schools, presented an announcement of the intent to appoint Dr. Denise Coleman to the Santa Clara County Office of Education Personnel Commission. Dr. Dewan thanked Mr. Nick

Education Facility Study. The members also heard a presentation from Christina Branham of American Survey Research on the 2023 School Readiness Assessment report process and findings. Trustee Lari announced that the next Strong Start Coalition meeting will be Tuesday, September 10, 2024.

Trustee Mah provided an update from the Silicon Valley Reads Advisory Committee. The Committee heard from Director Reed Myers on the recommended reading list. Trustee Mah shared that the committee has not yet finalized a theme but is considering themes such as technology, future of society, or how innovation will help humanity.

Dr. Dewan provided an update from the September 4, 2024, Policy Development Subcommittee meeting. The subcommittee held a discussion and review of Board Policy 0410 relating to nondiscrimination in SCCOE programs and activities and Board Policy 5143.3 relating to nondiscrimination and harassment. The next Board Policy Development Subcommittee regular meeting is scheduled for October 2, 2024. Both passed unanimously and will come to the Board for first reading on September 18, 2024.
