6. PUBLIC HEARING

A. Public Hearing on the Rocketship Sí Se Puede Charter School Renewal Petition

President Berta opened the public hearing on the renewal petition for Rocketship Sí Se Puede Charter School at approximately 5:50 p.m. The hearing began with a report from staff of the Charter Schools Department.

Janine Ramirez, Interim Executive Director, and Danisha West, Principal of Rocketship Sí Se Puede Charter School made a presentation on the renewal petition.

There were no speakers from the Alum Rock Union School District.

There were 11 public comments on the Rocketship Sí Se Puede Charter School renewal petition.

President Berta closed the hearing at 7:00 p.m.

7. INFORMATION ITEMS

A. Spotlight: Sustainability - Green Improvement Initiatives

Dr. Dewan provided an overview of Senate Bill 1383 which set a goal of reducing landfill organic waste by 75 percent by 2025. Dr. Dewan introduced Director of Special Projects, David Putney, and Climate Fellow, Devin Ngo, who presented highlights of the SCCOE sustainability project, including the Ridder Park Tree Planting, Solar Project, and the California Schools Healthy Air, Plumbing, and Efficiency Heating, Ventilation, and Air Conditioning (CalSHAPE HVAC) Program.

B. Spotlight: Post Secondary Deaf and Hard of Hearing Program

Dr. Dewan introduced Assistant Superintendent of Educational Services Teresa Shipp, Assistant Director of Special Education Kristie Kropp, Principal of Oster Cluster Dr. Tarsha Foye, and Program Manager of Vocational Education Rowan Lewis to highlight the SCCOE Post Secondary Deaf and Hard of Hearing Program, including the WorkAbility I program, worksite options, student entrepreneurship, and worksite opportunities and partnerships.

C. Charter Schools Update

There was 1 public comment.

Mefula Fairley, Executive Director of the Charter Schools Department, reported the County Superintendent has arranged an investigation into allegations that (1) Bullis Charter School has improperly disenrolled students with disabilities rather than providing a free appropriate public education ("FAPE") and (2) Bullis has not properly developed and/or implemented individualized education programs ("IEPs"). Director Fairley also reported that the County Superintendent has issued a notice of concern to Bullis regarding its failure to comply with its legal obligation to promptly respond to all reasonable inquiries from the SCCOE.

Director Fairley provided an update on the Alpha Jose Hernandez renewal.

Student Board Member De La Rosa Aguilera was excused at 7:57 p.m.

A. First Reading of Board Policy 0410 Nondiscrimination in County Office Programs

Dr. Dewan provided an overview of Board Policy 0410 Nondiscrimination in SCCOE Programs and Activities to reflect new federal regulations, 89 Fed. Reg. 33474 and 31320 to clarify what is included as "discrimination" as well as follow up relating to the Title IX grievance procedures. The Second Reading and adoption will be brought to the Board at the meeting on October 02, 2024.

B. First Reading of Board Policy 5145.3 Nondiscrimination and Harassment

Dr. Dewan provided an overview of Board Policy 5145.3 Nondiscrimination and Harassment to reflect new federal regulations 89 Fed. Reg. 33474 as well as state law, Assembly Bill 1165. The Second Reading and adoption will be brought to the Board at the meeting on October 02, 2024.

11. BOARD COMMITTEE REPORTS

Dr. Dewan provided an update on the September 18th Joint Legislative Advisory Committee meeting, including the status of SCCOE sponsored bills, overview of the budget clean up bill, highlights of legislation and budget projections for the anticipated 2025 state budget, and potential priority topics for the committee for 2025.

President Berta provided an update on the Warmenhoven Inclusion Collaborative Advisory Board meeting, including a review of the transition of the working group recommendations.

Trustee Lari provided an update on the September 10th Strong Start Coalition meeting. The Coalition members heard two presentations from Dr. Rachel Chazan Cohen, Assistant Professor from the University of Connecticut, relating to mental health of home visitor staff and a new project in Connecticut on bringing together home visitation and center-based staff to provide whole family supports through coordination of existing programs. The next Strong Start Coalition meeting is scheduled for October 8.

12. COUNTY BOARD OF EDUCATION MEMBER REPORTS

Trustee Mah reported on the following:

- Her attendance at the County Board Member Services conference along with President Berta and Trustee Lari. Trustee Mah further elaborated on the need to raise awareness on sex trafficking, as discussed at the conference and the work done in Monterey County around this topic. Trustee Mah highlighted the dangers to youth and recommended that topics such as mental health, dangers of opioid and fentanyl abuse, gang violence, and sex trafficking could be incorporated into a summit within the county;
- · Participation in the Joint Legislative Advisory Committee meeting;
- Attendance at the Santa Clara Alliance of Black Educators meeting where they shared their activities and had officer elections:
- Attendance of the Silicon Valley Leadership Group's Amazon AI Summit focusing on igniting innovation and driving the next technology evolution; and
- Questions brought by the Head Start Policy Council members relating to a current acting director and requested clarity on the bylaws and personnel policies, particularly to be translated to Spanish and Vietnamese to allow full participation by parents.

Trustee Sreekrishnan reported on the following:

- On September 14, she attended the College of Adaptive Arts' 15th anniversary celebration;
- Trustee Sreekrishnan thanked Dr. Dewan for connecting her with Jyothi Kalai, musician who performed at Hester and Gateway;
- An update relating to the backpack drive;
- Aayna Dhruv and her involvement in the environmental justice curriculum;
- Meetings with Dr. Dewan and Dr. Jessican Bonduris with local parents relating to faith-based discrimination; and
- A meeting with Hemant Buch and work relating to the recognition of cricket as a high school sport.

Trustee Lari reported on the following:

 On September 8th, she attended a community discussion at the West Valley Muslim Association;

- From September 12th to 15th, Trustee Lari attended the County Board Member Services conference and reiterated Trustee Mah's interest in highlighting the prevalence of human trafficking in our communities. Trustee Lari suggested incorporating this topic into the planned youth and wellness summit to provide education on trafficking;
- A public health advisory from the Surgeon General relating to a loneliness crisis, workplace wellbeing, and the impact of social media on mental health and wellbeing in the community; and
- Trustee Lari thanked Dr. Dewan and staff for working on a resolution to highlight mental health support issues.

President Berta reported on the following:

 Attendance at the CSBA County Board Services Conference and highlighted the work of the Alameda County Office of Education and the practices to build board members' capacity to understand issues around charter schools.
