2. SPECIAL RECOGNITION

A. Recognition of the SCCOE Employee of the Month

Trustee Rocha introduced the Santa Clara County Office of Education Employee of the Month, Melisa Escarcega, Occupational Therapist II in the Special Education Department. Melisa, who has served SCCOE for over 12 years, was honored for her dedication, inclusive practices, and collaborative spirit. Trustee Rocha acknowledged Melisa's contributions and presented her with a plaque in recognition of her work at the Santa Clara County Office of Education, along with an engraved pen and a reserved parking space.

3. STUDENT BOARD MEMBER REPORT

Student Board Member Pastrana Jimenez shared the following updates:

- Osborne School students are participating in a 15-module driving simulator program, with six students having completed it so far.
- Osborne is also beginning a 10-week violence prevention workshop through A Brighter Day.
- At Blue Ridge, the three-week welding cohort concludes on Friday, September 5. Several students
 earned American Welding Association certifications, including two who advanced to the higher-level
 course.
- Sunol has launched a new football league in partnership with Empowering Our Community for Success (EOCS).
- Osborne received a 2025–26 Dual Enrollment Opportunities College and Career Access Pathways Grant (CCAP) grant with San José City College to develop an entrepreneurial small business dual enrollment pathway, created in response to student advocacy.
- Students expressed interest in providing feedback to Superintendent Dr. Toston on these programs, either in meetings or through surveys.

7. ACTION ITEM

A. SCCBOE Retreat Ad Hoc Committee Appointment

The Board discussed forming an Ad Hoc Retreat Planning Committee to organize the October 4 Board Retreat, including structure, activities, and content. Trustee Speiser volunteered to serve, and Trustee Pacheco had previously expressed interest in joining the committee, with Trustee Rocha appointed as alternate should Trustee Pacheco decline.

Motion #2570-4 by Trustee Rocha, seconded by Trustee Speiser, to establish the SCCBOE Retreat Ad Hoc Committee and appoint Trustees Speiser and Pacheco as members, with Trustee Rocha serving as alternate. Motion carried 6-0-1 with the following vote:

8. BOARD COMMITTEE REPORTS

A. Committee members may provide or report on recent committee activities.

Vice President Chon reported that the Policy Development Subcommittee met on September 3 to review policies related to contracts and portions of the 9000 series, with selected items referred to the Governance Ad Hoc Committee. The subcommittee will continue its review of the remaining 9000 series policies at its next

meeting on October 1.

President Berta added that the Governance Ad Hoc Committee has also met, will continue its discussions at an upcoming meeting, and will keep the Board informed.

9. COUNTY BOARD OF EDUCATION MEMBER REPORTS

Trustee Lari reported on preparations for the Sept. 10–12 Youth and Wellness Summit and thanked all involved. She also shared updates on her work with the Immigrant Protection Empowerment Network (IPEN), encouraged trustee participation, and noted attending an Aug. 21 National Immigration Law Center webinar on challenges for immigrant children and families.

Trustee Speiser highlighted outreach with Area 1 trustees to share the role of the County Office and Board. She attended several meetings, including the Mountain View–Los Altos Challenge Team, SCCSBA Legislative Action Committee, the Unhoused Students Subcommittee, and fall convening planning. She noted the Nov. 15 convening on unhoused students at SCCOE, with Dr. Toston providing the introduction.

President Berta reported attending an Alum Rock USD board meeting to share an update on the FCMAT audit and participating in a statewide student panel with the California Association of Student Councils. She also recognized Trustee Lari's work with IPEN and invited trustees to the next convening on Sept. 26.

10. SUPERINTENDENT'S REPORT

Dr. Toston reported on the annual retreat with district superintendents, ongoing community engagement, and SCCOE's partnership with Silicon Valley Reads. He highlighted recent events, including Santa Clara Unified's beam signing, Library Camp, site visits to the Hester Cluster and Sunol Community School, and the Mountain View Whisman Board meeting on the extraordinary audit, which found no evidence of fraud. He added that SCCOE is assisting districts with year-end close, LCAPs, and budgets, and that SCCOE's unaudited actuals will be available in October.

11. INFORMATION ITEM

A. Future Agenda Items

Dr. Toston reviewed progress on agenda items, including the development of student advisory groups requiring Board direction, ongoing work with the Policy Subcommittee, and upcoming divisional reports beginning September 17. He also highlighted plans to engage employees and labor partners in the budget process and noted research on a possible local seal related to the science of reading.

Trustee Lari requested that a study on the impact of long COVID on student absenteeism be added to the list.
