

**RESOLUTION  
DESIGNATION OF APPLICANT'S AGENT RESOLUTION FOR NON-STATE  
AGENCIES**

**SANTA CLARA COUNTY BOARD OF  
EDUCATION RESOLUTION NO. 2266-2**

**WHEREAS**, on March 13, 2020, the President declared the Coronavirus pandemic a National Emergency. This unprecedented Nationwide Emergency, and the Secretary of Health and Human Services' (HHS) declaration of Public Health Emergency for COVID-19 established that exigent and emergency circumstances existed; and

**WHEREAS**, the approval of this major national disaster declaration (FEMA-4482) resulted in California's Disaster Declaration for the COVID-19 pandemic, which authorized the Federal Emergency Management Agency (FEMA) to provide federal assistance through the Public Assistance Grant Program, to every State, Territory, Tribal, local government, and certain private non-profit organizations for Emergency Protective Measures; and

**WHEREAS**, the Santa Clara County Office of Education has already incurred costs, and anticipates additional costs related to the COVID-19 pandemic which may be eligible for reimbursement from FEMA.

**WHEREAS**, the Santa Clara County Office of Education has already registered and submitted a Request for Public Assistance for FEMA Reimbursement with California's Office of Emergency Services (CAL OES), and requires approval of the CAL OES Form 130 Designation of Applicant's Agent Resolution for Non-State Agencies, which designates SCCOE representatives responsible for filing claims for reimbursement and providing information to CAL OES on behalf of the organization when required.

**THEREFORE, BE IT RESOLVED** by the County Board of Education of the Santa Clara County Office of Education that the County Superintendent or the Chief Business Officer is hereby authorized to execute for and on behalf of the Santa Clara County Office of Education, a public entity established under the laws of the State of California, this application and to file it with the California Governor's Office of Emergency Services for the purpose of obtaining certain federal financial assistance under Public Law 93-288 as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, and/or state financial assistance under the California Disaster Assistance Act.

That the Santa Clara County Office of Education, a public entity established under the laws of the State of California, hereby authorizes its agent(s) to provide to the Governor's Office of Emergency Services for all matters pertaining to such state disaster assistance the assurances and agreements required. This is a disaster specific resolution and is effective for only disaster number FEMA-4482-DR-CA (DR-4482).




