

## **RESOLUTION RECOGNIZING NATIONAL HOMELESS YOUTH AWARENESS MONTH**

## SANTA CLARA COUNTY BOARD OF EDUCATION RESOLUTION No. 2573-1

**WHEREAS**, November is National Homeless Youth Awareness Month. Every year, hundreds of thousands of American families become homeless, including more than 4.2 million children; 700,000 of whom are unaccompanied minors according to the National Conference of State Legislatures; and

**WHEREAS**, there were 5,806,221 students in California enrolled in public school in the 2024-25 school year, according to the California Department of Education; and

**WHEREAS,** the number of students who experience homelessness in California was at least 4.1 percent of the student population, which equates to approximately 230,443 young people in California; and

**WHEREAS**, during the 2024-25 school year there were 6,590 students in Santa Clara County experiencing homelessness according to the California Department of Education; and

WHEREAS, as defined by the McKinney-Vento Homeless Assistance Act, youth and children experiencing homelessness are individuals who lack a fixed, regular, and adequate nighttime residence, including those sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason; are living in motels, hotels, trailer parks, or camping grounds due to the lack of adequate alternative accommodations; are living in emergency or transitional shelters; and

**WHEREAS**, the McKinney-Vento Homeless Assistance Act further defines youth and children experiencing homelessness as those who have a primary nighttime residence that is a public or private place not designed for or ordinarily used as regular sleeping accommodation for human beings; children and youth who are living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings; and

WHEREAS, the population of youth experiencing homelessness also includes unaccompanied youth who have left home for one or more nights without permission; youth who have been kicked out of their homes, are abandoned, deserted, or prevented from returning home; and systems youth who have either aged out of foster care or have been released from juvenile justice or other public systems with nowhere to go; and

WHEREAS, due to the varying definitions of homelessness and the difficulty in capturing accurate data, the county statistics do not necessarily reflect the numbers in the McKinney-Vento Homeless Assistance Act. The Santa Clara County Office of Education (SCCOE) has established programs to assist schools and school districts in capturing accurate data and helping in the alignment of services to serve students and their families; and

WHEREAS, the SCCOE continues to help students experiencing homelessness through Foster and Homeless Youth Services (FHY) by providing assistance and training to local education agencies (LEAs) that help connect school districts and community partners, as well as keep them abreast on educational law that protects youth who are in foster care and experiencing homelessness; and

**WHEREAS**, FHY also collaborates with the Office of Supportive Housing (OSH), the juvenile justice system, and the Department of Family and Children's Services Prevention Bureau, as well as other agencies and organizations that are dedicated to working with youth who are in foster care and experiencing homelessness; and

**WHEREAS**, the SCCOE is committed to improving student equity and access to high-quality education for youth experiencing homelessness and who are in foster care through the FHY continued liaison support to districts, schools, students, and communities; as well as being a premier service organization; now

**THEREFORE, BE IT RESOLVED**, that the Santa Clara County Board of Education and the County Superintendent of Schools do hereby adopt this resolution recognizing November as National Homeless Youth Awareness Month.
