- B. <u>Revision of Classification Specifications: Supervisor-Head Start ERSEA/Restricted (CL SUPV)</u> MOTION #401-4 by Ms. Spector, seconded by Mr. Martin approved the revision of the class specifications for Supervisor-Head Start-ERSEA/Restricted, changing the title to Supervisor-Head Start Compliance-ERSEA/Restricted, (CL SUPV) and elevating the salary range assignment from Range 8.0 (\$79,650-\$101,656 monthly) to Range 10.0 (\$87,814 - \$112,077 monthly).
