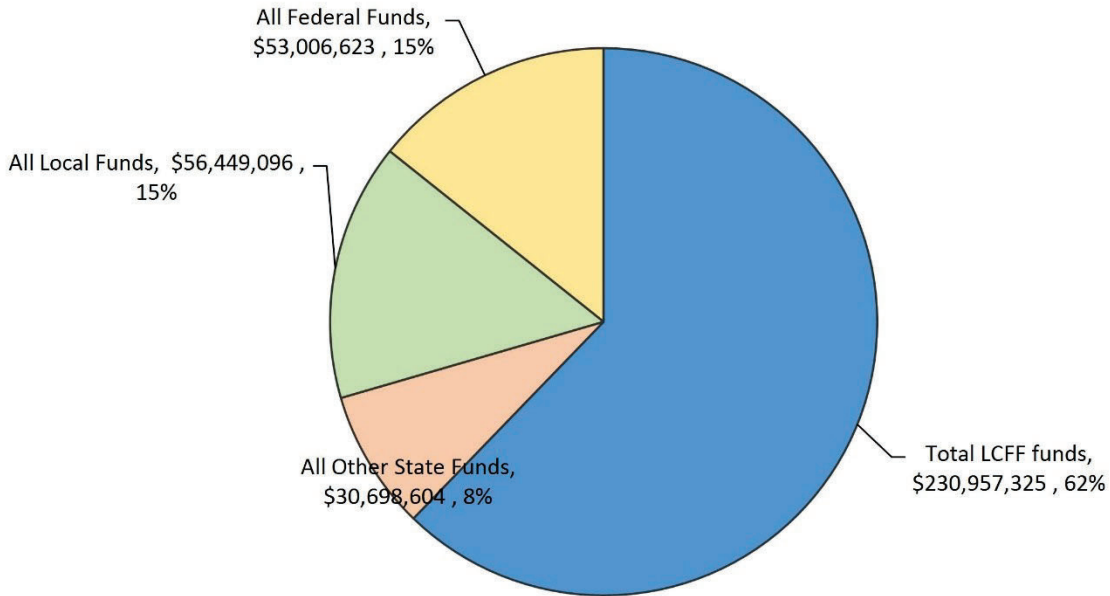

LCFF provides funding for 1) COE oversight activities of its school districts and 2) COE instructional programs in the form of base level of funding for all students and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).

Projected Revenue by Fund Source

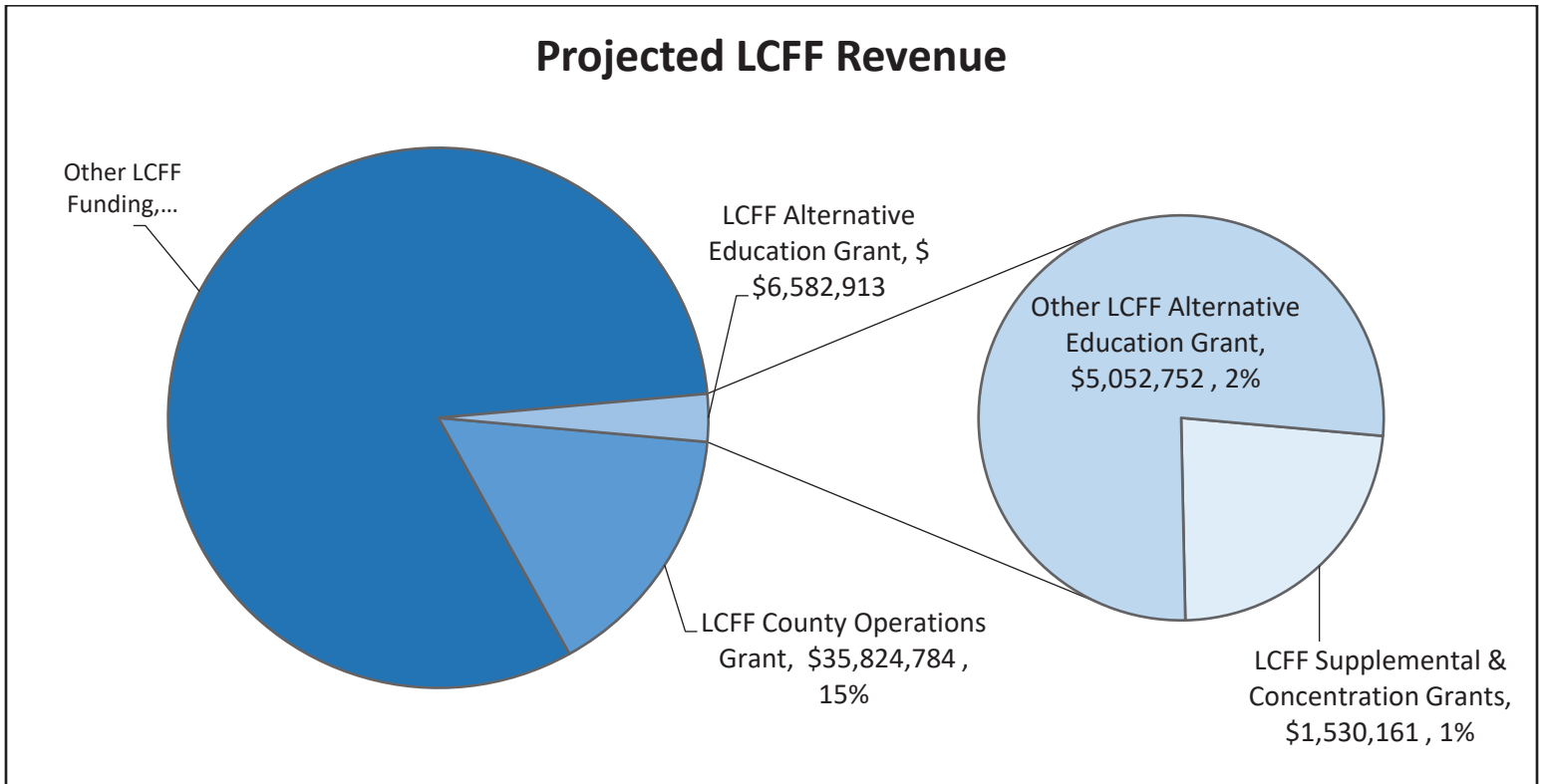


This chart shows the total general purpose revenue Santa Clara County Office of Education (SCCOE) expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Santa Clara County Office of Education (SCCOE) is \$371,111,648, of which \$230,957,325 is Local Control Funding Formula (LCFF), \$30,698,604 is other state funds, \$56,449,096 is local funds, and \$53,006,623 is federal funds.

Of the \$30,698,604 attributed to All Other State Funds, \$525,000 are attributed to the Student Support and Enrichment Block Grant.

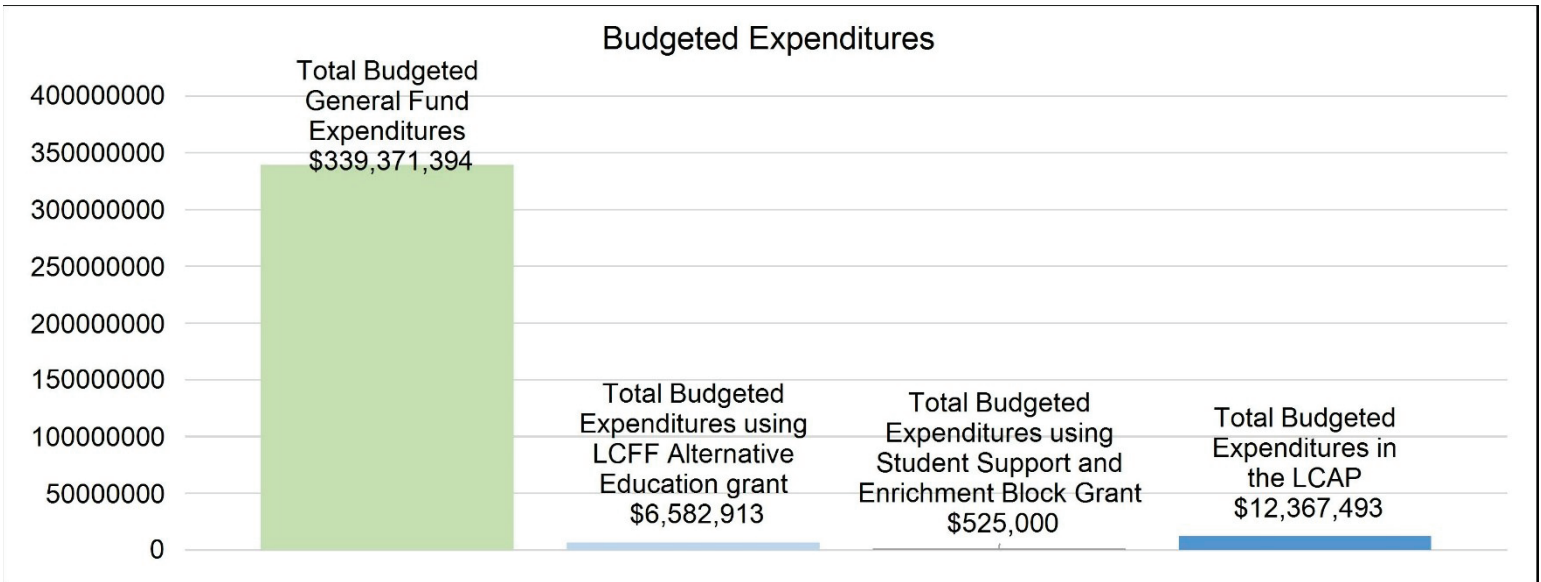


This chart shows the LCFF revenue Santa Clara County Office of Education (SCCOE) expects to receive in the coming year.

The text description for the above chart is as follows: The total LCFF revenue projected for Santa Clara County Office of Education (SCCOE) is \$230,957,325, of which \$35,824,784 is attributed to the LCFF County Operations Grant, \$6,582,913 is attributed to the LCFF Alternative Education Grant, and \$188,549,628 is other LCFF funds. Of the \$6,582,913 attributed to the LCFF Alternative Education Grant, \$1,530,161 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

SCCOE receives LCFF funds from school districts as fees for elective Special Education services.

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use these funds to serve students.

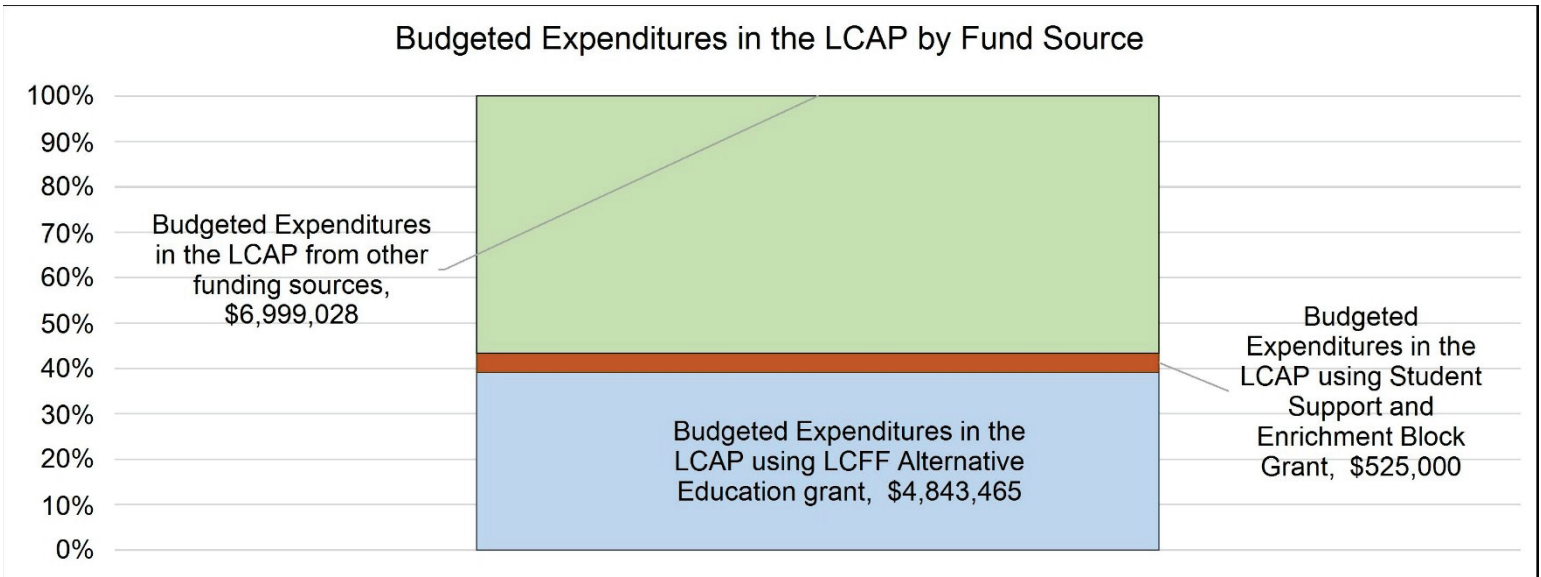

The text description of the above chart is as follows: Santa Clara County Office of Education (SCCOE) plans to spend \$339,371,394 for the 2026-27 school year. Of that amount, \$6,582,913 is attributed to the Alternative Education Grant and \$525,000 is attributed to the Student Support and Enrichment Block Grant. \$327,003,901 of the General Fund Budgeted Expenditures are not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

Unlike school districts, the Santa Clara County Office of Education (SCCOE) is a comprehensive education resource and service center with mandated fiscal, administrative, human resources, instructional oversight, administrative functions, and some direct student service functions. The direct student services provided to school districts include Special Education, Early Learning, Environmental Education, Alternative Education, Migrant Education and Opportunity Youth Academy (OYA). SCCOE also provides oversight and is the primary support for school districts with identified performance gaps. Funds not allocated for LCAP are restricted funds for mandated services and restricted programs.

SCCOE receives Alternative Education Grant funds for a dependent charter, Opportunity Youth Academy. These Alternative Education funds will be reported in Opportunity Youth Academy's Local Control Accountability fund separately From SCCOE's LCAP.

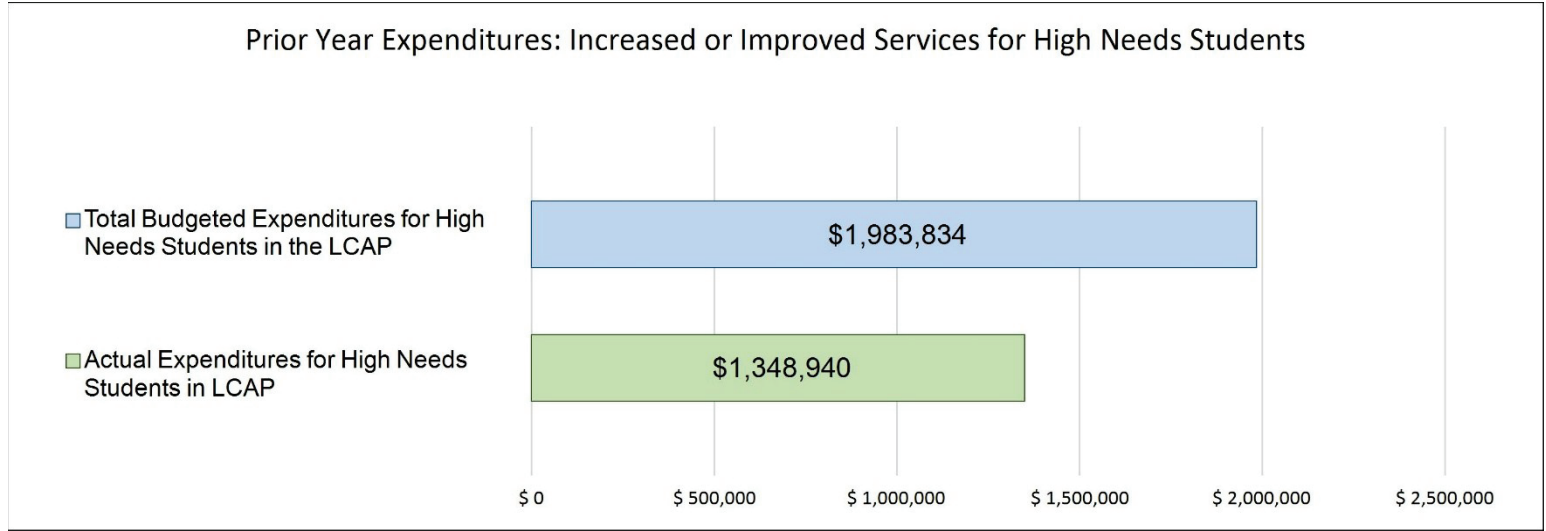

The text description of the above chart is as follows: In 2025-26, Santa Clara County Office of Education (SCCOE)'s LCAP budgeted \$1,983,833.52 for planned actions to increase or improve services for high needs students. Santa Clara County Office of Education (SCCOE) actually spent \$1,348,940 for actions to increase or improve services for high needs students in 2025-26.

The difference between the budgeted and actual expenditures of \$634,893.52 had the following impact on Santa Clara County Office of Education (SCCOE)'s ability to increase or improve services for high needs students:

The difference between the budgeted and actual expenditures was due to a combination of factors. Some planned actions and services were funded through supplemental grants, reducing the need to use the originally budgeted funds. Additionally, several initiatives are still in development and require more time for full implementation. Furthermore, several contracts came in at lower costs than anticipated due to vendor availability and other related factors. While these circumstances resulted in lower expenditures, they did not significantly impact the services for high need students.

General Information

General Information

Through the Educational Services Division, the Santa Clara County Office of Education (SCCOE) supports instruction for approximately 841 students in grades PK-Post Secondary throughout Santa Clara County. The Special Education program serves 690 students, and the Alternative Education Department which includes Court and Community School serves approximately 151 students. The programs are housed at various sites throughout the county.

Alternative Education

The Santa Clara County Office of Education's (SCCOE) Alternative Education Department (AED) serves students in various programs. 76.83% identify as Latinx, 9.76 % identify as White, 4.27% of students identify as African American, 6.71% of students identify as Asian and 2.44% of students identify Filipino or Native Hawaiian/Pacific Islander. The Alternative Education Department provides services for students who are currently expelled, incarcerated, choosing independent studies or have a mutually agreed upon placement from their district of residence. The programs are structured to work with students to (a) recover academic credit, (b) earn a diploma, and (c) complete Rehabilitation Plans. Programs are facilitated throughout school districts across Santa Clara County and provide opportunities for specialized instruction for students. All Alternative Education programs provide multi-tiered systems of support for students. Alternative Education employs academic counselors, Campus Youth Advocate, a Navigator, Manager of Implementation and Compliance, and College Liaison to support student needs and reach out to families. AED partners with community-based organizations to provide enrichment and specialized services. Court programs work collectively with Probation to offer an academic program for detained students and to support student

transition upon exit from the program. The Alternative Education program includes an unduplicated student count of 85%. 27% of students receive English language proficiency services, 67% of students identify as low-income, and 9% of students receive foster/ homeless youth services, as indicated in the census report of October 2025.

Court School Programs

Alternative Education serves youth currently incarcerated, grades 6-12 at Osborne School within Santa Clara County Juvenile Hall in San Jose and grades 8-12 at Blue Ridge School at James Ranch in Morgan Hill. Students reside in the facilities during and after court placement, and the SCCOE provides educational services within the institutions, including a core academic program to support graduation and career technical education. Students placed at James Ranch remain for long-term placement. Teaching is provided to students through in-person, direct instruction. The Court School Program received a lowest performance indicator for graduation rate for socioeconomically disadvantaged students on the 2023 CA Dashboard. Due to these performance indicators, the Court School Program qualified for the equity multiplier goal. This goal in the LCAP strives to improve the graduation rate of socioeconomically disadvantaged students by June 2027. The 2024 CA Dashboard displayed that Court school improved their graduation rate and did not receive any lowest performance level indicators. On the 2025 CA Dashboard, Court School received a red lowest performing indicator in graduation rate and lowest performing student group for socioeconomically disadvantage students. 100% of the students in the Court School Program identify as low-income. The program will continue to work on student engagement and improvement through credit recovery, developing art and music programs, and expanding CTE pathways. The program also working with the California Department of Education on Differentiated Assistance to support targeted goals. The Edgenuity learning platform is offered as credit recovery for students to accelerate learning. In addition, students participate in career technical education coursework and job certifications through online programming. Students at James Ranch are also able to participate in career pathway courses related to building construction, culinary arts, and horticulture. Students who are incarcerated and who graduate while attending the SCCOE programs are offered vocational coursework toward career readiness and the ability to enroll in local community colleges through online courses. For the 2026-27 Court School will continue to receive Equity Multiplier funding and has focus goal 5 established.

Community School Program

SCCOE Alternative Education also provides services for students from local districts in grades 6-12 who have been referred due to (a) expulsion, (b) attendance, or (c) social and emotional needs. Sunol Community School and South County Community School provide a complete instructional program for students. Both programs also offer support for students in meeting rehabilitation plans, preparing them for a successful return to their district of residence. This support includes (a) counseling, (b) tutoring, and (c) community involvement, as well as access to Career Technical Education (CTE) courses and college credit courses as requested. Sunol Community School also offers independent study for students in grades 6-12. Students participate in the program through referrals from local districts. Students may request referral based upon (a) mental health or social-emotional issues, (b) a desire to accelerate credit accumulation for graduation, or (c) referral due to non-attendance. Some may, at times, be placed in the independent study program after release from incarceration. Students participate in independent learning and meet with teachers for a minimum of one hour per week. Students have access to a full range of A-G courses and also have the option to participate in dual enrollment with local community college or participate in Career Technical Education courses. 45.28% of students in independent study experience low socioeconomic status, 9.43% receive services as English Learners, 5.66% of students with disabilities, currently enrolled in the program. The unduplicated count for the Independent Study Program is contained within the unduplicated count for the Santa Clara County Community School. Based on the 2025 CA dashboard, Community School will not be receiving Equity Multiplier funding in the 2026-27 school year.

The Santa Clara County Office of Education (SCCOE) Court and Community School Programs are utilizing their base grant to continue offering a broad course of study. These funds are designated to address key areas of focus within our plan including access to a broad course of study and employees who provide services to achieve objectives of JCCS funding expectations and accountability. The Court and Community School Programs are also receiving Student Support and Enrichment Block Grant funds which also help providing broad course of study staffing and to provide credit recovery programming and assessments to aid in high school completion for students and transition post graduation.

Special Education Program

The County Operated Special Education program does not contribute to the unduplicated count of students or receive funding from the Local Control Funding Formula. Student data collected for these programs is reported to each student's district of residence. Student enrollment in the Santa Clara County Office of Education's special education program is as follows: (a) 46% of students identify as low-income, (b) 32% of students identify as English Learners, and (c) less than 1% of students receive foster youth or homeless youth services. 100% of students have an Individual Education Plan (IEP), and the breakdown of students represented by identified ethnicity is: (a) 43.54% Latinx, (b) 31.23% Asian, (c) 14.26% White, (d) 4.8% Filipino, (e) 3.45% African American, (f) less than 1% Native Hawaiian, (g) Less than 1% American Indian, (g) less than 1% Missing, and (h) less than 1% multiple. The Santa Clara County Office of Education's special education program serves students in 98.5 classrooms at 36 school sites. The department serves as a partner with the county's 31 public school districts and 60 charter schools to serve students with disabilities. Special Education Program will not be receiving Equity Multiplier funding for 2026-27.

Foster Youth and Foster Youth Services Coordinating Program

The Santa Clara County Office of Education's Foster Youth Services Coordinating Program (FYSCP) provides technical support to districts to ensure students involved in the foster care system receive direct services from their home school districts. Services are designed to address their vital educational and social-emotional needs. The FYSCP technical support includes providing guidance and building the capacity of (a) schools, (b) school district staff, and (c) district liaisons regarding the various educational laws and practices that protect the rights of students in foster care. The FYSCP also provides resources specific to the educational success of students in foster care. The FYSCP works in collaboration with (a) community-based organizations, (b) the Department of Family and Children's Services, and (c) other agencies that work to improve the lives of students in foster care. The FYSCP coordinates educational services and opportunities and supports all foster youth countywide, including those enrolled in SCCOE's Alternative Education and Special Education programs. The FYSCP works in collaboration with (a) school districts and charter schools, (b) child welfare services, (c) juvenile court, (d) Probation, (d) community colleges, and (e) the Department of Family, Community Based Organization's and Children's Services to improve educational outcomes for foster youth. Services provided include (a) immediate enrollment, (b) identifying, coordinating, and referring for services, (c) gathering and reviewing school records, (d) accessing completion of partial credit and/or credit recovery, and (e) assisting with post-secondary education preparation including providing resources to youth placed in Santa Clara County from other counties. Furthermore, FYSCP provides technical support and professional learning to all LEAs and Charters as it pertains to laws, practices, and rights that protect students in foster care.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

The Santa Clara County Office of Education (SCCOE) Educational Services Division (ESD) strives to improve local and state indicators for all programs and have success related to student outcomes and Local Control Accountability Plan goals. The 2025 CA Dashboard reflects SCCOE's progression in improving student outcomes through improvement in chronic absenteeism, suspension rate and English Learner Progress. The Educational Services Division (ESD) continues to work on these areas as well as improving the graduation rate. The Community School and Court School saw a decline in the 2024-25 graduation rate. The programs are working on strategies to improve not only graduation rates but to track students once they leave Court or Community School to provide transition in order to have continuous services and support, thus reducing dropout rates. The Alternative Education Department is working with the California Department of Education through Differentiated Assistance to address chronic absenteeism, English Learner Progress and graduation rate. The County Operated Special Education programs saw growth in English Learner Progress, and a decline in chronic absenteeism and suspension rates. The Special Education Program is working with the California Department of Education through Differentiated Assistance to address chronic absenteeism, English Learner Progress and graduation rate. The rates of parent engagement have remained steady division-wide. The completion rates for career technical education courses and work-related programming for students remained steady and programs are developing new partnerships and strategies to improve access to college/career readiness. Engagement of the Foster Youth Services Department with local districts continues to support the needs of foster youth in Santa Clara County. Services and collaborative support for youth experiencing expulsion increased as programs expanded to support career technical education, environmental literacy, and ethnic studies. The dropout rate for alternative education programs continued to decrease. Though the SCCOE saw a slight decline in the graduation rate as a whole which are being addressed, overall there were still several indicators for each program that show improvement.

For the 2023 California Dashboard, the Santa Clara County Office of Education (SCCOE) received the lowest performance level for chronic absenteeism. SCCOE also received the lowest performance level for the suspension rate among the student subgroup of students with disabilities, and a low performance level for the College and Career Indicator for the student subgroups of socioeconomically disadvantaged and Hispanic students. In response, SCCOE incorporated action items into the Local Control Accountability Plan (LCAP) to address chronic absenteeism, the suspension rate of students with disabilities, and College and Career readiness for Hispanic and socioeconomically disadvantaged students. These goals and actions remain in place for the three-year LCAP adoption cycle.

For the 2024 California Dashboard, SCCOE continued to receive the lowest performance level for chronic absenteeism, with Hispanic and socioeconomically disadvantaged student subgroups identified as low performing. SCCOE also received the lowest performance level for suspension rate across multiple student subgroups, including African American, English Learners, Hispanic, Homeless, Long-Term English Learners, students with disabilities, and socioeconomically disadvantaged students. Additionally, the English Learner Progress Indicator received the lowest performance level, specifically for English Learners and Long-Term English Learners. The College and Career Indicator also demonstrated a low performance level, particularly for socioeconomically disadvantaged and Hispanic student subgroups.

In response to the 2024 Dashboard results, SCCOE expanded action items in the LCAP to address the identified lowest-performing indicators: chronic absenteeism, suspension rate, English Learner Progress, and College and Career readiness, with a particular emphasis on improving outcomes for all identified student subgroups. The LCAP also incorporates goals and actions focused on improving student attendance through engagement strategies and continued improvement in graduation rates across all programs.

For the 2025 California Dashboard, SCCOE received the lowest performance level for the College and Career Indicator, particularly for socioeconomically disadvantaged students, Long-Term English Learners, and Hispanic students. In response, strategies and plans to improve college and career readiness have been further expanded within the LCAP.

Community School Program

The SCCOE Community School Program has faced ongoing challenges with suspension rates, chronic absenteeism, and college/career readiness, particularly among historically underserved student groups. In 2023 and 2024, the program received the lowest performance levels on the California School Dashboard for suspension rates, with socioeconomic disadvantaged and Hispanic students most impacted, along with English Learners, students with disabilities, and long-term English Learners. In 2024, the program also received the lowest performance level for chronic absenteeism, especially affecting Hispanic students.

In response, the program implemented and expanded targeted strategies through its School Plan for Student Achievement and LCAP, including enhanced student enrichment, increased engagement initiatives, expanded PBIS implementation, and additional staff professional development. Equity Multiplier funding in 2024 supported social-emotional services focused on improving attendance for socioeconomically disadvantaged students, contributing to improved attendance and reduced chronic absenteeism by 2027. Although the program did not qualify for Equity Multiplier funding in 2025, it sustained positive attendance gains and continues to prioritize student engagement. In 2025, the Community School Program received the lowest performance level for College/Career readiness, prompting expansion of dual enrollment opportunities, with more students taking courses on community college campuses to strengthen postsecondary pathways.

Court School Program

On the 2023 California Dashboard, the Court School Program received the lowest performance level for the graduation rate indicator, with socioeconomically disadvantaged students identified as the student group at the lowest performance level. As a result of these performance indicators, the Court School Program qualified for the Equity Multiplier goal. This LCAP goal aims to improve the graduation rate of socioeconomically disadvantaged students by June 2027. To support this goal, the program will focus on increasing student engagement and achievement through expanded credit recovery and tutoring hours, the development of art and music programs, and the expansion of Career Technical Education (CTE) pathways.

On the 2024 California Dashboard, the Court School Program did not receive any low-performing indicators. However, on the 2025 California Dashboard, the Court School Program again received a low-performing indicator in graduation rate. Efforts continue to focus on improving the graduation rate for Court School students, all of whom are considered socioeconomically disadvantaged.

County Operated Special Education Program

The County Operated Special Education Program does not generate Local Control Funding Formula (LCFF) funding and does not contribute to the LCFF student count; therefore, references in the LCAP relate solely to the use of federal Title funds to support English Learners and low-income students and Learning Recovery Emergency Block Grant funds.

On the 2023 California School Dashboard, the program received the lowest performance level in graduation rate, particularly for socioeconomically disadvantaged students and students with disabilities. The program also received low performance levels in English Language Arts, Mathematics, and College/Career Readiness, with English Learners, socioeconomically disadvantaged students, Hispanic students, and students with disabilities most impacted. In response, the program added LCAP action items supported by categorical (Title) funds and began developing an alternative pathway to a diploma to improve graduation outcomes for students with disabilities.

In 2024, the program again received the lowest performance levels for chronic absenteeism, English Learner Progress, graduation rate, and College/Career Readiness. Multiple student groups were affected, including English Learners, Long-Term English Learners, students with disabilities, socioeconomically disadvantaged students, and several racial and ethnic groups. The program expanded LCAP actions to address these additional areas of need.

On the 2025 California School Dashboard, the program received the lowest performance level in English Language Arts; however, 60% of students demonstrated improvement compared to the prior year. Graduation rate and College/Career Readiness performance remained low during the 2024–25 school year. To address these outcomes, the program is expanding course offerings and strengthening trade and vocational career pathways to support improved postsecondary readiness and graduation rates.

Foster/ Homeless Youth

We have demonstrated significant acceleration and growth countywide in our foster target population.

Learning Recovery Emergency Block Grant

SCCOE received additional LREBG funds during the 2025-26 school year. A needs assessment was conducted and the areas requiring attention include chronic absenteeism, English Language Arts and Math Supports.

The programs will be using LREBG funds to address these areas of need through action items:

Community School: The Community School will be using LREBG funds to provide extra hours for staff to providing tutoring/extra support to students with an emphasis in ELA and Math. Action 1.3.

Court School: Will be using LREBG funds to provide extra hours for staff to providing tutoring/extra support to students with an emphasis in ELA and Math. Action 1.3.

Special Education Program: Will be using LREBG funds for literacy and classroom libraries. Action 1.2.

The funds will be carryover and are not included in the budget section but will be added for the Mid year report.

Reflections: Technical Assistance

The Santa Clara County Office of Education (SCCOE) as a whole is receiving Differentiated Assistance (DA) support due to one or more student groups having red indicators in at least two state priority areas as reflected in the 2024 CA Accountability Dashboard. These areas indicated include:

- 1) Hispanic students with a red indicator in chronic absenteeism, suspension rate and college and career indicator.
- 2) English Learners with a red indicator in English Learner Progress and Suspension rate.
- 3) Long Term English Learners with a red indicator in English Learner Progress and suspension rate.
- 4) Socioeconomically Disadvantaged students with red indicators in chronic absenteeism, graduation, suspension, and college and career indicator.

Santa Clara County Office of Education programs are partnering with the California Department of Education (CDE) for Differentiated Assistance. Work underway takes a continuous improvement approach and includes work toward understanding the problems and the systems that produced the areas of needed improvement. Meetings with CDE staff are underway to review student/program data and plan out strategies to meet students needs. Some of the actions that are being supported by DA are 1.8 English Learners, 1.9 Long Term English

Learners, 1.10 chronic absenteeism, 2.1 College/ Career Readiness, and 2.4 Career Preparation Programs and supplies To Support Pathways to Graduation and Career Planning.

Our Special Education Program has been focusing on implementing Empathy Interviews to find the root cause of students absenteeism and to form partnerships between staff and parents in order to boost parent and student engagement.

Similarly Community School has been conducting home visits to explore root causes of student chronic absenteeism and has been tracking visits and results.

Santa Clara County Office of Education (SCCOE) and the Educational Services Division (ESD) facilitate the Comprehensive Support and Improvement (CSI) plans to support student needs as determined by analysis of (a) the California School Dashboard data, (b) local surveys and needs assessments to include the California Healthy Kids Survey, and (c) information obtained during educational partner engagement processes. Currently, two programs in ESD qualify for CSI: (a) Santa Clara County Court Schools, and (b) Santa Clara County Special Education. Programs qualify due to the graduation rate.

Support for Identified Schools

A description of how the LEA has or will support its eligible schools in developing comprehensive support and improvement plans.

The Santa Clara County Office of Education (SCCOE) and the Educational Services Division (ESD) CSI planning is aligned with Local Educational Agency (LEA) processes for annual updates to the Local Control Accountability Plan (LCAP) and School Plans for Student Achievement (SPSA). Notification of the allocation of Comprehensive Support and Improvement funds is provided to school programs annually by the ESD in addition to quarterly categorical funding meetings. Each school program then meets with the School Site Council to review local and state data related to student performance and, in particular, CA School Dashboard indicators. The School Site Council is composed of (a) parents, (b) certificated and classified staff, (c) students, (d) school administration, and (e) community partners. Members of the School Site Council include representation of parents and staff of Students with Disabilities and students who receive English learner services. The School Site Council makes recommendations for spending, and this is contained in the School Plan for Student Achievement (SPSA) after the School Site Council's approval. The SPSA is approved annually by the Santa Clara County Board of Education. A process of continuous improvement enables programs to frequently review progress data and expenditures to ensure funds are meeting the needs of students and developing high-quality programs and systems. Areas of support include a focus on student engagement, climate, and processes to support a well-rounded academic program with an emphasis on college and career readiness. Another primary focus is parent and family engagement as a means to support student growth and pathways to graduation. Student individual needs are addressed with the goal of graduation and college and career skills. Through analysis of strengths and areas for growth, the ESD supports programs in identifying actions and services to support pathways to graduation for students.

Resource Allocation

Resource allocation is completed intentionally according to need. Funds are distributed for CSI plans according to state requirements. The ESD team analyzes needs and the combined use of other state and federal funds to ensure equity for student needs and the best use of funding for student groups. If the ESD identifies a need, the team works collaboratively to ensure the funding meets student needs. This process is also followed through the allocation of Titles I-IV and LCAP Supplemental and Concentration funding at the site level. The CSI funds are used to support immediate needs for improvement as defined in the data and to supplement other forms of funding as an added layer of support. The ESD team continually evaluates progress in funding and resource allocation through quarterly categorical meetings and monthly/ biweekly budget review meetings. These meetings include an analysis of funding and spending for CSI.

County Operated Special Education Program

Although Special Education receives CSI funding, the County Operated Special Education program enrollment does not weigh into the LCFF unduplicated count, and County Operated Special Education does not receive LCFF funding. The county-operated Special Education Program qualifies for CSI for the 2026-27 school year due to low graduation rate. The Special Education program shows a graduation rate of 2.4% but also shows a Certificate of Completion rate of 100%. Through a needs assessment, the Special Education Department and the School Site Council have determined that in order to address the graduation rate, they will select and implement research-based interventions/strategies/ activities to support the academic, social, and emotional needs of students as they meet graduation and IEP goals. These strategies include (a) instructional rounds coaching for staff, (b) Positive Behavior Interventions and Support (PBIS) and increasing student attendance and engagement, (c) Expand Hands-On Science, STEM, Visual and Performing Arts, 21st Century and Innovation Opportunities, (d) Increase Staff Capacity Through Coaching, Targeted Instruction and Professional Development (e) Strengthen Family Engagement and Community Partnerships (f) opportunities for expansion in college/career pathways and life skills.

Court School Program

The Court School Program shows a graduation rate of 50% on the CA School Dashboard. Through a needs assessment, the Santa Clara County Court Schools and the School Site Council have determined that in order to address the graduation rate, they will select and implement research-based interventions/strategies/and activities to support student literacy, math and Career Technical Education programs. These strategies include (a) Professional Learning Community coaching and facilitation to support instruction of students receiving English language acquisition services, (b) Professional Learning Community coaching and facilitation to support the implementation of a broad course of study with emphasis on ethnic studies, civic engagement, and environmental studies, (c) contracts and equipment to support expansion and sustainability of Career Technical Education programs, (d) contracts to support student health/mental health/social emotional and wellness efforts, (e) extra hours for staff to provide summer school instruction/credit recovery opportunities during non contract days, (f) extra hours for staff to support student credit recovery and (g) contract and professional development to expand college readiness.

Research-Based Interventions Used to Support Planning

The ESD utilizes research-based interventions to support the planning and implementation of the CSI Plan. ESD follows a process of continuous improvement and utilizes state-approved and research-based processes when planning. Programs utilize root cause analysis and strategic planning to guide budget development and strategic plans. The ESD also benefits from planning support from SCCOE internal assessment and accountability partners and utilizes improvement science to guide processes. These systems support CSI planning toward a well-rounded student program grounded in research-based strategies. Parent and family input is an integral part of the process.

Monitoring and Evaluating Effectiveness

A description of how the LEA will monitor and evaluate the plan to support student and school improvement.

The Santa Clara County Office of Education (SCCOE) and the Educational Services Division (ESD) participate in a process of continuous improvement that supports the monitoring and evaluation of the Comprehensive Support and Improvement (CSI) Plan. The CSI Plan is revised annually in conjunction with state guidelines and district planning processes. The ESD has a defined process of continuous improvement, which involves (a) data analysis and monitoring, (b) educational partner input structures, and (c) alignment of monitoring and evaluation processes with resource allocation and budgeting. This process is continual and systemic and includes alignment of Local Control Accountability Plan (LCAP) goals with School Plans for Student Achievement (SPSA) at the program level, as well as the Comprehensive Support and Improvement (CSI) plan. The CSI Plan for Court, and Special Education programs for 2026-27 addresses the graduation rate.

Program Evaluation The structures above provide an opportunity for data analysis and program evaluation when the budget is developed and as a continual process. Data analysis includes the areas of (a) student enrollment, (b) attendance and absenteeism, (c) student academic outcomes in reading and math, (d) graduation rate, (e) suspension rate, and (f) college and career readiness. The CSI Plan is a part of this program evaluation and monitoring process. CSI funds are used to provide supplemental support for LCAP goals aligned with CA School Dashboard needs. As goals and data are analyzed annually during budget development processes, the value and quality of CSI interventions are also evaluated and modified as needed. CSI funding is used collectively with other state and federal funds to provide a well rounded program to support student needs. Structures are in place to review expenditures and goals as purchases are made and at quarterly meetings. For the 2026-27 school year, the County Operated Special Education and Court School programs will participate in CSI.

Educational Partner Feedback and Support Partner support and engagement through surveys and anecdotal feedback is an integral part of the monitoring and reflection process, and the ESD continually enacts outreach to parents and guardians to garner feedback regarding the needs of students. Program evaluation is also obtained through discussions during parent conferences and Individual Education Plan (IEP) meetings. Student feedback regarding accessibility and needs is valued. Community partners involved with court schools also are included in decision-making meetings.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

The SCCOE and ESD continue to refine the services and support provided to programs and educational partners in building a system of continuous improvement. The ESD leadership has a dedicated vision to ensure all educational partners are valued, and opinions are respected. Communication avenues and structures for input are consistently refined to meet the needs of staff and families. Transparency is a goal, and the ESD desires that educational partners not only provide input but also see the impact of their input as much as possible. A tone of respect and flexibility provides safe spaces for individuals to provide feedback, and various venues are available for input. Data is shared readily, and systems are in place to ensure that state and local data is available and reflective of all groups in a timely manner. Budgeting processes are collaborative, and funding is guided toward student needs and equity in opportunity. Sustainability is built through the training of administrators and teacher leaders as new systems are implemented. Parent leadership is encouraged, several of our parents serve on multiple advisory committees and decisions are made to reflect the needs of the whole child as defined in the CA School Dashboard. The programs within the ESD are diverse and grounded in specific needs. The ESD works to support program-level decisions grounded in LCAP goals related to (a) academic achievement and college and career readiness, (b) student and family engagement, and (c) student transition and support. Through both consistency and communication, the ESD continues to refine processes to implement continuous improvement and support as a means for planning at all levels of the organization. CSI planning is a part of this process.

The 2026-27 Local Control Accountability Plan (LCAP) reflects the recommendations of educational partners.

Goal one provides for the academic progress of students. Goal one reflects recommendations from partners to include (a) positive behavior interventions and support training for staff, (b) professional development opportunities for staff, (c) training for staff to implement culturally responsive teaching and learning and inclusion, (d) training for staff in implementing environmental literacy, ethnic studies, and civic engagement. Also, in goal one, recommendations from partners that are included in the LCAP include (a) the addition of addressing access gaps, (b) online academic programs for learning acceleration for students, (c) enhanced supplemental support for English Learners and Long Term English Learners (LTELs), and (d) enhanced supports for student math and literacy. These recommendations were reflected in input sessions, on the LCAP survey, and by the School Site Councils/ Parent Advisory Committee. Goal one, which is to focus on academic achievement, supports improving the graduation rate for all students.

Goal two supports career and college readiness and pathways to graduation. Goal two reflects recommendations from partners to include (a) career planning and job training, (b) community partnerships to enable students to have relevant work experiences and work outcomes, (c)

opportunities for industry certifications, and (d) expansion of trades and career technical education programming to build program consistency in Alternative Education, (e) Alternative pathway for diploma for Special Education and (f) Career and vocational programs for Special Education students, (g) Post-Secondary students career support, (h) dual-enrollment support and (i) College access and support. These recommendations were made through the LCAP survey, input sessions, Youth Advisory Committee, and School Site Councils/ Parent Advisory Committee. Goal two, which focuses on college and career readiness, provides students an opportunity to achieve career readiness and graduate in a timely manner.

Goal three supports fostering relationships with educational partners. Goal three reflects recommendations from partners to include: (a) parent and community engagement activities, (b) enrichment activities to support student engagement, (c) materials to support parent communication and engagement activities, (d) inclusive and reverse inclusion practices, (e) material and support for mental and social-emotional health and wellness, and (f) Therapy support for students. These recommendations were made through the LCAP survey, input sessions, Youth Advisory Committee, and School Site Councils/ Parent Advisory Committee.

Goal four relates to Santa Clara County justice-engaged, foster youth, unhoused, and students with disabilities. Recommendations include more academic support for unduplicated students and continued support for justice-engaged, foster youth, unhoused, and students with disabilities. In addition, recommendations were made to continue to work on student transition. Recommendations were made by the LCAP survey, Youth Advisory Committee, School Site Councils/ Parent Advisory Committee, and LCAP District Advisory Committee.

Goal five represents the Santa Clara County Court School's equity multiplier goal to increase the graduation rate of the school's socio economic disadvantaged students by providing additional support and credit recovery opportunities. Recommendations were made through the LCAP Survey, School Site Councils/ Parent Advisory Committee, and the LCAP District Advisory Committee.

The Districts of Residence are accountable and responsible for addressing special education disproportionality. Therefore in accordance with state regulations and CDE guidance, the determination was made to continue to address disproportionality of student referrals to county operated programs for special education in collaboration with special education partners who contribute to the County Operated Special Education program and to not include this action in the LCAP.

Educational partner engagement is an ongoing part of the LCAP planning, and recommendations are considered as plans are made in both the program-based School Plan for Student Achievement and the LCAP.

An explanation of why the LEA has developed this goal.

The LEA developed this goal in partnership with parents and staff to ensure that students are provided with a well-rounded academic program that leads to a high school graduation. Goal one addresses basic academic needs, intervention, and literacy for all students. Another aspect of this goal addresses support for methods to assess student needs and provides supplemental support with an emphasis on technology-based supplemental learning and literacy. Goal one provides staff training on best teaching practices and implementation of academic programming, as well as additional coaching and support for teaching and learning. This goal extends the focus on teaching and learning to support students in accessing curriculum, obtaining credit recovery, and providing supplemental services to students to support academic needs. Inherent in goal One are opportunities for staff to receive coaching regarding (a) support for students who receive English language acquisition services, (b) implementation of curriculum aligned to civic engagement, ethnic studies, and environmental literacy, (c) coaching to support inclusion, and (d) professional development for staff. The Educational Services team, through ongoing structures at both the LEA and program level, engages in the process of continuous improvement, which provides a thorough understanding of the need for access. This process involves analyzing metrics to include (a) CA School Dashboard results, (b) local assessment data, and (c) educational partner engagement input. Actions and Services, as well as projected expenditures, are aligned to findings from these continuous improvement processes. Data analysis and educational partner engagement enable staff to plan on methods to eliminate barriers, promote achievement, and address access and achievement gaps.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

The Santa Clara County Office of Education (SCCOE) made meaningful progress in implementing Goal 1, which focuses on ensuring all students participate in rigorous, relevant, and engaging instruction aligned to 21st century skills. Several actions were fully implemented, while others were partially implemented or are still in development.

Fully Implemented Actions: Actions 1.1 (Supplemental Programs to Support Core Instruction), 1.3 (Learning Acceleration Opportunities for Students in the Alternative Education Program), 1.5 (Access to a Broad Course of Study), 1.6 (Support in Math and Reading Literacy Intervention), 1.7 (Online Reading and Math Assessments), and 1.11 (Support and Professional Development to Reduce the Suspension Rate) were fully implemented as planned. Notably, Action 1.3 saw expanded support with additional hours allocated, enhancing instructional impact and credit recovery efforts. Action 1.7 benefited from a multi-year contract, ensuring continuity in monitoring student progress.

Partially Implemented Actions: Actions 1.2 (Supplemental Materials to Support Core Instruction), 1.4 (Professional Development for Staff for Instructional Programs), 1.8 (Supplemental Materials to Support English Language Instruction for English Learners), 1.9 (Supplemental Support for Long Term English Learners), 1.10 (Support to Address Attendance Gaps and Chronic Absenteeism), and 1.12 (Professional Learning for Staff to Support Core and Supplemental Programs) were partially implemented. For Action 1.2, some materials were purchased but the full scope of the action is still being developed. Action 1.4 saw professional development and contracts initiated, but expansion of opportunities is still underway, with a challenge noted around registrations selling out due to high demand. Actions 1.8 and 1.9, both targeted through Differentiated Assistance, had some supplies purchased but remain under development to ensure they are intentional and truly supportive of English Learners and Long Term English Learners. Action 1.10 saw progress through the development of empathy interviews and home visits; however, other planned initiatives, including the purchase of a van, were not completed, and the action remains a work in progress. Action 1.12 had professional development and contracts completed, but some professional development opportunities are still under development.

Substantive Differences: Several substantive differences were noted. Action 1.10 originally included the purchase of a van to support attendance and student engagement, which was not completed. Actions 1.8 and 1.9 are being expanded and refined through Differentiated Assistance to more intentionally support English Learners. Action 1.12 did not complete all planned professional development. Action 1.11 noted some overlap between actions.

Successes: Key successes included the expansion of Action 1.3, where more students participated in credit recovery and benefited from morning one-on-one intervention supports. The multi-year contract supporting Action 1.7 ensured consistency in assessment and progress monitoring.

Challenges: Challenges included high demand for professional development leading to registrations selling out (Action 1.4), the ongoing development of supports for English Learners and Long Term English Learners through Differentiated Assistance (Actions 1.8 and 1.9), and the continued work needed to address chronic absenteeism (Action 1.10).

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The material differences between the Budgeted Expenditures and Estimated Actual Expenditures are primarily the result of spending coming in lower than anticipated. Throughout the year, we adopted a more intentional and disciplined purchasing approach, prioritizing essential needs and evaluating alternatives before committing to expenditures. This shift led to meaningful cost savings across several categories, creating a variance between what was originally budgeted and what was ultimately spent.

Similarly, differences between the Planned Percentages of Improved Services and the Estimated Actual Percentages reflect the efficiencies gained through this intentional approach. Many service improvements were achieved at a lower cost than projected, allowing outcomes to remain on track or in some cases exceed expectations despite reduced spending. These variances represent strategic resource management rather than unmet goals, demonstrating that improved services can be delivered without fully expending the budget.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Goal 1 shows a mixed picture of effectiveness across its actions:

Areas of Strength: Credit recovery (Action 1.3) has been highly effective, particularly at Court School (+89.4% in credits earned). LTEL reduction (Action 1.9) and reclassification rates (Metric 1.2) show strong progress across all programs. ELPAC growth (Metric 1.1) of 21.2% above baseline is encouraging. DASS graduation rates improved across all programs. Special Education showed meaningful Dashboard gains in ELA and Math for English Learners and Socioeconomically Disadvantaged students. Local reading and math grade equivalency improved from baseline. SCCOE-wide CAASPP and Dashboard indicators in ELA and Math improved.

Areas for Growth: Chronic absenteeism remains significantly elevated from baseline across all programs, though Year 1 to Year 2 trends show improvement. Suspension rates, while improving at some sites, remain above baseline SCCOE-wide.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Based on reflection of prior practice, several targeted revisions were made to strengthen alignment with our goal of improving academic outcomes. Action 1.4 was removed, as its intent is fully captured within Action 1.12, reducing redundancy and improving clarity of focus. Actions 1.7 and 1.8 were revised to include supplemental staffing supports, ensuring greater capacity to implement key services effectively. Additionally, language across actions was refined to emphasize services rather than specific positions, allowing for increased flexibility in implementation and more strategic resource allocation.

Action 1.10 was expanded to include transportation supports, recognizing its critical role in improving student attendance and engagement both essential to academic success. These updates better align to our high-leverage strategies: improving instruction, building a strong intervention system. Collectively, the revisions enhance coherence, adaptability, and the ability to meet targeted student outcomes.

The Educational Services Division has developed goal two to support the specific needs of students in the areas of transition, graduation, and college and career readiness. This goal is a maintenance of progress goal because metrics showed a continuous improvement of students transitioning to college/ career programs. The SCCOE will continue the goal and improve services for students. This goal addresses programming for job readiness for students, such as work-related programs and career technical education classes, as well as training for staff in the delivery of programs. Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

The Santa Clara County Office of Education (SCCOE) made strong progress in implementing Goal 2, which focuses on ensuring all students leave prepared for a successful transition to college and/or career as a result of quality programs, services, and curriculum. The majority of actions were fully implemented, with one action partially implemented and continuing to develop.

Fully Implemented Actions: Actions 2.1 (College and Career Programs for Students Who Participate in the Alternative Education Programs), 2.2 (Consumables and Materials for College and Career Technical Education Programs), and 2.3 (Support for College and Career Readiness and Pathways to Graduation) were fully implemented as planned with no substantive differences in implementation. These actions collectively supported the expansion of college and career programming for alternative education students.

Partially Implemented Actions: Action 2.4 (Career Preparation Programs to Support Pathways to Graduation and Career Planning) was partially implemented. Some career pathways were created; however, full implementation and expansion of pathways are still underway. This action is being targeted through Differentiated Assistance.

Substantive Differences: For Action 2.4, the full scope of pathway development has not yet been completed, as the program is still working toward full implementation and expansion of career readiness courses and alternative diploma pathways for Special Education students.

Successes: Key successes included students finding success in career and college pathways through Action 2.1, the development of new partnerships for CTE supplies under Action 2.2, and the continued tracking of student transitions under Action 2.3. The continued expansion of college and career programs across the alternative education program has been a notable achievement.

Challenges: The primary challenge was experienced with Action 2.4, where developing pathways that align to the specific needs of the student population proved difficult. The rollout has been slow but is gaining traction as the program continues to refine its approach through Differentiated Assistance.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The material differences between the Budgeted Expenditures and Estimated Actual Expenditures are primarily due to delays in contract execution and slower-than-anticipated hiring timelines. These delays resulted in lower actual spending compared to what was originally budgeted, as certain planned costs were not incurred within the expected timeframe. Despite these variances, resources were allocated strategically to ensure continuity of services and to maintain support for students and the broader community.

Similarly, differences between the Planned Percentages of Improved Services and the Estimated Actual Percentages reflect the impact of these delays. While some service enhancements were postponed, overall service levels remained strong, and core needs were met. The

organization continued to prioritize student and community support, and progress toward improvement goals remained steady. Looking ahead, we remain committed to expanding supports and strengthening service delivery as staffing and contractual processes stabilize.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Goal 2 shows a generally positive trajectory with notable areas of strength and some areas requiring continued attention:

Areas of Strength:

CTE enrollment and certificates expanded significantly, with more students earning industry-recognized credentials, particularly at Court School where 100% of Socioeconomically Disadvantaged students are enrolled in CTE.

Dual enrollment doubled from baseline (+7 students), providing EL, FY, and SED students with access to college-level coursework.

Community School attendance improved by +20.4%, a substantial gain that suggests CTE and career programming are positively influencing student engagement for SED students.

Graduation rates improved across all programs from baseline: SCCOE +1.9%, Court School +4.7% (SED +4.7%), Community School +9.3%, Special Education +1.5%.

DASS graduation rates showed strong gains: Court School +5%, Community School +6%, Special Education +11.2% (SED +9.7%).

Post-secondary planning saw a 100% increase, with all 338 workability students now having a plan.

Grade 11 CAASPP ELA improved +6.02% from baseline.

Areas for Growth:

The College and Career Indicator declined SCCOE-wide by -2.9% and for SED students by -2.2%, indicating that while participation in career programs is growing, formal CCI-qualifying completions need strengthening.

Advanced Placement participation and passage rates remain at less than 1% with no progress toward targets.

Grade 11 CAASPP Math declined -1.6% from baseline.

Special Education attendance declined slightly (-1.7%).

Work permits in AED decreased, suggesting a need to re-engage students in work experience opportunities.

The Educational Services Division has developed goal three to provide engagement opportunities that will enhance the educational environment to support students and families. These experiences include opportunities for parent/guardian engagement through parent education classes, family events, and enrichment opportunities for students in the form of (a) educational enrichment activities, (b) mentorships and job training, (c) mental health and wellness services, (d) elective classes, and (e) parent engagement events. A focus on creating a safe school environment for students and families grounded in meaningful enrichment activities will enable students to achieve at high levels and meet college and career readiness goals. Actions also provide intentional parent engagement strategies for families of students who identify as English Learners as well as all other parents. In order to meet goal three, which relates to student, family, and community partnerships, the Educational Services team engaged in a process of analyzing state and local data and partner engagement in order to develop actions, services, and expenditures to support the engagement of students and families to support student achievement and graduation. Analyzing metrics and educational partner input as a means to develop actions and services with associated budgeted expenditures will support student achievement and rigorous instruction in an environment that is culturally responsive, inclusive and safe.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

The Santa Clara County Office of Education (SCCOE) made meaningful progress in fostering relationships with educational partners to promote a positive, inclusive, and collaborative environment focused on student achievement. Of the six actions within Goal 3, four were fully implemented (Actions 3.1, 3.2, 3.5, and 3.6), and two were partially implemented (Actions 3.3 and 3.4).

Fully Implemented Actions: Actions 3.1 and 3.2, which focused on enrichment activities for all students and for students in alternative education programs, were fully implemented as planned. While Action 3.2 was successfully carried out, the team experienced some challenges with delays in internal processes related to equipment ordering. Action 3.5, supporting continuous improvement processes and parent engagement, was not only fully implemented but expanded beyond the original plan. Services were increased to include additional student input sessions, deeper collaboration with programs, enhanced multi-tiered input processes, and strengthened staff engagement. Notable successes included tightened practices, root cause analysis, and increased student voice in the planning process. Action 3.6, providing supplemental support and supplies for student mental health and wellness, was fully implemented with no substantive differences or challenges reported.

Partially Implemented Actions: Action 3.3, Parent and Family Engagement Activities for All Students, was partially implemented. While parent engagement supplies were purchased and some events were held, the Family and Community Resources Coordinator position was not filled for approximately 10 months after the previous coordinator was promoted. Internal processes caused delays in replacing the position and establishing a Campus Youth Advocate role instead. Action 3.4, Family Engagement for Families of students identified as English Learners, was also partially implemented. While engagement activities were held, parent participation was lower than expected, and no costs were associated with the action. Low parent participation remains an ongoing challenge for the program.

Overall, the SCCOE demonstrated strong commitment to student engagement, mental health and wellness, and continuous improvement. Key areas for continued growth include strengthening parent and family engagement, particularly for families of English Learners, and ensuring timely staffing to support engagement activities.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The material differences between the Budgeted Expenditures and Estimated Actual Expenditures, as well as between the Planned Percentages of Improved Services and the Estimated Actual Percentages, are primarily the result of shifts in funding sources, spending priorities, and implementation timelines. Several activities originally budgeted under specific actions such as Action 3.1 were ultimately supported by alternative funding sources, reducing the need to expend LCAP funds as planned. In addition, funds were intentionally reallocated to expand student mental health and wellness supports in response to emerging needs, which altered the distribution of expenditures across actions.

Further variance occurred because certain activities aligned with both student enrichment and mental health goals but were recorded solely under Action 3.6 (Mental Health and Wellness). This coding decision contributed to differences between planned and actual spending in Actions 3.1 and 3.2. Delays in hiring and contract execution also resulted in lower-than-anticipated expenditures during the reporting period. At the same time, additional supports were implemented under other actions to meet student and community needs. Despite these variances, the program maintained service continuity and continued to advance improvement efforts across all priority areas.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Goal 3 shows a mixed but generally positive trajectory in fostering relationships with educational partners and promoting student engagement:

Areas of Strength:

Enrichment activities and inclusive opportunities expanded significantly from baseline, with a wide variety of events, excursions, and programming now available across all programs.

Wellness Centers were established at each site, representing a major structural investment in student mental health for EL, FY, and SED students.

Student mental health indicators showed improvement: chronic sadness/hopelessness decreased from 32% to 17%, and optimism increased from 38% to 45%.

Resources provided to students expanded continuously, including health, housing, food assistance, career, and social-emotional supports.

Dropout rates decreased significantly: Court Schools by 13% and Community Schools by 9.2% from baseline.

Graduation rates improved across all programs, with Community School showing +9.3% and DASS Special Education showing +11.2% from baseline.

LCAP survey parent participation increased from 11.57% to 19.81%.

Exit/Reflection Survey maintained 100% participation.

Middle School dropout rate maintained at 0%.

Areas for Growth:

Chronic absenteeism remains significantly elevated from baseline across all programs (SCCOE +32.4%, Community School +32.8%, Special Education +5.8%), though Year 1 to Year 2 trends show improvement.

Formal parent meeting participation (ELAC, SSC, PAC, DELAC) declined from baseline, particularly for English Learner families. This is a critical area for improvement.

Student suicidal ideation increased from 8% to 11%, and life satisfaction decreased from 61% to 56%, indicating a need for expanded crisis prevention and mental health services.

Community School suspension rate increased 7% from baseline, though it improved from Year 1 to Year 2.

Special Education attendance declined slightly (1.7%) from baseline.

There were changes made to action descriptions to better suit the needs of the programs and students. Services were aligned.

The Educational Services Division, has developed goal four based on staff and parent feedback to provide support for intervention/prevention for justice-engaged, foster youth, students experiencing homelessness, and students with disabilities to improve academic outcomes. This goal is relevant to support Santa Clara County expelled students as they meet their rehabilitation plans with the goal of returning to their home districts or achieving placement after graduation. Another aspect of this goal is to sustain current practices for Foster Youth on current services provided to sustain and increase outcomes and support children.

The actions and services in goal four will enable the Santa Clara County Office of Education to increase current levels of collaboration and services to support youth facing expulsion and their school districts in supporting students, sustain the current progress of cross-system coordination and collaboration and will enable services to continue to serve justice engaged, students experiencing homelessness, foster youth and students with disabilities across Santa Clara County.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

The Santa Clara County Office of Education (SCCOE) demonstrated strong and consistent implementation of Goal 4, which focuses on supporting intervention and prevention programs for justice-engaged youth, foster youth, youth experiencing homelessness, and students with disabilities to improve academic outcomes. All eight actions within Goal 4 (Actions 4.1, 4.2, 4.3, 4.4, 4.5, 4.6, 4.7, and 4.8) were fully implemented as planned.

There were no substantive differences between the planned actions and actual implementation across any of the eight actions. The SCCOE successfully carried out professional development to support the transition of students facing expulsion (Action 4.1), maintained an integrated approach to transition services planning with local districts (Action 4.2), and supported student exit surveys and transition plans (Action 4.3). Services for youth experiencing homelessness and foster youth were fully provided through direct educational coordination and material supports (Actions 4.4 and 4.5). The Foster and Homeless Educational Services Department continued to build capacity within Santa Clara County districts through the Community of Practice Network (Action 4.6), provided coordinated educational case management and higher education transition support for foster youth (Action 4.7), and maintained the integrated data system, Foster Vision, to support cross-agency collaboration (Action 4.8).

No specific challenges or successes were reported for any of the actions within this goal. Overall, the consistent and full implementation of all actions reflects the SCCOE's strong commitment to supporting the most vulnerable student populations across Santa Clara County.

No material differences.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Goal 4 shows a moderately effective trajectory in supporting intervention and prevention programs for justice-engaged youth, foster youth, youth experiencing homelessness, and students with disabilities:

Areas of Strength:

District participation in monthly meetings increased from 8-12 to 15 districts, reflecting stronger cross-district collaboration for student transitions.

MOUs and allotments decreased (from 19 districts/120 allotments to 18 districts/105 allotments), which may indicate fewer students needing alternative placement due to improved prevention.

More students remained enrolled to complete rehabilitation plans rather than dropping out, suggesting improved retention strategies.

Countywide Foster Youth stability rate improved +1.3% from baseline, indicating fewer school placement disruptions.

Graduation rates improved across all programs: SCCOE +1.9%, Court School +4.7%, Community School +9.3%, Special Education +1.5%. DASS rates showed even stronger gains. 96% of local districts maintain Foster Youth actions in their LCAPs. 90% of districts continue to subscribe to FosterVision for cross-agency data sharing. Countywide student stability rate improved +0.3%.

Areas for Growth:

Rehabilitation plan completion rate decreased from 32% to 22%, indicating that while students are staying enrolled, they need additional support to complete their plans. Countywide Foster Youth graduation rate remained essentially flat (56% to 55.1%), suggesting that capacity-building and case management have not yet translated into significant graduation gains for Foster Youth. FosterVision participation decreased from 100% to 90%, reducing the comprehensiveness of cross-agency data sharing. SCCOE Foster Youth stability rate declined from 58.5% to 54.9%, indicating internal placement stability challenges. Foster Youth served in Community School remains at less than 1%, with limited data to assess the impact of direct services.

Action 4.5 was changed from providing services to Foster Youth at Community School to providing services for Foster Youth/ Students experiencing homelessness in SCCOE programs.

An explanation of why the LEA has developed this goal.

The Educational Services Division has developed goal five in partnership with parents and staff to establish the equity multiplier goal for the court school to ensure we increase student engagement and improve the graduation rate of socio-economically disadvantaged students. Providing the action items in goal five, the Educational Services Division aims to improve student engagement, thus improving the graduation rate of socio-economically disadvantaged students in court schools. This process involved analyzing metrics to include (a) CA School Dashboard results, (b) local assessment data, and (c) educational partner engagement input. Actions and services, as well as projected expenditures, are aligned to findings from these continuous improvement processes. This process of grouping together metrics, engagement input, and findings with proposed actions, services, and expenditures ensures that resources are allocated to meet student needs as defined in state and local indicators and educational partner recommendations. Analyzing metrics and partner engagement as a means to develop actions and services with associated budgeted expenditures will equip staff and students with the support needed to meet this goal.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

The Santa Clara County Office of Education (SCCOE) demonstrated strong implementation of Goal 5, which focuses on increasing engagement and improving the graduation rate of socio-economically disadvantaged students at Court School. All four actions within Goal 5 (Actions 5.1, 5.2, 5.3, and 5.4) were fully implemented as planned.

There were no substantive differences between the planned actions and actual implementation across any of the four actions. The SCCOE successfully provided personalized transition services for students exiting Court Schools through the Navigator position (Action 5.1), offered extra hours for court school teachers to support credit recovery and tutoring (Action 5.2), and provided additional supports for art and music programming to increase student engagement (Action 5.3).

While all actions were fully implemented, the team did experience challenges with Action 5.4 - Support to expand CTE Pathways. Specifically, delays in the contracting process impacted the timely launch of CTE programs, which in turn affected student access to CTE programming during the school year. Despite these challenges, the SCCOE remained committed to expanding CTE pathways and continued to work toward establishing the necessary contracts and programs to support student engagement and graduation outcomes.

No specific challenges or successes were reported for Actions 5.1, 5.2, or 5.3. Overall, the full implementation of all four actions reflects the SCCOE's dedication to improving outcomes for socio-economically disadvantaged students at Court School through expanded engagement opportunities, credit recovery, arts programming, and career technical education pathways.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There are material differences between budgeted expenditures and estimated actual expenditures. While the funds are still intended to support the designated actions, actual implementation has progressed more slowly than anticipated. As a result, spending has not yet aligned with the original budget timeline. The planned actions remain relevant and will continue to be pursued, with expenditures expected to align more closely with projections as implementation advances.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Goal 5, as an Equity Multiplier Focus Goal, shows a mixed picture of effectiveness in increasing engagement and improving the graduation rate of socioeconomically disadvantaged students at Court School:

Areas of Strength:

DASS 1-Year Graduation Rate improved +5% from baseline (from 90.5% to 95.5%), a strong indicator of progress for SED students.

CA Dashboard Graduation Rate improved +4.7% from baseline when comparing the overall trajectory.

Credit recovery participation maintained at 100% for all SED students, ensuring consistent access to learning acceleration.

CTE enrollment reached 100% for SED students, up +4% from baseline, with a significant expansion in the types and number of industry-recognized certificates available.

Suspension rate maintained at 0%, reflecting a positive and supportive school climate.

Dropout rate improved 13% from baseline overall.

Academic performance showed improvement from Year 1 to Year 2: ELA improved approximately 44.8 points and Math improved approximately 24.1 points on the CA Dashboard.

Student feedback confirmed that programs like Art and Credit Recovery are valued and perceived as helpful.

Areas of Significant Concern:

The Year 2 CA Dashboard graduation rate declined to 50%, a significant drop from Year 1's 71.4% and below the baseline of 66.7%. While the overall trajectory from baseline remains positive (+4.7%), this Year 2 decline is alarming and indicates that progress is not yet sustained.

The Year 2 dropout rate increased to 38.5%, up from Year 1's 15.6%, though still improved from the baseline of 28.6%. This fluctuation suggests instability in student retention.

The College Career Indicator declined -6.7% from baseline (from 13% to 7.4%), indicating that increased CTE participation has not yet translated into formal college and career readiness as measured by the state. English Learner Progress at Court School showed 21.4% making progress in Year 2, with limited baseline data for comparison. For EL students, continued language development support within the court school setting is essential. Implementation has progressed more slowly than anticipated due to the need for sustained collaboration with probation partners and staff buy-in, as noted in the Goal Analysis.

Recommendations for Continued Progress:

- Strengthen the connection between CTE participation and CCI-qualifying pathway completions.
- Intensify transition planning and post-release support to reduce dropout rates and sustain graduation gains.
- Deepen collaboration with probation to ensure educational continuity during and after court placement.
- Expand intervention and tutoring (as added to Action 5.2) to address academic gaps that may be contributing to the graduation rate decline.
- Monitor EL student progress closely and ensure language support services are integrated into all programming.
- Continue to leverage arts, music, and CTE as engagement strategies while strengthening their connection to academic outcomes.

Language was revised to ensure actions are aligned with services rather than specific positions, promoting flexibility in implementation and resource allocation. For action 5.2 intervention was added in order for court school students to receive credit recovery and intervention / tutoring.

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning, particularly to address and reduce disparities in opportunities and outcomes between student groups indicated by the California School Dashboard (California Education Code [EC] Section 52064[e][1]). - Ensuring that all increases attributable to supplemental and concentration grant calculations, including concentration grant add-on funding and/or LCFF carryover, are reflected in the LCAP (EC sections 52064[b][6], [8], and [11]).

The LCAP template, like each LEA’s final adopted LCAP, is a document, not a process.
