Definitions

- “On Roster” means:
 - Being included on the site/district computer based program used to track students’ attendance, grades, and records.
 - Being included in the scheduling of classes in the Fall and Spring .
 - Being included in district announcements

More Definitions

- Mainstreaming
 - Generally refers to the physical placement of students with disabilities with their non-disabled peers.
- Integration
 - Primarily a legal term connoting the actual assimilation of different groups together (disabled and non-disabled), rather than just the facilitation of physical proximity.



More Definitions


- Inclusion
 - A more popular term referring to the move to educate all children, to the greatest possible extent, together in a regular classroom setting.

The Numbers

- **Current enrollment of 13 students**
 - All students integrated at least one class per day (23% of class integrated less than 50%)
 - Ten students integrated in three or more classes per day. (77% of class is integrated 50% or more)

District Concerns

- Grades: How does county currently report grades?
- Credentials: Will there be credentialing issues?
- Class size: What is the impact on contracted class size?

- Sorting: How do we separate county kids from district kids in the system?

Benefits

- Students have more access to all courses offered
- Greater awareness of county presence on site

- Greater participation from general ed. teachers at IEP meetings

SCCOE SELPA Special Education Housing Policy

- Goal: When it is not possible to educate students with disabilities in their home school, they receive the services specified in their IEP in classrooms located as close to their homes as possible.
- “This goal is intended to fulfill the SELPA’S purpose that the students and staff be included to the greatest extent possible as a part of the school community.”

Institutionalized Discrimination

- Refers to the unjust and discriminatory mistreatment of an individual or group of individuals by organizations such as governments, corporations, public institutions, and other societal entities.
- Typically codified into the operating procedures, policies, laws, or objectives of such institutions.

A Matter of Rights

- **1973** : Section 504 The Rehabilitation Act
 - Banned discrimination on the basis of disability
- **1975**: Individuals with Disabilities Education Act – (IDEA) (P.L. 94-142)
 - Gives children with disabilities' right to equal educational opportunities
- **1992**: Americans with Disabilities Act (ADA)



Section 504 of the 1973 rehabilitation Act

- Banned discrimination on the basis of disability by recipients of federal funds.
- The exclusion and segregation of people with disabilities is viewed as discrimination.
- People with disabilities are viewed as a minority group.

Passage of ADA

- Accommodating a person with a disability is no longer a matter of charity, but instead a basic issue of civil rights.

Conclusion

- This is an issue which must be addressed from the top.
