SUBJECT:	2021-22 Santa Clara County Suspension Results

The following information summarizes the 2021-22 school year suspension data. The results are presented for Santa Clara County and the State of California and disaggregated by student groups, grade spans, disproportionality, and most serious offense categories. The glossary below is provided for general understanding of suspension data terms and methodologies.

#### **Glossary of Terms**

**Suspension Rate:** The unduplicated count of students who were suspended divided by the cumulative enrollment of the applicable student population.

**Unduplicated Count of Students Suspended**: Total count of all students of the applicable student population who were suspended one or more times. Students who are suspended multiple times are only counted once.

**Cumulative Enrollment:** Cumulative enrollment consists of the total number of unduplicated primary and short-term enrollments within the school year (July 1 to June 30), regardless of whether the student is enrolled multiple times within a school or district.

**Percent of Students Suspended:** For a given student group population of a given entity, that population's unduplicated count of students suspended divided by the total unduplicated count of students suspended of the entity (i.e., county or State).

**Percent of Cumulative Enrollment:** For a given student group of a given entity, that student group's cumulative enrollment divided by the cumulative enrollment of the entity (i.e., county or State).

**Disproportionality:** For a given student group, a calculation of the percentage the student group represents of all students suspended divided by the percentage the student group represents of all students' total cumulative enrollment. A measure of 1 represents an equal (1 to 1) suspension to enrollment ratio. A measure of 2 indicates that a student group is proportionally represented twice as much (or 100% higher) in an entity's students suspended total as they are in the entity's cumulative enrollment total. A measure of 0.50 indicates that a student group is represented half as

#### SUSPENSION RATE OVER TIME

The following graph represents the suspension rates for Santa Clara County and California over the past five years. Santa Clara County's suspension rate has consistently been lower than California's rate, with the latest difference being the county rate of 2.3% compared to the statewide rate of 3.2%. Santa Clara County's 2.3% suspension rate in 2021-22 was slightly less than the prepandemic rate of 2.5% in 2017-18 and 2018-19.




Figure 1: Suspension Rates from 2017-18 to 2021-22, Santa Clara County and California

\*The COVID-19 pandemic resulted in statewide physical school closures in February/March 2020 followed by the widespread implementation of distance learning during the 2020–21 school year. The CDE recommends caution when comparing discipline data across school years.

## SUSPENSION RATES BY STUDENT GROUPS

When suspension rate results are disaggregated by student groups, significant variation emerges. Illustrated below are the student group results by gender and race/ethnicity for Santa Clara County and California. As with the overall rate, in most cases Santa Clara County's suspension rates were lower than the statewide rates. Notable exceptions were that Santa Clara County's suspension rates were higher than California's for Hispanic/Latino (3.9% vs. 3.3%) and Pacific Islander (5.9% vs. 4.7%) and equal for Filipino (1.2%) students.

Within Santa Clara County, the male suspension rate was more than twice the rate for females, and the African American, American Indian/Alaska Native, Hispanic/Latino and Pacific Islander student groups suspension rates were well above the county rate and the rates of the other racial/ethnic groups.




Figure 2: 2021-22 Suspension Rates by Gender and Race/Ethnicity, Santa Clara County and California

Similarly, when overall results are disaggregated by programs as displayed below, Santa Clara County's suspension rates were most often lower than the statewide rates. The exceptions were that Santa Clara County's suspension rates were higher than California's for Homeless (6.4% vs. 5.6%) and equal for Socioeconomically Disadvantaged (4.0%) students.

The suspension rates for Santa Clara County Socioeconomically Disadvantaged, Students with Disabilities, Homeless and Foster students were all at least twice as high as their countywide peers who were not in these groupings.





Figure 3: 2021-22 Suspension Rates by Student Program, Santa Clara County and California

#### SUSPENSION RATES BY GRADE SPAN

The following visualization illustrates the suspension rate data disaggregated by grade span. Santa Clara County suspension rates were lower than the State across the grade spans. When grade spans are compared to one another, students in grades 7-8 had the highest suspension rate followed students in grades 9-12. In Santa Clara County, the suspension rate for grades 7-8 was 4.7% and the rate for grades 9-12 was 3.0%

Figure 4: 2021-22 Suspension Rates by Grade Span, Santa Clara County and California




## DISPROPORTIONALITY OF STUDENTS SUSPENDED

The illustration below displays the disproportionality of Santa Clara County's suspended students by gender and race/ethnicity. Suspension disproportionality represents the unequal correlation between the percentage a student group represents of the students suspended total compared to the percentage they represent of the enrollment total (see glossary at beginning for examples). Hispanic/Latino students are over-represented in the cohort of suspended students by a measure of 1.74 (74% higher than their enrollment ratio), African American students are over-represented by a measure of 2.25 (125% higher) and Pacific Islander students are over-represented by a measure of 2.62 (162% higher).

The 1.74 measure for Santa Clara County Hispanic/Latino students compares to a 1.06 measure statewide. The 2.62 measure for Santa Clara County Pacific Islander students compares to a 1.47 measure statewide. March 2023 Page **6** of **15**  In the same fashion as the previous page, the illustration below displays the disproportionality of Santa Clara County's students suspended by programs. Though Foster students have the smallest cumulative enrollment (615 students) the group is by far is the most disproportionally represented amongst students suspended with a measure of 4.88 (388% higher than their enrollment ratio). The disproportionate numbers of students suspended is also quite alarming for Socioeconomically Disadvantaged (1.76 or 76% higher), Students with Disabilities (2.29 or 129% higher) and Homeless (2.80 or 180% higher).

The disproportionality measures for Santa Clara County's program groups are higher than their statewide counterparts: Foster (4.88 vs. 3.98); Homeless (2.80 vs 1.75); Student with Disabilities (2.29 vs. 1.74); Socioeconomically Disadvantaged (1.76 vs. 1.27); and English Learners (1.32 vs. 1.02). 


Figure 6: 2021-22 Disproportionality of Students Suspended by Program, Santa Clara County

#### **MOST SERIOUS OFFENSE CATEGORIES OF SUSPENSIONS**

Suspension incidents often involve multiple offenses. The illustration below compares Santa Clara County to California by the most serious offense category of suspension incidents during the 2021-22 school year. About half of all suspension incidents in Santa Clara County and statewide have a Violent Incident (No Injury) as the most serious offense category. The largest difference between Santa Clara County and California in 2021-21 was that in Santa Clara County, 19.5% of suspension incidents' most serious category was Violent Incident (Injury) compared to a 15.5% rate statewide. 

#### **APPENDIX A**

#### Federal Offense Categories, Defiance Only, and "Other"

In order to report summaries of student-level disciplinary outcomes (suspensions and expulsions), the CDE has mapped each of the 33 California Education Code sections reported in CALPADS to their corresponding Federal Offense categories and the following suggested Federal severity hierarchy:

- Violent Incident (Injury)
- Violent Incident (No Injury)
- Weapons Possession (No Injury)
- Illicit Drug Related (Includes Alcohol)
- Defiance Only (Not Part of the Federal Hierarchy)
- Other (Not Part of the Federal Hierarchy)

**IMPORTANT NOTE:** For DataQuest reporting, all suspensions and expulsions are counted under the Federal Offense Category associated with the most severe offense committed by a student in an incident, unless the most severe offense committed belongs to the "Defiance Only" or "Other" nonfederal categories.
