Parent Engagement Questions that Extend the LCAP Template Guiding Questions

Per the chart on the reverse, meet with key parent and community stakeholders at the various school and district advisory meetings to compile information in meeting minutes from parents and community groups in the development, review, and support of the Local Control Accountability Plan. After reviewing the parent engagement guiding questions included in the LCAP template, a district can use the additional questions below to extend the LCAP template guiding questions:

1. List the parent policies in place that support student achievement for English learners, low income pupils, foster youth, and all other students.
2. List the various opportunities for parent and community partners to participate in decision-making, access to school programs, and receipt of student and school information with resources.
3. Identify the various types of programs and educational strategies at your school or district that have had the greatest impact on student achievement for English learners, low income pupils, foster youth, and all other students?
4. How can district and school staff provide added opportunities for parents and community partners to access school staff and programs on an ongoing basis?
5. What parent and community partnership strategies at your school and district have effectively supported the overall achievement of English learners, low income pupils, foster youth, and all other students?
6. What parent education and academic program education programs provide parent and community partners with the best information to support students in their academic learning?
7. How can parents and community partners participate more fully in the academic success of all students at your school site and through the district programs?
8. How can parents and community partners become more engaged in increasing school attendance and graduation rates and support the decrease of absenteeism and dropout rates?
9. How can parents and community partners support an increase in school safety and school connectedness and decrease in pupils' expulsion rates?
10. How can the district monitor the implementation of the Local Control Accountability Plan to ensure ongoing parent and community engagement?
