A LOOK AT LEARNING (A.L.L.) TRAINING OF TRAINERS (TOT)

This training is designed to help districts build capacity in developing a cadre of experts and teams who are highly committed to increase the academic achievement of English Learners. This training is based on English learner research-based best practices, Common Core State Standards (CCSS), the new English Language Development (ELD) Standards, and the Active Implementation Frameworks. Implementing these research-based practices requires a multi-year commitment. A Look at Learning (A.L.L.) is a comprehensive professional development model that has extensive tools, guides, and video resources.

The A.L.L. system enables school districts to streamline multiple academic improvement initiatives in grades PreK-12. The A.L.L. framework addresses four essential focus areas of effective English learner programs: learning environment, planning, apply best teaching and learning strategies, and using assessment for differentiation. Implementation is characterized by teacher's collaborative engagement in cycles of inquiry.

Goal: Participants will learn about the A.L.L. system in order to present the information to school/district teams. They will also use the information learned to guide the school/district implementation.

Outcomes:

- 1. Transition to integrating CCSS with the new ELD Standards in instructional planning and lesson delivery.
- 2. Become familiar with features in the A.L.L. system.
- 3. Use collaborative, procedural and technology norms and protocols strategically.
- Know how to use A.L.L.'s tools to increase teacher efficacy and maximize student achievement.

- 5. Know how to translate the ToT content into action steps in order to implement A.L.L.
- 6. Align district implementation plan with the 17 core components of A.L.L. and its pathway to reach full implementation.
- Prepare to submit a school/district implementation plan for 2013

 2014 following the principles of the Active Implementation

PREPARING RELUCTANT WRITERS TO CONSTRUCT WRITTEN RESPONSES FOR THE COMMON CORE

English learners and under-resourced classmates rarely benefit from the over-the-shoulder writing coaching that advanced students receive outside of school. To meet the text-dependent, evidence-based argumentation and research demands of Common Core writing assessments, these students will require extensive in-class guided

practice constructing articulate responses in an academic register.

Participants will learn effective ways to:

- Introduce and dissect a model paper exemplifying the elements of a CCSSaligned writing type
- Provide an analytical rubric that specifies the attributes of the writing type
- Frontload rhetorical conventions and academic language for a specific writing type
- Structure routine doses of brief academic writing to build competencies for extended responses
- Utilize reading comprehension questions to formulate brief academic writing tasks
- Guide students in making critical register distinctions between casual and academic word choices
- Facilitate productive peer feedback sessions targeting appropriate rubric criteria

Dr. Kinsella will provide an overview of the shifts in emphasis with writing instruction and assessment initiated by the Common Core Standards. She will clarify the differences between merely assigning routing writing tasks and acting as an engaged and informed mentor who introduces and unpacks a writing model, explicitly teaches related language and rhetorical conventions, and guides drafting and revision. Participants will leave with practical resources and model lessons to implement these instructional routines school-wide for Common Core achievement.
