Attached are: (1) a memo concerning the 2014 local educational agency (LEA) poverty and population data that the Census Bureau recently published; (2) a spreadsheet comparing the 2014 Census data by State with the 2013 data, and (3) a spreadsheet containing the 2014 Census data broken out by LEA for California. The U.S. Department of Education (ED) plans to use these data to calculate fiscal year (FY) 2016 (school year 2016-2017) Title I, Part A LEA allocations.
