To fit in your schedule, sessions are held late afternoons and evenings (plus the occasional Saturday).

The EPIC program prepares candidates to become teacher specialists in an inclusive classroom. It provides instructional and experiential opportunities to work with families, develop collaborative skills and become proficient classroom managers. Candidates learn from the best experts in the field—current and past teachers, special education directors and scholars.

Interested candidates may choose from these credentialing programs:

- Preliminary Early Childhood Special Education
- Preliminary Moderate/Severe
- Clear Education Specialist Induction Program

The EPIC process

Coursework is divided into modules covering a two-year period and candidates work as interns in their second year in the Preliminary Credential Program. Participants are in a cohort throughout the program, sharing their learning experiences and beginning cross program collaborations – learning collaborative behaviors that will assist them throughout their careers as Education Specialists.

Each EPIC module unit is equivalent to ten hours of classroom instruction. Each Specialist Credential is equal to 45 quarter units.

To accommodate work schedules, classes meet late afternoons and evenings and on some Saturdays. There are also some Summer courses.

Internships are self-procured by each candidate.



The Preliminary Credential Curriculum

All Preliminary Credential candidates participate in common coursework, and each credential also has additional coursework unique to it.

- Reading and Language Arts
- Moderate/Severe: Intern/Field Experience

Prerequisites for credential programs

- Bachelor of Arts/Science from an accredited institution
- Child Development Course (minimum 3 units)
- Minimum grade point average of 2.75
- Principles of US Constitution or exam
- Pass California Basic Education Skills Test (CBEST)
- Pass or attempt to pass the California Subject Examinations for Teachers (CSET) (at least one subtest) ECSE exempt
- Meet Commission Approved subject matter requirements as appropriate

Clear Education Specialist Induction Program

All Clear Education Specialist Induction Program participants will be provided with a two-year, individualized job-embedded system of mentoring, support and professional learning:

Prerequisites

- Completion of a Preliminary Credential
- Verification of employment in your specialization area
- Proof of completion (copies) for Health Education & Computer Education Courses if you have a level 1 credential

Credentials that can be cleared

- All Education Specialist Credentials
- All General Education Credentials
