Cal Mock Trial (CMT) is the official mock trial program at UC Berkeley. Since its founding in 1999, CMT has consistently been one of the top ten collegiate mock trial programs in the nation

During the 2014-2015 season, CMT placed second in our division at the National Championships. We were also one of only five programs in the entire country to qualify two teams (the maximum possible) to Nationals. We take pride in the depth of our program's talent, selecting approximately twenty-five students (both new and returning) each year from hundreds of applicants.

As a program, we are committed to fostering an environment where every member is encouraged to offer advice to his or her teammates. We work one-on-one with every individual to look over material and improve his or her abilities as much as possible – a practice that we implement in our high school workshops as well.



High School Workshops

WHAT WE DO

In 2011, CMT launched its first high school workshop. Since then, our program has continued to develop a curriculum that helps high school students learn the secrets to success, both in and out of the courtroom. Many of the teams we have worked with have gone on to achieve recognition at both county and state competition.

Our workshop format consists of a two-day training program, where students alternate between interactive lectures that outline the essential skills of mock trial and firsthand experience at putting those skills to the test.

Throughout the workshop, students receive extensive personal feedback (both oral and written) from each of our accomplished team members, who have won American Mock Trial Association awards at the regional, super-regional, and national levels.

We directly work with every individual to pass on the techniques that have allowed our attorneys and witnesses to achieve the highest scores that every student is capable of. We love being able to work with high school students who are passionate about mock trial, and we work hard to ensure that those participating in the workshop have the best experience possible.

We host our high school workshops right here on the UC Berkeley campus. This gives students the opportunity to work in Boalt Hall, which is consistently ranked within the top ten law schools nationally. Students are also given a personal tour of the #1 public school in the world (Go Bears!). If you're interested in working with us, let us know today!

*Our workshop also has three lectures and breakout sessions devoted solely to pre-trial attorneys, which typically run at the same time as our lectures on directs, crosses, and objections. Our pre-trial lectures are divided into Statements & Rebuttal, Questions, and Case Law.
