

**RESOLUTION  
FOR 180-DAY WAIT PERIOD EXCEPTION  
Government Code sections 7522.56 & 21229**

RESOLUTION No.**

**WHEREAS**, in compliance with Government Code section 7522.56 the Santa Clara County Office of Education must provide CalPERS this certification resolution when hiring a retiree before 180 days has passed since his or her retirement date; and

**WHEREAS**, Vicky Blake, CalPERS ID 7518702432 retired from Palo Alto Unified School District in the position of Payroll Supervisor effective December 30, 2018; and

**WHEREAS**, section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is June 29, 2019 without this certification resolution; and

**WHEREAS**, section 7522.56 provides that this exception to the 180-day wait period shall not apply if the retiree accepts any retirement-related incentive; and

**WHEREAS**, the Santa Clara County Office of Education, the Palo Alto Unified School District and Vicky Blake certify that Vicky Blake has not and will not receive a Golden Handshake or any other retirement-related incentive; and

**WHEREAS**, the Santa Clara County Office of Education hereby appoints Vicky Blake as an extra help retired annuitant to perform the duties of the Payroll Supervisor for the Palo Alto Unified School District under Government Code section 21229 effective May 20, 2019; and

**WHEREAS**, no matters, issues, terms or conditions related to this employment and appointment have been or will be placed on a consent calendar; and

**WHEREAS**, the employment shall be limited to 960 hours per fiscal year for all CalPERS employers; and

**WHEREAS**, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal the hourly rate; and

**WHEREAS**, the maximum base salary for this position is \$7,688.00 and the hourly equivalent is \$44.18, and the minimum base salary for this position is \$5,243.00 and the hourly equivalent is \$30.13; and

**WHEREAS**, the hourly rate paid to Vicky Blake will be \$44.18, and

WHEREAS, Vicky Blake has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate; and

**NOW, THEREFORE, BE IT RESOLVED** that the Santa Clara County Superintendent of Schools hereby certifies the nature of the appointment of Vicky Blake as described herein and detailed in the attached employment agreement/contract/appointment document and that this appointment is necessary to fill the critically needed position of Payroll Supervisor for the Palo Alto Unified School District by May 20, 2019 for training of a new Payroll Supervisor and support through continuing payroll cycles.
