Message from the County Superintendent of Schools, Dr. Dewan

Greetings everyone,

One of our goals at the SCCOE is to encourage schools and communities to work together to stop all forms of bullying. October is National Bullying Prevention Month. The intent of this recognition is the prevention of bullying behavior through kindness, respect, acceptance, and inclusion, all of which parallel SCCOE's values and principles of equity, diversity, inclusion, and partnership. The SCCOE is committed to supporting districts and schools in this effort, which includes partnering with county organizations, like the Santa Clara County Public Health Department, Santa Clara County Office of LGBTQ Affairs, and the County of Santa Clara Behavioral Health Services, to provide resources that can help districts and



schools create safe environments for all students to thrive. Another example of this commitment is the work of the SCCOE Safe and Healthy Schools Department to prevent violence and bullying, which includes assessing the implementation of bullying prevention efforts and creating and implementing positive behavior interventions and supports (PBIS) throughout the county. As a regional Technical Assistance Center, the SCCOE PBIS team develops strategies to reduce bullying behavior. The process may look different across communities and across elementary, middle, and high schools, but the overall goal is the same – to reduce bullying behavior.

The beginning of October marks the final quarter of a year, unlike any other. Many still struggle through challenges as a result of the pandemic. We are hopeful and remain ever watchful. Please continue to practice COVID-19 risk-reduction

protocols throughout this season, and look out for one another because that is how we continue to stay stronger together.

Public Health Updates

Celebrating Halloween and Dia de Los Muertos Safely

Several Bay Area health officials released a joint statement on Monday, September 28, 2020. Their collective voice, while reiterating the <u>local</u> and State Health Officer Orders are still in effect, strongly recommends alternative festivities in lieu of traditional activities. Rather than trick-or-treating or the costume parties, consider focusing on decorating, limiting activities to the people with whom you do not reside, and opt for virtual costume parties.

Mandatory Directive for Schools

On August 28, 2020, the State Health Officer released a new framework for restrictions on certain activities, including in-person operations at schools. Under the <u>Blueprint for a Safer Economy</u> framework, schools in counties in Tier 1 remain closed, except for elementary schools that obtain a waiver from the local health officer. When a county enters Tier 2, all schools in that county may resume inperson instruction 14 days later. This directive supplements the State

requirements for schools and describes the process for schools to resume inperson instruction in Santa Clara County.

Santa Clara County Downgrades to Red Tier

Santa Clara County is at the Red Risk Level under the State's new COVID-19 reopening framework. That means certain activities can resume, and certain businesses can reopen indoor operations at reduced capacity. Some indoor businesses and activities are still too high risk to allow at this time, however, and the local order and directives ensure that people who live in the county are protected from these risks. For example, movie theaters, indoor gatherings, and indoor dining are not yet permitted to reopen under Santa Clara County's Order. Remember to follow the more restrictive set of rules. Continue to keep your distance, wear your mask, and get tested.

Be Heard On November 3, 2020!

Due to the pandemic, you may have concerns regarding the November 3rd election. Registering to vote and casting your vote may appear a bit overwhelming. However, during this upcoming election it is actually easier to do both. If you have not yet registered to vote or would like to verify the status of your registration, please visit the <u>California Voter Registration</u>. Please note the **deadline to register to vote is Oct 19, 2020**, 15 days before **Election Day on Nov 3, 2020**. Anyone who is registered to vote will receive a ballot mailed to them automatically. Completed ballots can be returned in the free postage-paid envelope that is provided or can be placed in one of 98 conveniently located drop-boxes throughout the county.

<u>The Registrar of Voters Office</u> will also be open for early voting beginning on October 5, 2020 through Election Day. Voters who prefer to vote in person can still do so at any of the more than 100 Vote Centers that will be open throughout Santa Clara County starting October 31, 2020.

Adhering to COVID-19 protocols, the Vote Centers will offer sanitary, in-person options for a full spectrum of services including language and accessibility assistance. For more information visit sccvote.org/voterschoice or call **866-430-VOTE** (8683). A few dates to keep in mind:
