Message from the County Superintendent of Schools, Dr. Dewan

I'd like to begin by acknowledging the celebration of Indigenous People's Day, Monday, October 12th. On this day and always, we recognize the strength and resilience of indigenous people and honor their heritage, legacy, culture, leadership, and ongoing contributions to Santa Clara County, California, throughout the Americas, and the world.

There are many adults who can positively influence a child's life as they grow up, including school administrators, school principals, and others. October 11th - 17th is School Administrator Appreciation Week. We recognize the important work that administrators do



daily and acknowledge how they have responded to their communities' needs during this pandemic. Thank you to our county's school administration staff for your efforts and collaboration to create conditions at school sites and classrooms that ensure all staff and students feel safe and succeed.

I would also like to honor and acknowledge National Coming Out Day that took place on October 11th. This day is designated to raise awareness, promote inclusion, support individuals within the LGBTQ+ community, and completely denounce homophobia. Coming Out Day honors the courage of individuals who identify as LGBTQ+ to safely come out to their family and friends. The Santa Clara County Office of Education is committed to creating a safe and inclusive learning environment for all students and staff. We are now an OUT for Safe Schools[™] organization! OUT for Safe Schools is a national campaign that encourages school district and school staff to publicly identify as supportive LGBTQ+ allies. Coming out as an ally lets youth and adults know that "safe spaces" exist everywhere, not just the classroom. To provide guidance and resources for creating inclusive schools, we have created the SCCOE Information Resource Guide: Supporting LGBTQ+ Youth.

Please continue to maintain a steadfast commitment to practicing the risk reduction strategies that help keep us all safe and healthy. Remember to wash your hands frequently with soap and water, properly wear a face-covering when in public, and maintain a physical distance of at least 6 feet from others who are not in your household. Public Health Updates

Blueprint for a Safer Economy

On **October 14**, Santa Clara County became eligible to transition to the orange or moderate county risk level of the state's *Blueprint for a Safer Economy* framework. This allows some indoor business operations to open with modifications. A <u>local Santa Clara County Public Health Order</u> overlays the state's requirements at the moderate county risk level. <u>Click here</u> for specific details.

COVID-19 Testing Guidance

At this time, the Santa Clara County Public Health Department (SCCPHD) recommendations for testing of educators and other school staff that are working on-site and have frequent interactions with students or the public, are for them to take a COVID-19 test and have the results prior to returning to the site, and participate in surveillance testing at least once a month. Educators and other school staff should first attempt to access baseline and surveillance testing through their healthcare facilities. Symptom-free essential workers that are unable to receive testing from their healthcare facilities can inform the SCCPHD by going to sccCOVIDconcerns.org and providing information about their experience.

Alternatively, SCCPHD offers free testing in each city in the county one to two weekdays a month. These sites are appointment-based, allowing for a fast testing experience. The County Fairgrounds site offers large capacity appointment-based drive-through testing and is open on Saturdays. Details for each testing site and upcoming testing dates can be found at <u>SCCFreeTest.org</u>.

Celebrating Halloween and Dia de Los Muertos Safely

Several Bay Area health officials released a joint statement on **Monday**, **September 28, 2020**. Their collective voice, while reiterating that <u>local</u> and State Health Officer Orders are still in effect, strongly recommends alternative festivities in lieu of traditional activities. Rather than trick-or-treating or costume parties, consider focusing on decorating, limiting activities to the people with whom you do not reside, and opting for virtual costume parties.



Santa Clara County Health Department

The Santa Clara County Health Department released a new <u>A Parent's Guide to the</u> <u>Reopening of Santa Clara County K-12 Schools</u> on September 21, 2020. The document, which is

Flu Shot Clinic

The **Santa Clara County Public Health Department** recommends that every person aged 6 months and older needs the flu vaccine, every year. This is especially important this year, with COVID-19 also circulating widely in Santa Clara County.

The county will provide free flu shots at the **Santa Clara County Fairgrounds** in San Jose and will continue every Saturday through mid-December. An appointment is not needed. For more information click <u>here</u>.

The Public Health Department continues to help more people get tested for COVID-19. Those without health insurance or those who do not provide insurance information can still get a test at those sites. For people without COVID-19 symptoms, the County currently offers indoor and drive-thru sites. People with symptoms are directed to drive-thru sites to reduce the chance of getting others sick.

Be Heard on November 3, 2020!

Due to the pandemic, you may have concerns regarding the November 3rd election. Registering to vote and casting your vote may appear a bit overwhelming. However, during this upcoming election it is actually easier to do both. If you have not yet registered to vote or would like to verify the status of your registration, please visit the <u>California Voter Registration</u>. Please note the **deadline to register to vote is October 19, 2020**, 15 days before **Election Day on November 3, 2020**. Anyone who is registered to vote will receive a ballot mailed to them automatically. Completed ballots can be returned in the free postage-paid envelope that is provided or can be placed in one of 98 conveniently located drop-boxes throughout the county.

<u>The Registrar of Voters Office</u> will also be open for early voting beginning on October 5, 2020 through Election Day. Voters who prefer to vote in person can still do so at any of the more than 100 Vote Centers that will be open throughout Santa Clara County starting October 31, 2020.

Adhering to COVID-19 protocols, the Vote Centers will offer sanitary, in-person options for a full spectrum of services including language and accessibility assistance. For more information visit <u>sccvote.org/voterschoice</u> or call **866-430-VOTE (8683)**. A few dates to keep in mind:
