Each year, every school in California is required by state law to publish a School Accountability Report Card (SARC). The SARC contains information about the condition and performance of each California public school. Under the Local Control Funding Formula (LCFF) all local educational agencies (LEAs) are required to prepare a Local Control and Accountability Plan (LCAP), which describes how they intend to meet annual school-specific goals for all pupils, with specific activities to address state and local priorities. Additionally, data reported in an LCAP is to be consistent with data reported in the SARC.

ConnectED partners with school, district, and community leaders to transform education through Linked Learning pathways so that all students, especially those furthest from opportunity, are prepared to succeed in college, career, and civic life.

OYA Contract with ConnectED:

This scope is for year one of a three-year plan to implement Linked Learning College and Career Pathways into the Santa Clara County Office of Education's Opportunity Youth Academy. The three-year project seeks to move the school's traditional alternative school program of study into a program of study aligned with best practices around getting graduates college and career ready. This will allow the school to provide the youth who come through their doors with viable options for future success by giving them opportunities to enter into aligned college programs and gain a continuum of work-based learning experiences all of which will leave them better positioned and prepped for success. Each year of the three-year plan will focus on a different aspect of the ConnectED four phases of engagement: Year One will focus on Readiness Assessment and Planning, Year Two will focus on Implementation and Year Three will focus on Sustaining practices.
