With the newly approved Charter Material Revision we have adopted a structured Governance Council. Term of office memberships will include the Assistant Superintendent of Student Services & Support, Dr. Steve Olmos who is a permanent standing member of the Governance Council and is the Chair of Council.

#### Terms of Office:

 The County Assistant Superintendent, Student Services & Support Division shall be a permanent member of the Governance Council.

- b. Two (2) Santa Clara County Office of Education employees shall serve a two (2) year term.
- c. The five (5) community members consisting of partners and/or parents shall have a staggered two (2) year term.

In order to create staggered terms, the initial terms of community members or parents will be determined by a random drawing whereby two (2) members will serve a one (1) year term and the other three (3) Members will serve a two (2) year term. All subsequent terms will be for two (2) years. Community members or parents who serve as Governance Council Members will be limited to serving three (3) consecutive terms, whether full terms or three (3) partial in the case of an appointment. This will allow multiple community members or parents to serve Opportunity Youth Academy over time. Terms will be from December through November of each calendar year. The student representative will serve for one school year.
