  - ii. Phase 2 Scheduled specific times for teachers to have professional development to learn the necessary platforms to engage and work with students. Increased expectations to provide connection to school and

- iii. Phase 3 Planned virtual student success targeted instructional delivery methods, including student support systems for academic and non-academic needs and attendance as it relates to student engagement. Content and assignments are hosted on Schoology, and cohort blending learning are being scheduled.
- d. Shared with students and families the resources listed on the Santa Clara County Office of Education website and provided a list of resources that are available at some of the campuses.
