Approve 2020-2021 School Plan for Student Achievement

California Education Code sections 41507 and 41572 require each school to consolidate all school plans for programs funded through the Consolidated Application and Reporting System, into the School Plan for Student Achievement (SPSA). The SPSA is completed annually by school sites accepting federal funds. Through a stakeholder engagement process including staff, students, and parents the school site sets goals and budgets funds to support student achievement and student and parent engagement.

The Opportunity Youth Academy's School Site Council revised and approved 2019-2020 and 2020-21 School Plan for Student Achievement to include updated budget information on June 2, 2020.
