The Expanded Learning Opportunities Plan will explain how Opportunity Youth Academy will use the funds it receives through the Expanded Learning Opportunities (ELO) Grant to provide supplemental instruction and credit recovery options for students. These funds will be available in fiscal year 2021-2022 and will cover program operations through August 30, 2022.

An LEA receiving ELO Grant funds under EC Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.
