Background

Section 124(e) of Assembly Bill 130 requires LEAs to present an update on the annual update to the 2021–22 LCAP on or before February 28, 2022 at a regularly scheduled meeting of the governing board or body of the LEA. At this meeting the LEA must include all of the following:

- Mid-year expenditure and implementation data on all actions identified in the 2021–22 LCAP.

Student Impact

The LCAP Supplemental content directly impacts the academic and social emotional needs of Opportunity Youth Academy (OYA) students and families. The LCAP Supplemental defines district use of federal and supplemental funds and their alignment with Local Control Funding Formula (LCFF) goals and funding. This alignment impacts OYA students

through focus on: (a) rigorous, relevant, and engaging instruction, (b) increase the performance of English Learners, (c) a successful transition to college and/or career, and (d) a culturally responsive and safe learning environment grounded in partnership with community and family members.

Background

A-G Completion Improvement Grant provides additional supports to local educational agencies (LEAs) to help increase the number of California high school pupils, particularly unduplicated pupils, who graduate from high school with A-G eligibility requirements completed for admission to the California State University and the University of California.

Impact

The A-G Completion Improvement Grant focus areas include professional development for staff regarding the logistics of A-G coursework and implementation of Advanced Placement courses, supplemental activities that directly support students accessing A-G courses such as Saturday sessions, intercessions during winter and spring, and tutoring. The A-G Completion Improvement grant supplements services already provided through the Local Control Accountability Plan.
