On March 17, 2020, the Governor issued Executive Order N-29-20 that suspended the teleconferencing rules set forth in the Brown Act enabling legislative bodies to meet remotely. On September 16, 2021, the Governor signed AB 361 authorizing a legislative body subject to the Brown Act to continue to meet remotely using teleconference without compliance with the Brown Act teleconference rules if certain conditions are followed. On <u>September 21, 2021</u>, the County Health Officer issued a recommendation, which is attached hereto and incorporated herein, that public bodies continue to meet remotely. On November 30, 2021, June 2, 2022, June 28, 2022, October

13, 2022, and January 31, 2023 the County Superintendent made findings and adopted Resolution No. 2289-5 authorizing remote meetings pursuant to AB 361.

The County Health Officer has recommended that legislative bodies continue to meet remotely to promote social distancing as one means to reduce the risk of COVID-19 transmission. The Opportunity Youth Academy Governing Board has an important governmental interest in protecting the public health, safety, and welfare of those who participate in meetings of the various legislative bodies during COVID-19 and ensuring that all members of the public can participate safely in meetings of legislative bodies.

California law requires the Comprehensive School Safety Plan of each school to be annually evaluated and amended, as needed, to ensure the plan is being properly implemented (Education Code 35294.2[e]). An updated file of all safety-related plans and materials is maintained by Opportunity Youth Academy and is readily available for inspection by the public.

Comprehensive School Safety Plans are required under SB 719 & AB 115 and contains the following elements:

- · Assessment of school crime committed on school campuses and at school-related functions
- Child abuse reporting procedures
- Disaster procedures
- Suspension and expulsion policies
- Procedures to notify teachers of dangerous pupils
- · Discrimination and harassment policies
- · School wide dress code policies
- · Procedures for safe ingress and egress
- Policies enacted to maintain a safe and orderly environment
- · Rules and procedures on school discipline
- Hate crime reporting procedures

The Comprehensive School Safety Plan will be reviewed and updated by March 1st every year.

Background:

In June of 2022 it was announced that SIATech curriculum was to be phased out and no longer would be available in the fall of 2023. A curriculum committee of five teachers and one administrator was formed and tasked with identifying a new online curriculum for the school.

Initially the committee identified four Learning Management System (LMS) options to include SAAVAS, FuelEd, Edmentum, and Imagine Edgenuity. The committee went through a review process that included presentations to the committee and then all staff. Narrowing the field to Edmentum and Imagine Edgenuity, the committee explored both systems over the course of several weeks. Staff were surveyed and a student voice campaign launched. After 15 weeks of exploration the committee recommended Imagine Edgenuity as the LMS more closely aligned with the needs of OYA students and the program as a whole.
