


School districts receive funding from different sources: state funds under the Local Control Funding Formula (LCFF), other state funds, local funds, and federal funds. LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).



This chart shows the total general purpose revenue Opportunity Youth Academy expects to receive in the coming year from all sources.

The total revenue projected for Opportunity Youth Academy is \$4,151,775.00, of which \$3,276,860.00 is Local Control Funding Formula (LCFF) funds, \$89,724.00 is other state funds, \$157,987.00 is local funds, and \$627,204.00 is federal funds. Of the \$627,204.00 in federal funds, \$14,533.00 are federal CARES Act funds. Of the \$3,276,860.00 in LCFF Funds, \$294,271.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

For the 2020-21 school year school districts must work with parents, educators, students, and the community to develop a Learning Continuity and Attendance Plan (Learning Continuity Plan). The Learning Continuity Plan replaces the Local Control and Accountability Plan (LCAP) for the 2020–21 school year and provides school districts with the opportunity to desribe how they are planning to provide a high-quality education, social-emotional supports, and nutrition to their students during the COVID-19 pandemic.



This chart provides a quick summary of how much Opportunity Youth Academy plans to spend for planned actions and services in the Learning Continuity Plan for 2020-2021 and how much of the total is tied to increasing or improving services for high needs students.


Opportunity Youth Academy plans to spend \$4,687,360.00 for the 2020-2021 school year. Of that amount, \$321,496.00 is tied to actions/services in the Learning Continuity Plan and \$4,365,864.00 is not included in the Learning Continuity Plan. The budgeted expenditures that are not included in the Learning Continuity Plan will be used for the following:

Actions in the Learning Continuty Plan describe of the general fund dollars the school is utilizing to provide continuty of learning during the Covid-19 pandemic in the 2020-21 school year. The additional funds that make up the total general fund budget are also spent on maintaining academic and social programs and services like SIATech Online Curriculum, Mental Health Support Services, College and Career Readiness Curriculum and Support Services, and Professional Development in Universal Design for Learning. Additionally the general fund is used for staffing and operational costs like facility rental costs and maintenance, and classroom materials and supplies.

Increased or Improved Services for High Needs Students in in the Learning Continuity
Plan for the 2020-2021 School Year

In 2020-2021, Opportunity Youth Academy is projecting it will receive \$294,271.00 based on the enrollment of foster youth, English learner, and low-income students. Opportunity Youth Academy must describe how it intends to increase or improve services for high needs students in the Learning Continuity Plan. Opportunity Youth Academy plans to spend \$321,496.00 towards meeting this requirement, as described in the Learning Continuity Plan.

Update on Increased or Improved Services for High Needs Students in 2019-2020



This chart compares what Opportunity Youth Academy budgeted in the 2019-20 LCAP for actions and services that contributed to increasing or improving services for high needs students with what Opportunity Youth Academy actually spent on actions and services that contributed to increasing or improving services for high needs students in the 2019-20 school year.

In 2019-2020, Opportunity Youth Academy's LCAP budgeted \$999,057.00 for planned actions to increase or improve services for high needs students. Opportunity Youth Academy actually spent \$1,102,739.80 for actions to increase or improve services for high needs students in 2019-2020.
