INTRODUCTION

This report summarizes the 2010 findings of specific monitoring responsibilities of County Superintendent of Schools as identified by the Williams Settlement and subsequent legislation in four key areas:

1. **Instructional materials** – Students must have sufficient access to standards aligned materials or textbooks;
2. **Facilities maintenance** – Schools must be in “good repair” (safe, clean, and functional);
3. **Teacher credentialing** – Teachers must have proper certification or training, especially for classes with 20% or more English Learners (EL); all classes must be assigned a permanent teacher of record; and
4. **Public reporting** – School Accountability Report Cards (SARC) must include information on Williams; non-compliance with Williams must be incorporated in Uniform Complaint Procedures and classroom posting of notices.

Teacher credentialing was monitored during the 2009-10 school year and teacher vacancies were monitored during the first semester of the 2010-11 school year.

All instructional materials and facilities monitoring was conducted during fall 2010 based upon a list of Deciles 1-3 schools according to 2009 Base API scores and/or schools designated under the Quality Education Investment Act (QEIA).

SUMMARY OF FINDINGS

Based upon the 2009 Base API results and/or QEIA designation, there were 51 schools in 12 school districts that were subject to instructional materials and facilities monitoring that requires physical inspections. These 51 schools had a combined 2009-10 enrollment of 33,985, approximately 13% of the total 2009-2010 enrollment in Santa Clara County (n = 265,544). The type of school (elementary, middle or high) is designated by (E), (M), or (H) in the table.

Instructional Materials

Students must have sufficient access to standards aligned materials or textbooks.

All Deciles 1-3 and/or QEIA schools must be visited within the first four weeks of school. A sampling methodology is used, in which at least one in every five classes in every section, by grade and/or by subject, is visited by a Williams monitor to determine that each student has a district adopted, standards aligned textbook for use in class and at home.

In the fall of 2010, staff from the Santa Clara County Office of Education (SCCOE) visited 841 classrooms. Williams monitoring was first implemented in the spring of 2005. In that first year, 19 of the 40 (48%) schools monitored had classrooms that were found to be deficient. In the fall of 2010, 15 of the 51 (29%) schools monitored had deficiencies. Fifty-six classrooms (7%) were found to have insufficient textbooks during the initial inspection. All textbook insufficiencies were corrected within three days of the initial inspection.

Facilities Maintenance

Schools must be in "good repair" (safe, clean, and functional).

All Deciles 1-3 (2009 API) and/or QEIA schools are subject to facility inspection by staff from the County Office of Education. The inspections are conducted by teams using the Facilities Inspection Tool (FIT), developed by the California Department of Education's Office of Public School Construction to determine if a school is in "good repair" as defined by Education Code Section 17002(d) and to provide a rating of its condition. The FIT was first used in 2007 and was revised in 2009. The FIT evaluates school facilities in 15 areas and an overall "good repair" rating is determined according to the following standards:

- Playgrounds/School Grounds
- Overall Cleanliness

The 51 schools monitored in fall 2010 received an average rating of "Good" with an average score of 93.0%. This is lower than the 2007 average of 98.4% (Exemplary), the first year in which the FIT was used, and continues the downward trend in facilities monitoring results observed since 2007.

Teacher Credentialing

Teachers must have proper certification or training, especially for classes with 20% or more English Learners; all classes must be assigned a permanent teacher of record.

Staff from the SCCOE Credentials Department monitors all visited Williams schools to ensure that teachers are appropriately credentialed for their assignment, including authorization for teaching students who are designated English Learners. This monitoring is conducted over the course of the school year, and the findings of the 2009-10 monitoring are presented in this report.

In 2009-10, a total of 13 teacher misassignments were identified (6 in Alum Rock Union School District, 5 in East Side Union High School, 2 in San Jose Unified). All teacher misassignments were corrected within 30 days of being identified. Details regarding teacher misassignments are included in the monitoring of findings by school district later in this report.

The Credentials Department also monitors teacher vacancies in visited Williams schools. A vacancy is defined as existing when a permanent, credentialed teacher has not been assigned for the school year. In the first semester of 2010, eight teacher vacancies were found in the 51 schools (6 in Alum Rock Union School District, 1 in Franklin-McKinley School District, and 1 in East Side Union High School District).

Public Reporting

School Accountability Report Cards (SARC) must include information on Williams; non-compliance with Williams must be incorporated in Uniform Complaint Procedures and classroom posting of notices

The Williams Settlement requires school districts establish procedures for notifying parents, teachers, students, and community members of their rights and to make complaints regarding compliance with Williams requirements for instructional materials, teacher qualifications and vacancies, and facilities. Districts are required to post notices of these rights in all classrooms and to establish procedures for responding to and resolving the complaints. Additionally, districts are required to report to their elected boards on the number, type of complaint (i.e., textbooks, teachers, or facilities), and status (resolved/unresolved) of complaints on a quarterly basis.

The districts are also required to submit these quarterly reports to the County Superintendent of Schools. Since 2008, compliance with the Valenzuela Settlement (regarding the provision of supplementary support and instruction to students who had not passed the California High School Exit Exam – CAHSEE) was included in the reporting requirements. A summary of the number and type of complaints for Santa Clara County (all 32 districts plus Metropolitan Education District and the Santa Clara County Office of Education) is presented in the following table.
