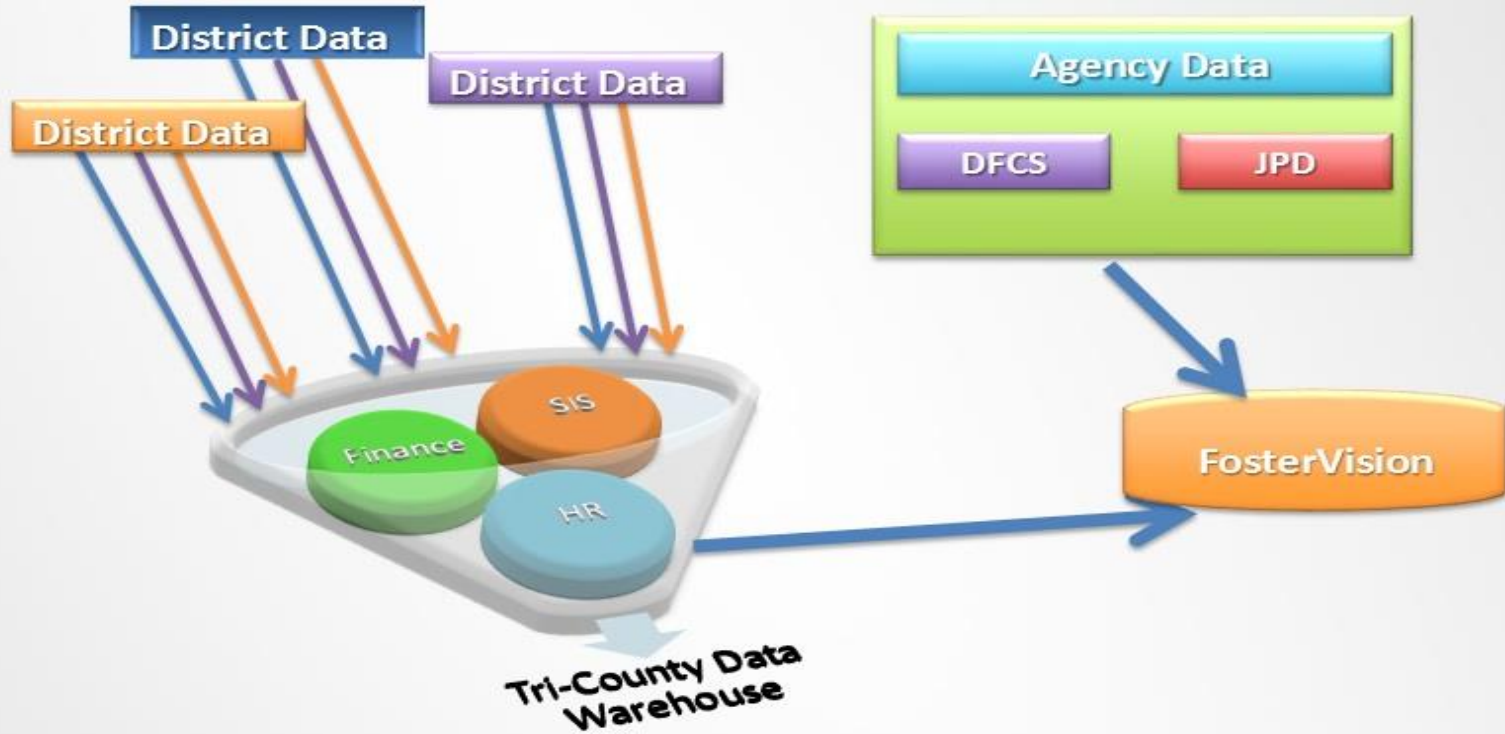
Honorable Judge Patrick Tondreau's bench order to develop one database for dependency court to include education, probation & social services information in one location.

2013 Began developing the DataZone data warehouse

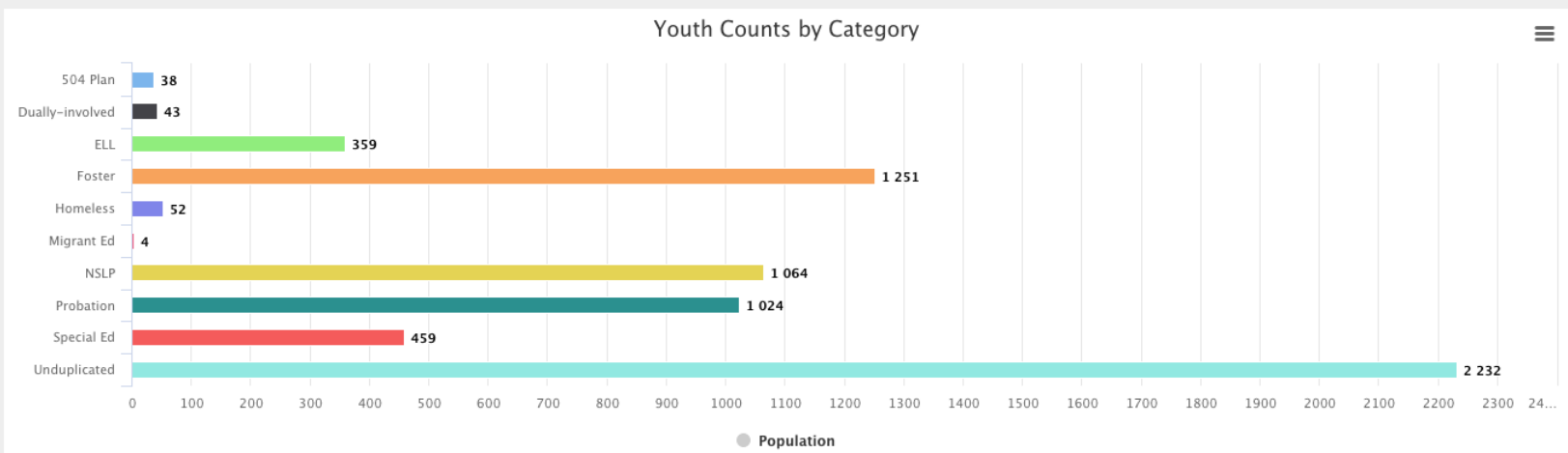
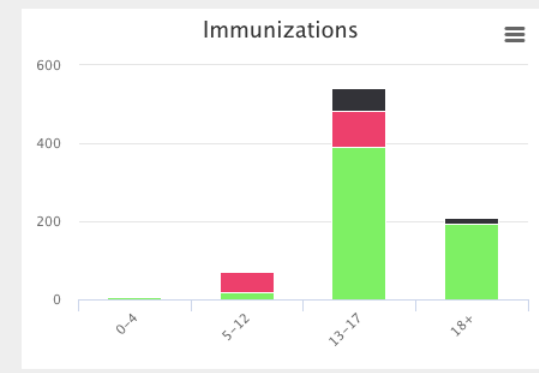
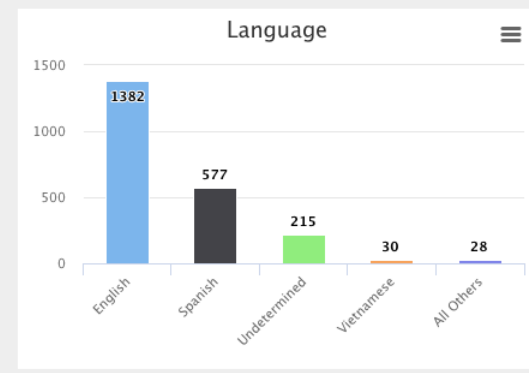
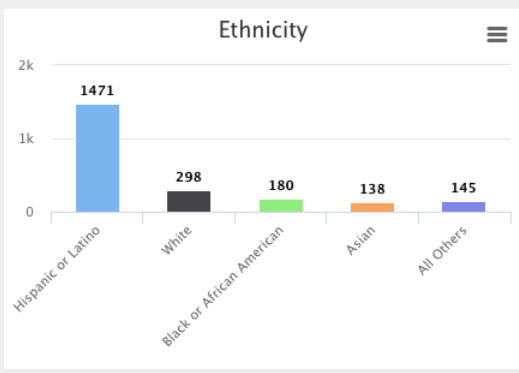
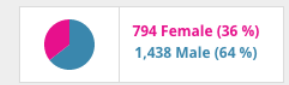
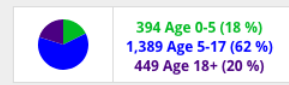
