

AB 2601: CHYA APPLIES TO CHARTER SCHOOLS

- Just signed by Governor Brown
- (1) "School district" includes county boards of education, county superintendents of schools, the California School for the Deaf, and the California School for the Blind.
- (2) Commencing with the 2019–20 school year, "school district" also includes charter schools.

Amendment to EC 51931



"SEXTING": <u>AB 1868</u>

"A school district may provide optional instruction, as part of comprehensive sexual health education and HIV prevention education, regarding the potential risks and consequences of creating and sharing sexually suggestive or sexually explicit materials through cellular telephones, social networking Internet Web sites, computer networks, or other digital media."

Amendment to Section 51934



HUMAN TRAFFICKING

Information on human trafficking shall include both of the following:

 (A) Information on the prevalence, nature, and strategies to reduce the risk of human trafficking, techniques to set healthy boundaries, and how to safely seek assistance.

 (B) Information on how social media and mobile device applications are used for human trafficking.

- Other Policies to check on before teaching CSE:

 - Student Safety
 - Uniform Complaint Procedures
 - Confidential Medical Release
- Funding
 - LCAP lock it in each year!

- All staff need updates on topics covered under CHYA

Parents Need Factual Information and Emotional Support

Messaging for Parents and Communities: Every student deserves to feel safe, welcome, and acknowledged at school.



NEED FOR CSE

Comprehensive sexuality education gives students the knowledge and confidence they need to make healthy decisions. With honest and factual information, students can take charge over the many confusing aspects of puberty and growing up, giving them the space they need to concentrate on their future.



TOO MUCH TOO SOON?

Just because young people are learning about sexuality doesn't mean they're choosing to have sex—but it does open the door for important conversations between parents and their kids. When whole families have the facts, it's easier to talk honestly about safety, consent, and contraception, long before young people need it. In fact, teens who receive comprehensive sex education generally choose to have sex later in life and have lower rates of unplanned pregnancy and STIs.



INCLUSIVITY

LGBTQ students thrive when they see themselves reflected in lessons and learn that it is entirely normal for people to have different sexual orientations or gender identities. Inclusive lessons create a positive effect on all students and reduce bullying, discrimination, and harassment.



INCLUSIVITY

Our communities are diverse, and all students including our LGTBQ students—should see themselves reflected in sex ed lessons. If our goal is to help young people make healthy decisions and be successful throughout their lives, sex ed must be relevant to all young people. Everyone is better off when there is mutual respect and understanding.



PARENTS' ROLES

Families play an indispensable role in preparing kids for the future and should complement the science-based sex ed instruction their children receive in school, just as they might help them with math, biology, or history homework. All of these subjects help prepare students for higher educational achievements and healthy adult relationships, including options like getting married or having a family. We hope parents discuss issues like puberty, consent, sex, gender identity, and healthy relationships with their children to help connect their studies with family traditions and cultures.
