- June 16, 17 and 18: Presentation of information from Countywide Superintendents Association Meeting to SELPAs I, II, III, IV and VII Executive Council Meetings
- Special Meeting for June 2021 or 2021-2022 school year: Executive Council and Rep Council Meetings to finalize SELPA Base Rate agreements.

# IV. ACTION ITEMS

A. Process to invite South East Consortium SELPA for countywide discussion among superintendents regarding SELPA Base Rates

Supt. Jeff Baier moved to approve the process to invite the South East Consortium SELPA for a countywide discussion regarding SELPA Base Rates as outlined above. Dr. Mary Ann Dewan seconded, and the motion carried 5-0.

B. NW SELPA Administrative Unit (AU) Budget for 2021-2022 based on estimated revenue of \$1,283,754 to fund the SELPA AU.

Supt. Jeff Baier moved to approve the NW SELPA Administrative Unit (AU) Budget for 2021-2022 as presented. Dr. Mary Ann Dewan seconded, and the motion carried 5-0.

## C. Approval of Superintendents' Rep Council Meeting Calendar for 2021-2022

Dr. Mary Ann Dewan moved to approve the 2021-2022 SELPA Superintendents' Rep Council Meeting Calenda. Supt. Jeff Baier seconded, and the motion carried 5-0.

## D. Nomination and Election of Rep Council Chairperson and Vice Chairperson for 2021-2022

Supt. Jeff Baier moved to approve the nomination/election of Supt. Polly Bove as the chairperson of the 2021-2022 SELPA Superintendents' Rep Council, with Supt. Jeff Baier as the vice-chair. Dr. Mary Ann Dewan seconded, and the motion carried 5-0.

#### V. INFORMATION ITEM

Director Leo Mapagu provided the following information:

- The SELPA Local Plans are being finalized, awaiting comments from CAC representatives. The Local Plans will be presented to the Executive Councils in mid-June and will be submitted to CDE on June 30, 2021.
- The individual SELPA meetings with district representatives have been combined into "collaborative meetings" to allow better collaboration and sharing of resources among member districts.
- ADR services are now available to parents and district staff through the SELPA office, made possible by the approval of five COVID-19 ADR Grants from the state.
- CALPADS: preparing for EOY 4 and EOY 3; Personnel Data Reports are in progress
- Fiscal: apportionments and projections are underway
- Professional Development: the SELPA AU hosted 33 trainings in 2020-21, with 2,197 duplicated participants. SELPA AU is finalizing plans for a 2-day ADR Conference that will be held in September.

The Council expressed appreciation to the SELPA AU team for all their work in the past year.
