Framing Our Future 2016-2019

Goal: 1 Improve student equity and access to high quality education

Rationale: During the needs assessment phase of the strategic planning initiative, information was collected from branches about the activities, projects, and initiatives being implemented. This information was considered against the values and priorities of the office as determined from stakeholder input.

The strategic actions for Goal 1 are key priorities for which the office has leadership, service, and advocacy roles. A community based need became evident, and research exists.

In the area of early learning, numerous researchers have found positive impacts on educational and societal outcomes. Early Edge of California maintains a website with research about the importance and need for early learning at http://www.earlyedgecalifornia.org/resources/research--- studies/. Many of the studies and research papers provided there form the basis for the SCCOE's ongoing role in supporting early learning expansion as a strategy for preventing the achievement gap.

The Data Zone and the Silicon Valley Regional Data Trust are essential projects to support the urgent need for data sharing to improve educational outcomes for youth. In the article entitled, *The Rise of the Chief Data Officer* (<u>http://www.wired.com/insights/2014/07/rise-chief-data-officer/</u>), the authors note that organizations need to harness the power of Big Data to leverage data for competitive advantage, to legitimize data, inspire change, and identify new opportunities.

The outcomes for foster youth in Santa Clara County suggest a need to study the current delivery system and discover opportunities for improvements. As a key provider of services for foster youth, the SCCOE has a vested interest in ensuring improved outcomes for all foster youth. The Alternative Education and Special Education departments directly serve students from school districts. These programs engage in improvement planning initiatives annually through the state required Local Control Accountability Plan (LCAP) process.
