



**RESOLUTION APPROVING THE FILING OF A LEGAL BRIEF WITH
OTHER SCHOOL DISTRICTS AS *AMICI CURIAE* IN SUPPORT OF THE
COUNTY OF SANTA CLARA'S COMPLAINT CHALLENGING THE
EXECUTIVE ORDER DIRECTING REPRISALS AGAINST SANCTUARY
JURISDICTIONS AND AUTHORIZING THE EXECUTION OF NECESSARY
DOCUMENTS AND RELATED ACTIONS**

**SANTA CLARA COUNTY BOARD OF EDUCATION
RESOLUTION NO: 2199-3**

WHEREAS, on January 25, 2017, President Donald Trump (the "President") signed an executive order that gives the President and his subordinate executive officers, including the Attorney General and the Secretary of Homeland Security, the power to declare any "sanctuary jurisdiction" ineligible to receive federal funds (the "Executive Order"); and

WHEREAS, the Executive Order does not define the term "sanctuary jurisdiction"; and

WHEREAS, the Executive Order directs the Attorney General to take broad enforcement action against any "sanctuary jurisdictions"; and

WHEREAS, the Executive Order fails to provide any state or local government agency designated as a "sanctuary jurisdiction" with notice or the right to challenge the designation through judicial review or any other means; and

WHEREAS, the County of Santa Clara (the "County") has filed a complaint against the President and other officials for declaratory and injunctive relief from the Executive Order (the "Complaint"), attached hereto as Exhibit A; and

WHEREAS, if enforced, the Executive Order will harm undocumented students, their parents, and ultimately, school districts; and

WHEREAS, schools are at the core of our communities and they must remain a safe space for all; and

WHEREAS, in order to address the unique harm and extensive impact the Executive Order would have on school districts if enforced, the Santa Clara County Office of Education (the "Office") desires to file a brief together with other school districts across the State of California as friends of the court or "*amici curiae*" supporting the County's complaint and sharing anecdotal evidence of the effect the Executive Order will have on students and the school community (the "*Amicus Curiae* Brief");

NOW, THEREFORE, BE IT RESOLVED by the Santa Clara County Board of Education (the "Board"), as follows:

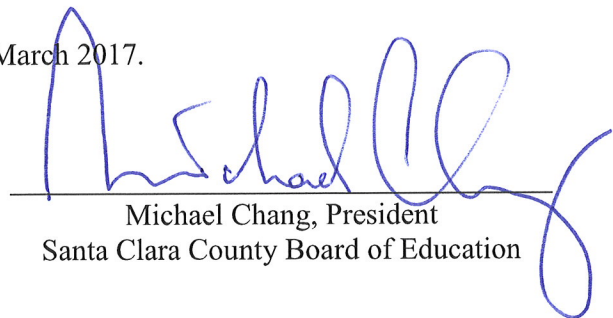
Section 1. Recitals. All of the above recitals are true and correct, and the Board so finds.

Section 2. Authorization to Join the *Amicus Curiae* Brief. Subject to the final review and approval of the *Amicus Curiae* Brief by the Superintendent of the District, the Assistant Superintendent, or such other officer or employee of the District as the Superintendent may designate (each an "Authorized Officer"), the Authorized Officers are each hereby authorized and directed, for and in the name of the District, to join and sign the *Amicus Curiae* Brief as a named *amici*.

Section 3. Delegation of Authority. The Authorized Officers are hereby authorized and directed, jointly and severally, for and in the name of and on behalf of the District, to do any and all things which they may deem necessary or advisable in order to consummate the actions herein authorized and otherwise to carry out, give effect to and comply with the terms and intent of this Resolution, including, signing, on behalf of the District, the *Amicus Curiae* Brief in support of the County's complaint upon an Authorized Officer's review of the *Amicus Curiae Brief* when finalized.

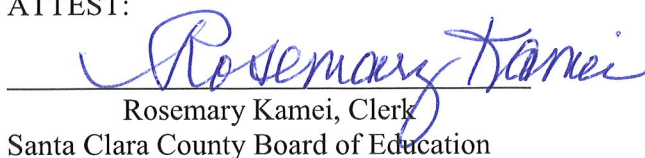
Section 4. Effective Date. This Resolution shall take effect from and after its date of adoption.

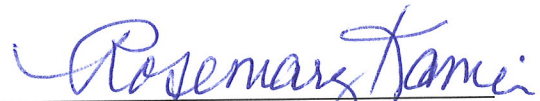
