

Budget Overview for the 2023-24 School Year




This chart shows the total general purpose revenue Alpha: José Hernández School expects to receive in the coming year from all sources.



Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Alpha: José Hernández School (AJH) is part of the Alpha Public Schools network, whose mission is: We believe that all children have a fundamental right to an excellent education. Alpha Public Schools will ensure that all of our scholars develop the academic skills and leadership habits required to succeed in college and live with integrity.

Led by principal Julianna Parra and staffed by a talented and energetic staff, AJH is a safe and tuition-free community school serving students in grades TK-8. The school is co-located with Alpha: Blanca Alvarado School and is authorized by the Santa Clara County Office of Education. AJH develops students into lifelong learners who will enter high school with the academic skills, strength of character, and passion for learning to succeed in and graduate from college.

According to CALPADS as of census day 2022, AJH serves approximately 412 students, 93% of which are low-income. The school's demographic profile is 93% Latino, 3% Asian, 2% Filipino, 1% White, and less than 1% Black and American Indian. We serve a student body that is 63% English Learner and 10% Students with Special Needs.

Reflections: Successes

This school year, we saw the release of CA School Dashboard data for the first time since 2019 due to the COVID-19 pandemic and state regulations. Alpha Public Schools continues to focus efforts on evaluating available state and local data to identify our LCAP areas of success and greatest areas of progress. At Alpha Jose Hernandez, we are proud of our community of students, staff, and families and our

focus and dedication every day to ensure that all members of our community grow and thrive. This school year, while we continue to face attendance and hiring challenges, and see the long term impact the pandemic has had on our community, we have a lot to be proud of and celebrate. Here are some of our successes in meeting our 2021-2024 LCAP goals:

Family Engagement Survey Data:

- 96% of families responded favorably to the question "The school staff listen to parents when they have questions, concerns, or ideas."
- 96% of families responded favorably to the question "The school is preparing all students to be successful in college."
- 93% of families responded favorably to the question "I am satisfied with the level of safety (physical/emotional) at the school."
- 94% of families responded favorably to the question "The school listens to family voice and input when making decisions."
- 95% of families responded favorably to the question "I feel a sense of belonging and connectedness to the school community."

We saw significant growth for all students and our significant student groups in both our ELA and Math NWEA MAP Assessments: ELA NWEA MAP Assessment

42.51% of students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 15.51% from the previous year.

- 42.51% of English Learner students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of -15.51% from the previous year.
- 44.19% of students with disabilities met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of -15.19% from the previous year.
- 41.88% of Hispanic students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 19.88% from the previous year.
- 57.89% of Asian students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 22.89% from the previous year.

Math NWEA MAP Assessment

- 42.61% of students met or exceeded their typical growth goal for spring NWEA MAP assessment in Math, a growth of 19.61% from the previous year.
- 41.79% of English Learner students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of -22.79% from the previous year.
- 25.58% of students with disabilities met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of -11.58% from the previous year.
- 42.13% of Hispanic students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 23.13% from the previous year.
- 57.89% of Asian students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 25.89% from the previous year.

By continuing to implement the following Actions and strategies, we believe we will build upon our successes and ensure that all students are given the opportunity to succeed:

In order to build upon and maintain high family survey results, we will continue to educate Jose parents as to Parent Learning Center supports available, enroll new families and any families not yet enrolled in Konstella, and expand community events, volunteer opportunities on campus, and strengthen our SSC, ELAC and Cafecito (Goal 4).

Our All-Staff data stepbacks were very impactful this school year and we will continue to leverage these spaces to monitor student data, identify performance gaps, and hone in on specific action steps to better support students (Action 3.4)

Reflections: Identified Need

This school year, we saw the release of CA School Dashboard data for the first time since 2019. Alpha Public Schools continues to focus efforts on evaluating available state and local data to identify our LCAP areas of success and greatest areas of progress. Based on the review of our local data and CA School Dashboard state and local indicators, we have identified the following areas that need improvement:

Chronic Absenteeism: As reported on the 2022 CA School Dashboard, our Chronic absenteeism was at a Very High status for all student

groups. The data breakdown is as follows:

All students: 36.2%, compared to 30% state-wide

English Learners: 36%

Hispanic: 37.2%

Socioeconomically Disadvantaged: 35.8%

Students with Disabilities: 31.8%

English Language Arts: As reported on the 2022 CA School Dashboard, our ELA indicator was at a Very Low status for all student groups.

The data breakdown is as follows: All students: 80.3 pts below standard

English Learners: 112.9 pts below standard

Hispanic: 83.6 pts below standard

Socioeconomically Disadvantaged: 78.4 pts below standard

Students with Disabilities: 144.1 pts below standard

Math: As reported on the 2022 CA School Dashboard, our ELA indicator was at a Very Low status for all student groups. The data

breakdown is as follows:

All students: 129.5 pts below standard English Learners: 158.8 pts below standard

Hispanic: 132.5 pts below standard

Socioeconomically Disadvantaged: 127.4 pts below standard

Students with Disabilities: 186.2 pts below standard

English Learner Progress: As reported on the 2022 CA School Dashboard, our English Learner Progress Indicator was at a Low status with 37.2% making progress towards English language proficiency.

Attendance for both scholars and staff continued to be a significant challenge this year. There are steps we will continue and implement next year in order to continue to decrease our chronic absenteeism rates. We have made modifications to our 5.1 Action to support and maintain high attendance, and minimize chronic absence through systems/procedures according to a tiered system of interventions, including data review, supportive conferences, staff/team touchpoints, and school-wide culture. This will also include improved communication procedures for absences and tardies and school and classwide incentives for high attendance. In addition, we will continue to partner with FACTR (Action 5.3), our external provider, and our Dean of Students (Action 5.7) who support students and families access mental health counseling alongside equipping students and staff with strategies that will help students feel safe, motivated, and challenged in classrooms and around campus in order to increase attendance.

California continues to face significant staffing shortages for teachers. The state has been grappling with a critical shortage of qualified educators across various subject areas and grade levels. One major factor is the high cost of living in many parts of California, which makes it challenging for teachers to afford housing and maintain a comfortable standard of living on their salaries. This issue particularly affects regions with higher living costs, such as the San Francisco Bay Area. Alpha Jose directly felt the impacts of this state-wide teacher shortage and was unable to fully staff our academic intervention and ed specialist teams, which had an impact on the consistency of implementing our MTSS program and intervention supports we were able to provide to all students. Currently, we are on track to fully staff our 3 SPED Paraprofessionals (Action 1.8) and 6 Academic Interventionist (Action 1.1) that will allow us to more robustly focus on our students on the margins to implement academic, behavior, attendance strategies. Additionally, to support the growth in our Math performance, we are modifying our Action 1.8 to focus more intentionally on Math supports by providing more push in support during rotational models, implementing common phonics curriculum for readers who are not meeting academic proficiency, and iterating on the Resource Class model for our most underserved students in math.

We were unable to hire an ELD Specialist for the 22-23 SY, but have hired a specialist for the 23-24 SY (Action 3.3), which will have a significant impact on our ELD program and our multi language learner outcomes for SY 23-24. The ELD Specialist will work to improve integrated ELD professional development and supports as the current focus has been on designated ELD, but moving forward, we feel designated by itself is not enough and are not seeing the impact we are looking for in the data.

LCAP Highlights

This year, our LCAP process included a more robust analysis of our LCAP Goals and Actions to ensure we are set up for success in the last year of our 3-year LCAP cycle. As a result of engagement with our educational partners we have made a couple minor updates to the language of our first and second goals that speak more directly to the academic, behavior, and attendance supports we will provide to all students and specifically call out our English Learners and Students with Disabilities in our second goal. The updated Goal language is highlighted below:

Goal 1: We will consistently implement our MTSS framework in order to effectively respond to Academic, Behavior and Attendance needs for all students.

Goal 2: We will create and implement systems for ongoing progress monitoring of student data to drive effective tiered supports, with a particular focus on subgroup performance for English Learners and Students with Disabilities.

In addition to the updates to our first two goals, key features and changes emphasized throughout this year's LCAP which will be a focus for our school next year consist of the following:

Goal 1: Based on educational partner input and data analysis process, Action 1.8 will be adding a Math focus to improve our outcomes for Students with Disabilities with an emphasis on push in support during rotational models, implementing common phonics curriculum for readers who not meeting standards, and iterating on Resource Class model for our most underserved students in ELA and math.

Goal 3: Academic Achievement: We will introduce a new ELA curriculum, Amplify's Core Knowledge Language Arts (CKLA), this year as highlighted in Action 3.1

Goal 5: Learning Environment: As chronic absenteeism continues to affect our school communities, we are focusing our data analysis and monitoring efforts on decreasing chronic absenteeism for all students with an emphasis on our students with disabilities, who continue to have the highest rates among all student groups. Action 5.1 will focus on the support and maintenance of high attendance, and minimize chronic absence through systems/procedures according to a tiered system of interventions, including data review, supportive conferences, staff/team touchpoints, and school-wide culture.

Goal 6: Continue to develop teachers (through 1:1 coaching, PD sessions, walkthroughs, grade level/department meetings) around prioritized indicators from the teacher & coach rubrics. (Action 6.6)

Additionally, Alpha Jose's LCAP will serve as our Additional Targeted Support and Improvement Plan (ATSI). Based on California's approved COVID-19 Addendum, ATSI eligibility determinations in 2022–23 will be based on only one year of Dashboard results (i.e., the 2022 Dashboard). Schools are eligible for ATSI if one or more student groups meet one of the following criteria:

- · All indicators at the lowest status level; or
- All indicators at the lowest status level but one indicator at another status level

The first criterion applies for all student groups that have at least one state indicator with a n-size 30 or greater. The second criterion applies

for all student groups that have two or more indicators that have met the n-size 30 or greater. As a result of the above criteria, Alpha Jose's English Learners, Hispanic, Low Income, and Students with Disabilities student groups were identified for ATSI based on their performance on the Chronic Absenteeism, English Language Arts, and Math State Indicators on the CA School Dashboard. As such, we have engaged with our educational partners throughout our LCAP process to ensure our LCAP effectively incorporates the necessary Actions to support our student groups, not only academically, but also to build a strong sense of connection to school for our students in order to decrease chronic absenteeism. The first and second goal of the LCAP will be focused on our student groups who met the criteria for ATSI, with an emphasis on our English Learners and Students with Disabilities. We've also incorporated targeted Actions under Goal 5 to increase our average daily attendance and reduce chronic absenteeism.

At Jose Hernandez, we believe that engagement from all educational partners is key to the successful implementation of our program. Throughout our LCAP development process, we consulted with the following educational partners: administrators, teachers, non-instructional staff members, students, SSC members, ELAC members, and other parents of our students. Please see below for the various ways in which stakeholders have been engaged:

Annual Family Survey – This survey was administered in April and went out to families in multiple languages. The survey included statements for families to provide their input on the school's engagement efforts & their perspectives on student experience. Questions centered on school safety, belonging, efforts to include family voice in school decision making, and satisfaction with instruction and levels of preparedness for their students. In addition to the above focus areas, we also asked families to respond directly to our LCAP Actions giving them an opportunity to provide insight into the direction of our LCAP for SY 23-24.

Annual Student Survey – Student Culture Surveys were administered two times a year. Questions centered on school safety, belonging, student voice, classroom preparation, and teacher evaluation questions. In addition to the above focus areas, we also surveyed students in April asking them to respond directly to our LCAP Actions giving them an opportunity to provide insight into the direction of our LCAP for SY 23-24.

Annual Teammate Survey – This survey was administered to all staff members in April and asked staff members to consider our current LCAP Goals and Actions and gave them an opportunity to provide insight into the direction of our LCAP for SY 23-24.

SSC and ELAC meetings – Our SSC and ELAC met this past year on zoom and in person when applicable, and parents had the opportunity to discuss student growth, successes, and challenges. Parents shared what was and was not working about our program and Actions outlined in the LCAP and what supports their children needed. Our SSC serves as our LCAP Advisory Committee and spends additional meeting time providing LCAP input and reviewing draft and final LCAPs. Below are the dates that we conducted our SSC and ELAC meetings:

Coffee with the Principal — These meetings took place monthly this past year, providing families with the opportunity to give input on the work happening at the school and our LCAP goals for the coming year.

Staff Meetings – Staff meetings took place weekly and staff members consistently analyzed data related to student academic success, attendance, and social-emotional supports and belonging.

Lead Team Meetings—The leadership team met bi-monthly to plan for the leading of professional development for the entire staff, driving decisions around academic and social-emotional supports and needs.

SELPA - Our LCAP was sent to our El Dorado County SELPA for review and comment on June 5

Additionally, the following Actions have been added and or modified as a result of input from our Families (SSC and ELAC included) and Staff:

Given that chronic absenteeism continues to be high for our campus, Action 5.1 will shift the focus from overall attendance to chronic absenteeism with efforts to minimize chronic absence through systems/procedures according to a tiered system of interventions, including data review, supportive conferences, staff/team touchpoints, and school-wide culture.

We've updated Action 1.8 to add a focus on Math support for our students with disabilities based on local and state data as well as staff input.

Action 1.4 has been modified to focus on Academic, Behavior, and Attendance strategies and now reads "Define and identify current Academic, Behavior, attendance strategies within each tier, and educate staff on PBIS/MTSS interventions through third-party resources" Incorporate additional LCAP discussions with families through our Comprehensive Community Programming Scope & Sequence (4.1) to ensure all families are knowledgeable on our LCAP process, goals, and actions to help inform the new LCAP cycle starting in 2024.

We will continue to define and improve the systems of tiered supports, based on our strategic use of a variety of data, that meets the needs of all students. This system will continue to support academic, behavioral, and social-emotional needs, and will continue to be available to all students, regardless of eligibility for special education or other student support services. We will continue to implement and improve the Student Support Team (SST) Meetings for all grade levels. This year we will formalize and teach staff how to clearly define and identify the parameters in which qualify a student for the different levels of interventions based on data gathered. This year we will focus more on supporting all staff members to ensure that they understand the systems and are able to respond appropriately and in a timely manner when needed. All staff members will receive quarterly professional developments on the MTSS umbrella and all systems under that umbrella. All staff members will understand and implement PBIS in order to establish a healthy and positive culture that can help improve social, emotional, behavioral, and academic outcome for all of our students. Staff will effectively use the variety of data gathered to make informed decisions to better support all students and identify when a student needs more targeted support or when supports can be faded out. This system of tiered supports and interventions will be maintained throughout the school year through grade level meetings, professional developments, and coaching meetings.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Overall the actions created for Goal 1 were implemented as planned. The primary difference in our planned actions and actual implementation were as a result of staffing. Similar to districts across the state, we continued to be faced with staffing challenges and were

unable to fully staff our academic intervention team (Action 1.1) and Ed Specialist (1.8). Without a full and robust team, we struggled to fully provide small group supports for our student groups and additional Tier 2 supports.

We successfully maintained a comprehensive home library of academic and behavioral interventions and resources. This library served as a repository of effective strategies and tools that could be accessed and utilized by staff to support student success and address individual needs. Additionally, we continued to provide a wide range of blended programming options accessible to all students, inclusive of 1:1 Chromebooks for all students. These programs were designed to scaffold classroom instruction and offer additional learning opportunities and practice outside of the traditional classroom setting. By offering diverse modalities of learning, the school aimed to cater to various learning styles and promote student engagement and achievement.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between Budgeted Expenditures and Estimated Actual Expenditures

An explanation of how effective the specific actions were in making progress toward the goal.

Our actions for Goal 1 were effective in making progress toward our goal. Our Actions 1.5, 1.6, and 1.7 effectively contributed to the fact that we continued to ensure that 100% of students have access to standards-aligned instructional materials and internet and devices, for use at school and at home. We also saw an increase in our Average Score on the Implementation of State Standards Self- Reflection Tool from a 2.8 out of 4 to a 3.2.

The use of on-site school cards & data story practices has been a bright spot for this year, in support of our MTSS Strategies (Action 1.4). We focused on ensuring Tier 1 instruction was very strong from the start. In the full first quarter & some of the second quarter, we were very focused on this through coaching & partnership with Rethinc on internalization. We saw a minor dip in our end of year STAR reading assessment to 13% meeting their growth targets, however, we did see 39% at or above grade level for our early literacy assessment.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

As a result of our LCAP reflection process and engagement with our education partners, we will be making a few minor modifications to Goal 1 language and Actions

Given where we are in the development of our MTTS framework, we are updating the language to the goal as we are no longer in a creation phase, and will be focusing more on the consistent implementation. The updated goal language will read as follows: We will consistently implement our MTSS framework in order to effectively respond to Academic, Behavior and Attendance needs for all students.

We've updated Action 1.8 to add a focus on Math support for our students with disabilities based on local and state data as well as staff input.

Action 1.4 has been modified to focus on Academic, Behavior, and Attendance strategies and now reads "Define and identify current Academic, Behavior, attendance strategies within each tier, and educate staff on PBIS/MTSS interventions through third-party resources"

At Alpha José Hernández, we understand that regular progress monitoring of student data allows us to see clearly how we can best support all of our students to grow academically and socially. By creating systems and structures to regularly monitor students' academic progress, behavior, and social-emotional needs, we can quickly meet these needs by implementing strong tiered interventions. A clear and consistent system for progress monitoring will allow all of our students to make significant growth that will prepare them for high school and beyond. Despite collecting a variety of high-level academic data, we currently do not have a clear system for identifying high-leverage data, nor for consistently implementing tiered interventions.

This goal will allow us to focus and track our efforts on creating the needed structures and systems for consistent progress monitoring that are embedded into our teachers' regular practices that help to enable the improved outcomes and experiences for students. We will continue our focus on the identification of our systems and structures for ongoing progress monitoring, clear triggers that identify when students should be elevated to receiving additional tiered support, and finally, we will ensure that the analysis becomes part of our teachers' regular practice by providing time and structures for teachers to do this work.

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We have successfully implemented the Actions as planned for the goal of creating and implementing systems for ongoing progress monitoring of student data to drive effective tiered supports, with a particular focus on subgroup performance for English Learners and Students with Disabilities.

To ensure effective progress monitoring, we successfully implemented data analysis tools and techniques throughout the year. This included utilizing data during weekly coaching sessions and bi-weekly leadership data meetings. Teachers had access to structures that helped identify students who may require additional tiered support, which occurred during our 1:1 meetings and occasional grade level meetings. We hope to create a more consistent structure to analyze our student data during grade level meetings next year. This would occasionally happen during the teachers coming together, but not consistently during the department level meetings.

We continued to execute a standardized and intentional assessment structure for all grades. This structure includes the use of the NWEA MAP growth assessment, which helps identify, monitor, and adjust supports and strategies to maximize student growth. We ensured that the assessment process is not overwhelming for students or teachers, avoiding excessive testing that may lead to burnout.

Collaboration with the Alpha network-wide Data Specialist played a significant role in supporting data analysis efforts. The Data Specialist supports school sites with data analysis and data cycles. They lead professional development initiatives to guide staff in facilitating academic and behavior data talks, emphasizing the breakdown of data by significant student groups. This support was essential in identifying tier 2 and 3 intervention supports, working closely with Academic Interventionists.

Overall, the successful implementation of these actions demonstrates the school's commitment to using data effectively to monitor student progress, provide targeted interventions, and ensure that instructional strategies align with the needs of individual students and student

groups. By leveraging data analysis tools, providing structures for data analysis, and collaborating with data specialists, Jose is making strides in maximizing student growth and success.

An explanation of how effective the specific actions were in making progress toward the goal.

With the release of the 2022 CA School Dashboard, our SBAC ELA and Math outcomes are not where we want them to be. Throughout the 22-23 school year, we continued to create dedicated space to analyze student data and leverage tools, such as Educlimber, on-site school cards, and data story practices, in order to effectively progress monitor students and use the data during individual coaching sessions, leadership team meetings, and department meetings. As a result of our dedicated staff and support from the Alpha network data specialist, we saw significant growth in our MAP spring outcomes. In ELA, our students grew 15.5% and in Math, our students grew 19.6%. A full breakdown of our subgroup growth is described below:

ELA NWEA MAP Assessment

- 42.51% of students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 15.51% from the previous year.
- 42.51% of English Learner students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 15.51% from the previous year.
- 44.19% of students with disabilities met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 15.19% from the previous year.
- 41.88% of Hispanic students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 19.88% from the previous year.
- 57.89% of Asian students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 22.89% from the previous year.

Math NWEA MAP Assessment

- 42.61% of students met or exceeded their typical growth goal for spring NWEA MAP assessment in Math, a growth of 19.61% from the previous year.
- 41.79% of English Learner students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 22.79% from the previous year.

- 25.58% of students with disabilities met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 11.58% from the previous year.
- 42.13% of Hispanic students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 23.13% from the previous year.
- 57.89% of Asian students met or exceeded their typical growth goal for spring NWEA MAP assessment in ELA, a growth of 25.89% from the previous year.

While we saw significant growth for all our student groups in meeting their NWEA growth targets, we saw a light decline in the percentage of students in the 65th percentile or higher at 10.24%

With the effective data analysis protocols put into place this school year, progress monitoring, and tiered supports, we are hopeful the spring administration of the SBAC will see significant growth for all our student groups.

After reviewing our data with staff and other education partners, we are making a slight modification to our second goal to ensure we are focusing on our multi-language learners and students with disabilities with an emphasis on tiered support. The updated goal language will read as follows: "We will create and implement systems for ongoing progress monitoring of student data to drive effective tiered supports, with a particular focus on subgroup performance for English Learners and Students with Disabilities."

We saw great success and collaboration with our network-wide Data Specialist role, so the language for Action 2.5 has been modified slightly to read "Continue to collaborate with the Alpha network-wide Data Specialist to support school sites with data analysis and data cycles. This role will lead professional development efforts to guide staff in facilitating academic and behavior data talks/analysis with an emphasis on data broken down by significant student groups. This support will also work closely with Academic Interventionists in identifying tier 2 and 3 intervention supports."

An explanation of why the LEA has developed this goal.

At Alpha José Hernández, we believe that literacy is the foundation of all content and instruction. To that end, all teachers are literacy teachers. We believe that in creating a strong literacy foundation, our students will be able to reach their full academic potential and this will also help support their social-emotional well-being. We want all students to thrive and grow as scholars and as citizens of the world, and we recognize that in order to serve our students effectively, we need literacy objectives present in all subject areas so that teachers can deeply understand our students' literacy needs and strengths. To achieve stronger literacy we will need to deepen our understanding of standards for both literacy and ELD, as well as creating a common understanding of literacy strategies across content areas. Through a collaborative model in which we closely monitor our students' literacy performance and instructional needs, we will also deepen our practices to better serve our students.

Through various local and state data points collected since Alpha José Hernández's founding in 2014, we have recognized the significant gaps that exist in our scholars' literacy knowledge and skills. To address our literacy gaps, respond to stakeholder feedback, and meet the needs of our diverse student body, we created this LCAP goal to dedicate resources, time, and development to our literacy initiatives. This goal and the associated metrics and actions capture how we will measure success in achieving increased literacy outcomes and experiences for our scholars and strengthen our teachers' literacy instruction.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We experienced substantive differences in our planned actions versus the actual implementation during the 22-23 school year. The most significant difference being that we were unable to hire an English Language Development Specialist as outlined in Action 3.3. In the absence of an ELD specialist, the school leader team and network academic teams provided support in focusing on EL compliance and Professional Development. While we did spend the significant amount of time we had hoped during the school year monitoring and addressing instruction, data analysis, and tiered supports, we know this is a place where we will continue to prioritize for the 23-24 school year.

Teachers and staff continued to receive differentiated PD, but the focus was on designated ELD strategies. We were hopeful that we would be able to incorporate integrated ELD PD into our schedule as well, but without an ELD Specialist staffed, the focus remained on designated strategies which we feel that by itself is not enough to improve outcomes for our English Learners as demonstrated by our current data.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between Budgeted Expenditures and Estimated Actual Expenditures

An explanation of how effective the specific actions were in making progress toward the goal.

As a result of staff vacancies in our EL department, we did not make progress toward achieving our desired outcome. Our 21-22 overall Summative ELPAC results saw only 6.98% of EL students meeting proficiency, which was a slight decrease from our results 2020-2021 (8.13%). Our RFEP rates in 21-22 were 6.7% and we saw a slight decrease to 4% in 22-23. We saw a slight decline in our staff survey feedback:

35% Staff perception on the TNTP question regarding academic opportunity

40% Staff perception on the TNTP question regarding leadership: My school has a clear vision that drives goals within the school. Not having a dedicated role focused on our English Learner Development, played a factor in seeing a small decline in our reclassification rates for this school year. We have hired for this role for the 23-24 school year, and are focused on building out or school site professional development for integrated ELD practices along with support from the Alpha network to lead designated ELD professional development as well. We've also updated our ELA curriculum to ensure higher alignment and ratings with common core standards

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

During the 22-23 school year, we will continue with our present Goal and Action Steps as outlined above with the small exception of adding a new ELA curriculum to Action 3.1. We no longer will be using Fountas & Pinnell and will be implementing Core Knowledge Language Arts. As part of purchasing a new curriculum comes the development of a detailed implementation plan that includes timelines, resource allocation, and professional development for teachers and ensuring that all necessary resources, such as textbooks, instructional materials, and technology, are in place before starting the school year. Alpha leadership will provide ongoing professional development for teachers to ensure they have the necessary skills and knowledge to effectively deliver the new curriculum and monitor the implementation process regularly and evaluate its effectiveness. This will include using student performance data and teacher feedback to make necessary adjustments and improvements.

An explanation of why the LEA has developed this goal.

Before our school existed, our families saw a need for school choice and ensuring their children had access to an education that puts them first at all times. This vision and the strong advocacy of our founding families is why we are here in the first place. It is our responsibility to continue to put our families and students first which is where the add-on of this fourth initiative comes in.

Our overall vision for this initiative has two parts: First, we will use a variety of communication tools (Konstella, Newsletters, Social Media pages) and community programming throughout the year to engage all of our families. Within this engagement we will provide all of our families with the information and tools they need to be advocates for their children and community. Second, we will set up systems in order to encourage and support families to play an active role in further growing this engagement by building capacity among other families and their community so that all can act as strong advocates for their children.

Our first goal will be for all staff to prioritize the use of Konstella for family communication and to have 100% of our families signed up on Konstella and participating by the end of the fourth week of school. We will meet this goal by providing all staff with training and support in becoming well versed in Konstella. Our team will then prioritize having times for families to sign up to Konstella and practice with using the different features of the application during all beginning of the year community programming. During this time, we will ask all families to complete specific actions via Konstella (i.e. chat their homeroom teacher, complete a sign up) and teachers will track completion in order to determine next steps in family support. Meeting this goal will ensure that we have a quick way to share updates, surveys, sign ups and any necessary school information with all of our families throughout the year.

Our second goal will be to create a community programming scope and sequence for the school that is accessible to all families. This scope and sequence will be accessible via the Konstella calendar and in physical copy on campus so that families have reminders of upcoming programming. Our committee will work with the operations team and family leaders to update this scope and sequence monthly. Within this scope and sequence, we will have the third goal of holding at least one community programming event per quarter.

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

The Actions outlined in Goal 4 have been successfully implemented to make progress toward our goal of increasing engagement for all of our families. Firstly, a community programming scope and sequence for the school year was created and updated monthly. This information was shared with the community through Konstella, an online platform, as well as physical copies posted on campus. To foster community engagement, we held at least one community programming event per quarter, separate from regularly scheduled meetings such as SSC, ELAC, or Cafecito. These events provided opportunities for families to come together and participate in school activities.

To improve family communication, we have prioritized the use of Konstella. We have achieved a high level of participation by ensuring that 100% of AJH families are signed up on Konstella by the third week of school and actively participating by the end of the fourth week.

Jose is actively evolving Cafecito into a family member-led model, empowering families to take ownership and lead these sessions. This approach encourages greater involvement and participation from the parent community. To support families, we maintain services from the Alpha Parent Learning Center and Parent Learning Center Lead. These resources provide educational support and connect families to various resources.

We continue to conduct parent leadership training meetings to empower families and equip them with the skills to advocate for their students. Collaborating with the Senior Director of ACE, the school formed partnerships with external parties to bring additional services and resources to students and families. The parent learning center plays a role in this process by providing training and support to develop parents' advocacy and leadership skills. We also successfully maintained a parent engagement coordinator who played a crucial role in improving overall family engagement. This position supports family meetings, volunteer opportunities, and ensures clear communication within the school community and other stakeholders.

There were no material differences between Budgeted Expenditures and Estimated Actual Expenditures

An explanation of how effective the specific actions were in making progress toward the goal.

Our Actions, as implemented during the SY 22-23, were effective in making progress toward our goal. We have seen more families in school this year thanks to quarterly conferences, monthly SSC and ELAC meetings, in-person cafecitos, additional award ceremonies, and volunteer opportunities for families to chaperone field trips and support at school. This is reflected in our family survey response of families who felt welcomed and heard by the school and their overall sense of belonging:

- 96% agreed that The school staff listen to parents when they have questions, concerns, or ideas and
- 94% agreed that The school listens to family voice and input when making decisions.
- 95% of families feel a sense of belonging and connectedness to the school community.
- 94% of Families who feel the school does a good job of family engagement

Still, we feel that we will renew our focus around how to help our families participate, volunteer, and be on campus in formal and informal ways through the school year. Through our SSC as well as other feedback we receive, families are asking for ways to support staff and teachers on campus more frequently. This is exciting and a good focus for us to pursue as we transition to 23-24.

While we are satisfied with our progress here, we would like to improve on the number of regular parent volunteers and overall campus presence opportunities for our families now that our office is back to normal. We will continue to leverage our Senior Director of Advocacy and Community Engagement to bring additional services and resources to students and families.

We will continue with the current goal, metrics, desired outcomes and actions based on family input and our outcomes that we've seen. In particular, we will continue to educate Jose parents as to Parent Learning Center supports available, enroll new families and any families not yet enrolled in Konstella, and expand community events, volunteer opportunities on campus, and strengthen our ELAC and Cafecito.

JH is committed to fostering an environment that allows students to develop the leadership skills they will need to bring positivity and change to their communities. Our ability to foster this environment is dependent on creating classrooms where students feel safe, motivated, and challenged. Analysis of student attendance, engagement, suspension, and survey data show that students are engaged (96.6% attendance/engagement rate), and scored a 3.3 average (out of 4) on the student culture survey.

Based in stakeholder input through the LCAP / Initiative setting process, we hope to continue/maintain the positive and joyful school culture that we have been building, through supports such as the work of our Dean of Students, PD for teachers, and a focus on student leadership.

We have successfully implemented the majority of the actions outlined in Goal 5 to make progress toward our goal of creating a welcoming learning environment where students will feel safe, motivated, and challenged.

To address attendance and minimize chronic absence, we have established systems and procedures based on a tiered intervention approach. This included regular data review to identify patterns and intervene as necessary, conducting supportive conferences with students and their families, providing staff and team touchpoints for collaboration and support, and fostering a school-wide culture that emphasizes the importance of attendance.

To track student behavior and culture data effectively, we utilized systems like the Dean's List to monitor student behavior trends. This data supports analysis, problem-solving for effective strategies, and communication with families to address any concerns. To ensure access to student and family mental health counseling through the availability of school-based counselors and external providers, such as FACTR. Recognizing the importance of non-academic student experiences, we increased resources dedicated to enhancing these experiences, such as student events and field trips. To improve operational efficiency, we developed a specific scope and sequence of professional development for the operations team, continued quarterly walkthroughs for performance evaluation, and further documented systems through an operations playbook.

To support the implementation of multi-tiered intervention strategies, we successfully maintained our Dean of Students who works directly with students and supports teachers and staff in equipping them with strategies to create a safe, motivated, and challenging learning environment.

Lastly, the school rolled out the use of shared project management software to manage the operations compliance calendar. This software enables efficient organization, planning, and tracking of tasks related to operational compliance.

While the majority of these actions were implemented as planned, we did not continue our partnership with the City Peace Project this year. Instead, much of the work of engaging students through mentorship and social-emotional learning was supported internally by our counselors and school team, through structures such as advisory.

There were no material differences between Budgeted Expenditures and Estimated Actual Expenditures

An explanation of how effective the specific actions were in making progress toward the goal.

Our Actions, as implemented during the SY 22-23, were mostly effective in making progress toward our goal. Chronic absenteeism continues to be high for our school site and larger community. Alpha Jose's chronic absenteeism is a Very High Status on the CA School Dashboard at 36.2%. We found that our actions listed were necessary, but we see the need for a renewed focus for a more tiered approach to attendance. In particular, focusing on more high quality strategies for our "tier 3" students - a higher degree of home visits, one on one mentoring, and stronger connections/relationships with the student and their family to find solutions to attend school more consistently.

The work we are doing with FACTR (Action 5.3) and Deanslist (Action 5.2) has led to positive outcomes with our suspension rates (4.38%) and attendance rates (89.5%).

We continued to set operations performance goals for the year, monitor a monthly compliance calendar, and performed operations walkthroughs that covered a range of school, finance, facilities, and data management procedures.

Evidence of our success around operations is from our family survey, which showed 85% of Families who agree that the school's facilities are clean and welcoming. Evidence of our success also shows in our staff operations survey, which shows, out of a scale of 5, overall operations effectiveness at 4.42.

Our actions were effective this year in helping the operations and facilities of our school stay at our high standard. This was evidenced in our strong score on our Facility Inspection Tool (FIT) scores as reported on the SARC, and our families survey response on how clean and welcoming our facilities are (88%).

In addition, we took some significant steps forward around having a stronger and more consistent professional development scope and sequence for our front office / operations teams; which led to aligned goals and responses around a range of operations related functions: data management, facilities repair management, and strong operations (attendance, food service) systems

We will continue with our current goal, and most metrics, desired outcomes and actions. While we feel good about our operations and facilities work, we will work to improve the schools operations team performance through developing ops team specific scope and sequence of professional development, continuation of quarterly walkthroughs, and the further codification/documentation of systems through the operations playbook (Action 5.6).

We continue to not partner with the City Peace Project (Previously Action 5.5), so this action will remain as discontinued. Given that chronic absenteeism continues to be high for our campus, Action 5.1 will shift the focus from overall attendance to chronic absenteeism with efforts to minimize chronic absence through systems/procedures according to a tiered system of interventions, including data review, supportive conferences, staff/team touchpoints, and school-wide culture.

More than ever, it is clear to us through our data that having fully credentialed, experienced, and talented teachers is a key enabler in our student success. Those teachers who have been with us the longest have shown to have higher success, both academically and in building strong, lasting relationships with students. This highlights the importance of investing greatly in ensuring the teachers we hire are highly and appropriately qualitifed, that there are many structures in place for development, and that our structures and compensation systems reflect this value to retain high quality teachers and staff.

All of stakeholder groups, through the LCAP / initiative setting process, have highlighted the importance of hiring, developing, and retaining high quality faculty and staff as a key enabler in our success in achieving all of our other goals.

The Actions outlined in Goal 6 were implemented as planned. To ensure a diverse and qualified teaching staff, Jose and the Alpha network have employed various strategies. These included establishing a network-based teacher recruitment team, partnering with Alder Graduate School to run an Alpha-specific Teacher Residency program, and involving family, staff, and students in the interview and hiring process for key roles. These efforts help attract and select talented educators who reflect the diverse needs of the school community.

The school has implemented a transparent teacher salary scale, with differentiated pay based on certification status. This incentivizes teachers to obtain appropriate credentials and recognizes their expertise and qualifications. We continued to provide teacher certification and credentialing support, with a bi-annual review of assignments and credential status. This ensures that teachers have the necessary support and resources to maintain their certifications and credentials, thereby enhancing their professional growth and effectiveness. Teachers were provided with leadership opportunities, such as mentoring teacher residents and assuming additional responsibilities as department or teacher leads. This allows experienced teachers to share their expertise and contribute to the growth and development of their peers.

In addition to internal professional development, teachers had the flexibility to choose external professional development opportunities aligned with their development goals. We implemented additional teacher salary and benefit compensation packages, including additional mental health and wellness days. Regular evaluations of the teacher salary scale and other compensation opportunities were conducted to ensure fair compensation compared to similar opportunities.

To support teacher retention, Alpha aligned on a shared vision of leadership development, offering pathways for effective teachers and leaders to advance their careers within the organization. The focus is on elevating staff voices, enhancing sustainability, and creating a positive work environment. The strategies identified by TNTP (The New Teacher Project) for effective teacher retention were also implemented.

Lastly, teachers were developed through various means, including 1:1 coachings, professional development sessions, walkthroughs, and grade level/department meetings. These development opportunities focused on prioritized indicators from teacher and coach rubrics, enabling teachers to enhance their instructional practices and professional growth.

There were no material differences between Budgeted Expenditures and Estimated Actual Expenditures

Our actions were effective in supporting our goal, though ensuring strong hiring and retention of teachers was increasingly challenging this past year as a reflection of the overall teacher talent environment. We continued to put heavy resources (time and money) into teacher development, including utilizing external PD providers, continuing 1:1 coaching, and establishing a more complete and updated teacher rubric. 100% of teachers who receive regular, weekly CCSS-aligned professional development, including ELD PD.

We also continued to invest heavily in various strategies around hiring diverse and highly qualified teaching staff, including offering tuition reimbursement, credentialing support, and robust talent sourcing strategies. This was evident in our data as 92% of core teachers had an appropriate credential or permit to teach.

We also increased our teacher salary scale mid-year, as well as researched and ran focus groups around benefit and overall compensation-related improvements. Based on the feedback and research we did, we will be implementing a number of benefit improvements such as higher employer-paid coverage for families, additional dental/orthodontic benefits, and childcare discounts.

We see that this has maintained our teacher/staff retention for next year above 60% at 62%

As part of our engagement process with staff and families, we have modified Action 6.6 to to focus on a specific deep dive into sustainable work schedules for teachers. Next year will be year 2 of Action 6.7, so we will modify the language to Continue to develop teachers (through 1:1 coachings, PD sessions, walkthroughs, grade level/department meetings) around prioritized indicators from the teacher & coach rubrics.

For each action being provided to an entire school, or across the entire school district or county office of education (COE), an explanation of (1) how the needs of foster youth, English learners, and low-income students were considered first, and (2) how these actions are effective in meeting the goals for these students.

Unduplicated funds will be principally directed to low-income and English Learners, the majority of our student body. The student body is 97% unduplicated students, therefore the needs of English learners and low-income students comprise the needs of the majority of our students and represent the focus of our actions. The funds will be effective in increasing and improving the level of academic support, interventions, professional development, enrichment, SEL supports, as outlined below in our Actions that are being funded with supplemental and concentration funds.

When reviewing our data, and based on input and feedback from our teachers, staff, and students, we identified that through an instructional lens, the performance of our low-income students and our English Learners lags behind that of our overall population. In order to address this growth area related to our support of low-income students and english learners, we have chosen to primarily focus on a number of actions and strategies around building aspects of our MTSS framework and literacy supports (ELA and English Language Development), that we believe will be especially effective for our unduplicated student population. The actions and strategies are:

Action 1.1: Hiring Academic Interventionists to support instruction in the classroom, and provide targeted support to small groups of students and one to one support, including executing on ELA intervention strategies during the REACH block. These are additional FTE relative to previous years in order to support the execution of our MTSS framework, and their work with low income and english learners will be

prioritized. In addition, the amount of time spent in direct support and the strategies used that will be targeted towards individual students, will improve and increase services.

Action 1.2: Hiring an Associate Teacher to provide additional classroom support, as well as work with small groups of students to support tier 2 strategies. Similarly to the academic interventionists, the associate teacher will target their work primarily to our unduplicated students, an similarly support tier 2 interventions.

Action 3.3: School will continue to staff an English Language Development specialist to provide designated instruction and teacher support for integrated ELD. This strategy will support our English Learners through direct support and through the work that the ELD specialist does through PD and coaching of teachers.

- Action 1.5: Creating home library of academic and behavioral interventions and resources. This will supplement classroom/in-person learning and will be targeted as tier 2/3 supports for specified students. The wider range of home resources we provide will significantly impact our low income and english learner subgroups, and will improve the access these students have to additional supports.
- Action 2.2: Structures for identifying when students should be elevated to receiving additional tiered support and ensure that all teachers can identify them. The focus on building out our MTSS framework will improve our services to our unduplicated students, through the identification and implementation of interventions for these student groups.
- Action 1.4: Define and identify current PBIS/MTSS strategies within each tier, and educate staff on PBIS/MTSS interventions
 through third-party resources. Similar to the above, many of the interventions identified through our MTSS framework will focus
 support on low income and english learner students.
- Action 6.4: In addition to internal Professional Development, Teachers have the resources to choose external Professional
 development according their own development goals, which is largely targeted towards ELD and MTSS tier 2 intervention supports.
- Action 5.7: School will staff Dean of Students to support the implementation of our multi-tiered intervention strategies. The Dean of
 Students will work directly with students, and will also support teachers and other staff to equip them with strategies that will help
 students feel safe, motivated, and challenged in classrooms and around campus. This action will increase both the capacity/FTE
 directed towards this work, and also more efficiently direct the time and strategies used by these roles within the context of an
 MTSS framework (team, shared interventions, action plan). Our low income students will be a primary focus given the data that
 shows higher suspension and referral rates.
- Action 2.4: Continue to execute on a standardized and intentional assessment structure for all grades, which will help us identify,
 monitor, and adjust supports/strategies to maximize student growth, including NWEA MAP growth assessment; while not inducing
 burnout by over-assessing.

These actions and strategies above are provided on a school-wide basis, and we expect that our more effective MTSS framework and related strategies will benefit all students at our school. Still, based on the data and our stakeholder input, we know these strategies will be more significantly directed towards and will impact our low income and english learner students.

Each of these actions and strategies will provide additional human resources that will enhance our MTSS and overall student culture

strategies by providing direct support to students, PD support for teachers, as well as culture data analysis (culture surveys, attendance, referrals) that will more quickly identify trends, needed interventions, and action plans based on these data. These actions and strategies will be provided on a school-wide basis, and we expect that this will benefit all students at our school, with a more significant impact on our low-income students.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

As share above, we have identified actions and strategies that address our primary goals around enhancing our MTSS framework, ELA/ELD programming, and positive student culture. These actions and strategies were developed with our low-income and english learner students in mind, as they are meant to increase and/or improve services towards these groups. Below is a description of how we will do so:

- Academic Interventionists to support instruction in the classroom, and provide targeted support to small groups of students and one
 to one support, including executing on ELA intervention strategies during the REACH block. These are additional FTE relative to
 previous years in order to support the execution of our MTSS framework, and their work with low income and english learners will
 be prioritized. In addition, the amount of time spent in direct support and the strategies used that will be targeted towards individual
 students, will improve and increase services.
- Associate Teacher to provide additional classroom support, as well as work with small groups of students to support tier 2 strategies.
 Similarly to the academic interventionists, the associate teacher will target their work primarily to our unduplicated students, an similarly support tier 2 interventions.
- School will continue to staff an English Language Development specialist to provide designated instruction and teacher support for integrated ELD. This strategy will support our English Learners through direct support and through the work that the ELD specialist does through PD and coaching of teachers.
- Creating home library of academic and behavioral interventions and resources. This will supplement classroom/in-person learning and will be targeted as tier 2/3 supports for specified students. The wider range of home resources we provide will significantly impact our low income and english learner subgroups, and will improve the access these students have to additional supports.
- Structures for identifying when students should be elevated to receiving additional tiered support and ensure that all teachers can identify them. The focus on building out our MTSS framework will improve our services to our unduplicated students, through the identification and implementation of interventions for these student groups.
- Define and identify current PBIS/MTSS strategies within each tier, and educate staff on PBIS/MTSS interventions through third-party resources. Similar to the above, many of the interventions identified through our MTSS framework will focus support on low income and english learner students.
- Teachers and staff will attend and engage in differentiated PD each Wednesday, which may include lesson support, curriculum support, cross-grade collaboration time, as well as a focus on implementing ELD strategies. This focus on ELD strategies is meant to support building instructional skills for all of our teachers to support english learners and those RFEP who have transitioned recently. This is an added focus relative to previous years. In addition to internal Professional Development, Teachers have the

- resources to choose external Professional development according their own development goals, which is largely targeted towards ELD and MTSS tier 2 intervention supports.
- School will hire and train a Dean of Students to support the implementation of our multi-tiered intervention strategies. The Dean of Students will work directly with students, and will also support teachers and other staff to equip them with strategies that will help students feel safe, motivated, and challenged in classrooms and around campus. This action will increase both the capacity/FTE directed towards this work, and also more efficiently direct the time and strategies used by these roles within the context of an MTSS framework (team, shared interventions, action plan). Our low income students will be a primary focus given the data that shows higher suspension and referral rates.

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

As named above, the school was able to leverage increases associated with additional concentration grant funding to support its LCAP priorities:

Goal 1: We are committed to creating and implementing systems that include advanced tier interventions that are available for all students, regardless of eligibility for special education or other student support services.

Goal 2: We will create systems and structures for ongoing progress monitoring of student data that is collected and discussed in collaboration for stronger tiered supports.

Goal 3: We will focus on improving training, coaching, and supporting all teachers to know how to better differentiate instruction based on their students' literacy performance and instructional needs.

Goal 4: We will use a variety of means to increasingly engage all of our families by consistently providing them with the information and tools they need to be advocates. Our families will play an active role in further growing this engagement by building capacity among other families and their community so that all can act as strong advocates for their children.

Goal 5: Create a welcoming learning environment where students will feel safe, motivated, and challenged.

Goal 6: Hire, develop, sustain, and value a high quality faculty & staff.

With the additional concentration funding projected to be approximately \$179,084, we were able to fund additional positions for instructional support that focus on providing tiered support and intervention for our unduplicated populations.

Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- Comprehensive Strategic Planning: The process of developing and annually updating the LCAP supports comprehensive strategic planning (California Education Code [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. LEAs should continually evaluate the hard choices they make about the use of limited resources to meet student and community needs to ensure opportunities and outcomes are improved for all students.
- Meaningful Engagement of Educational Partners: The LCAP development process should result in an LCAP that reflects decisions made through meaningful engagement (EC Section 52064[e][1]). Local educational partners possess valuable perspectives and insights about an LEA's programs and services. Effective strategic planning will incorporate these perspectives and insights in order to identify potential goals and actions to be included in the LCAP.
- Accountability and Compliance: The LCAP serves an important accountability function because aspects of the LCAP template require LEAs to show that they have complied with various requirements specified in the LCFF statutes and regulations, most notably:
 - o Demonstrating that LEAs are increasing or improving services for foster youth, English learners, and low-income students in proportion to the amount of additional funding those students generate under LCFF (*EC* Section 52064[b][4-6]).
 - Establishing goals, supported by actions and related expenditures, that address the statutory priority areas and statutory metrics (EC sections 52064[b][1] and [2]).

• Annually reviewing and updating the LCAP to reflect progress toward the goals (EC Section 52064[b][7]).

The LCAP template, like each LEA's final adopted LCAP, is a document, not a process. LEAs must use the template to memorialize the outcome of their LCAP development process, which should: (a) reflect comprehensive strategic planning (b) through meaningful engagement with educational partners that (c) meets legal requirements, as reflected in the final adopted LCAP. The sections included within the LCAP template do not and cannot reflect the full development process, just as the LCAP template itself is not intended as a tool for engaging educational partners.

If a county superintendent of schools has jurisdiction over a single school district, the county board of education and the governing board of the school district may adopt and file for review and approval a single LCAP consistent with the requirements in *EC* sections 52060, 52062, 52066, 52068, and 52070. The LCAP must clearly articulate to which entity's budget (school district or county superintendent of schools) all budgeted and actual expenditures are aligned.

The revised LCAP template for the 2021–22, 2022–23, and 2023–24 school years reflects statutory changes made through Assembly Bill 1840 (Committee on Budget), Chapter 243, Statutes of 2018. These statutory changes enhance transparency regarding expenditures on actions included in the LCAP, including actions that contribute to meeting the requirement to increase or improve services for foster youth, English learners, and low-income students, and to streamline the information presented within the LCAP to make adopted LCAPs more accessible for educational partners and the public.

At its most basic, the adopted LCAP should attempt to distill not just what the LEA is doing for students in transitional kindergarten through grade twelve (TK–12), but also allow educational partners to understand why, and whether those strategies are leading to improved opportunities and outcomes for students. LEAs are strongly encouraged to use language and a level of detail in their adopted LCAPs intended to be meaningful and accessible for the LEA's diverse educational partners and the broader public.

After assessing the needs, conditions, and circumstances of our low-income students, we learned that the attendance rate of our low-income students is 7 percent lower than the attendance rate for all students. (Needs, Conditions, Circumstances [Principally Directed])

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action[s])

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
