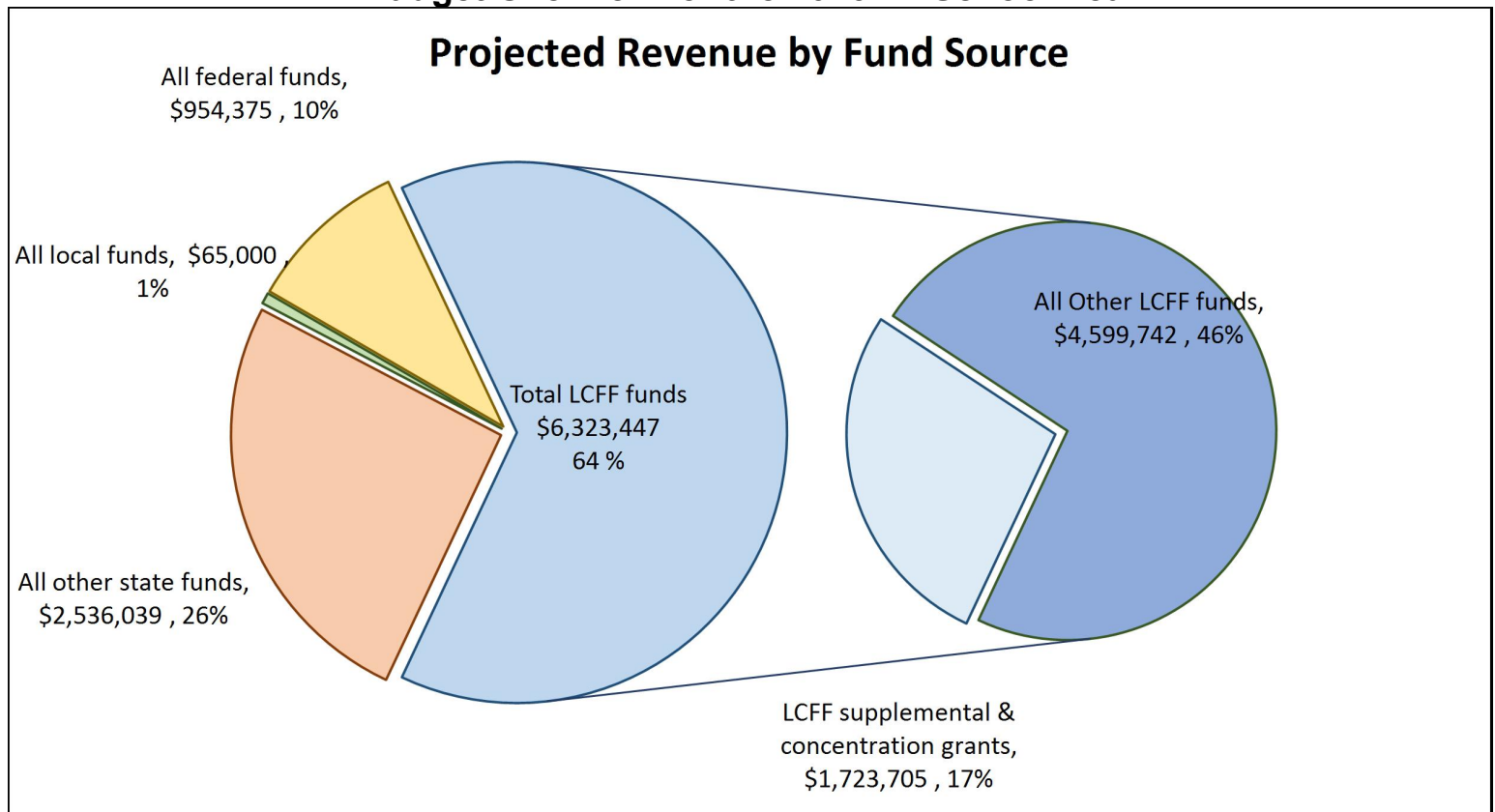

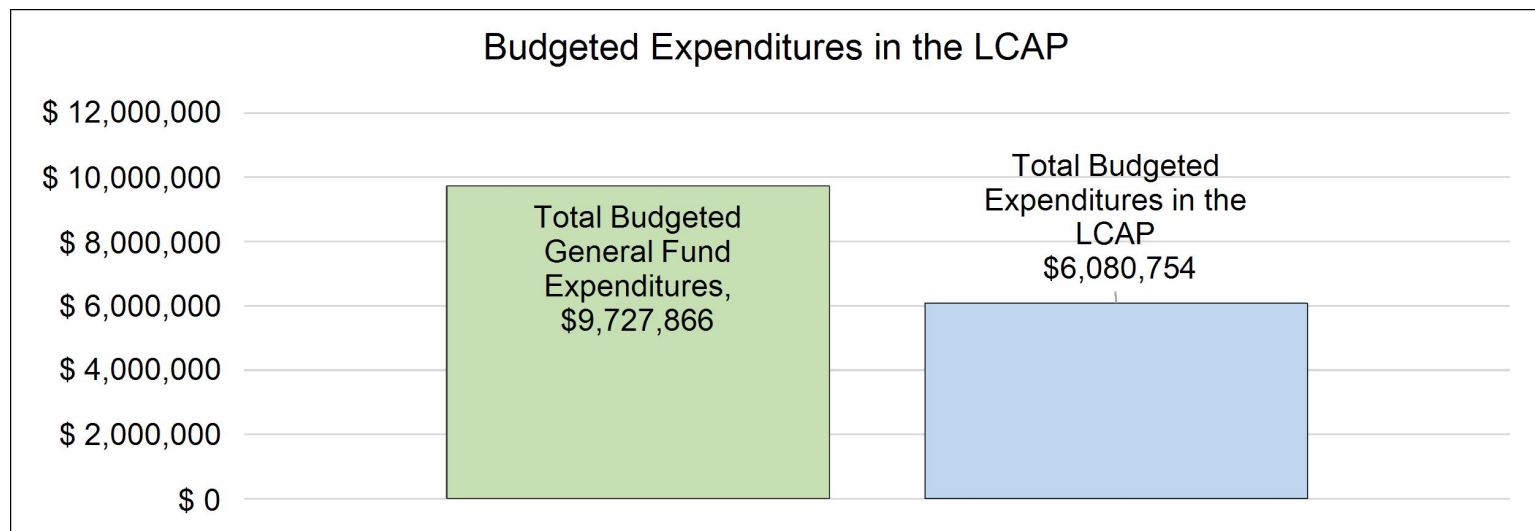


This chart shows the total general purpose revenue Alpha: José Hernández School expects to receive in the coming year from all sources.

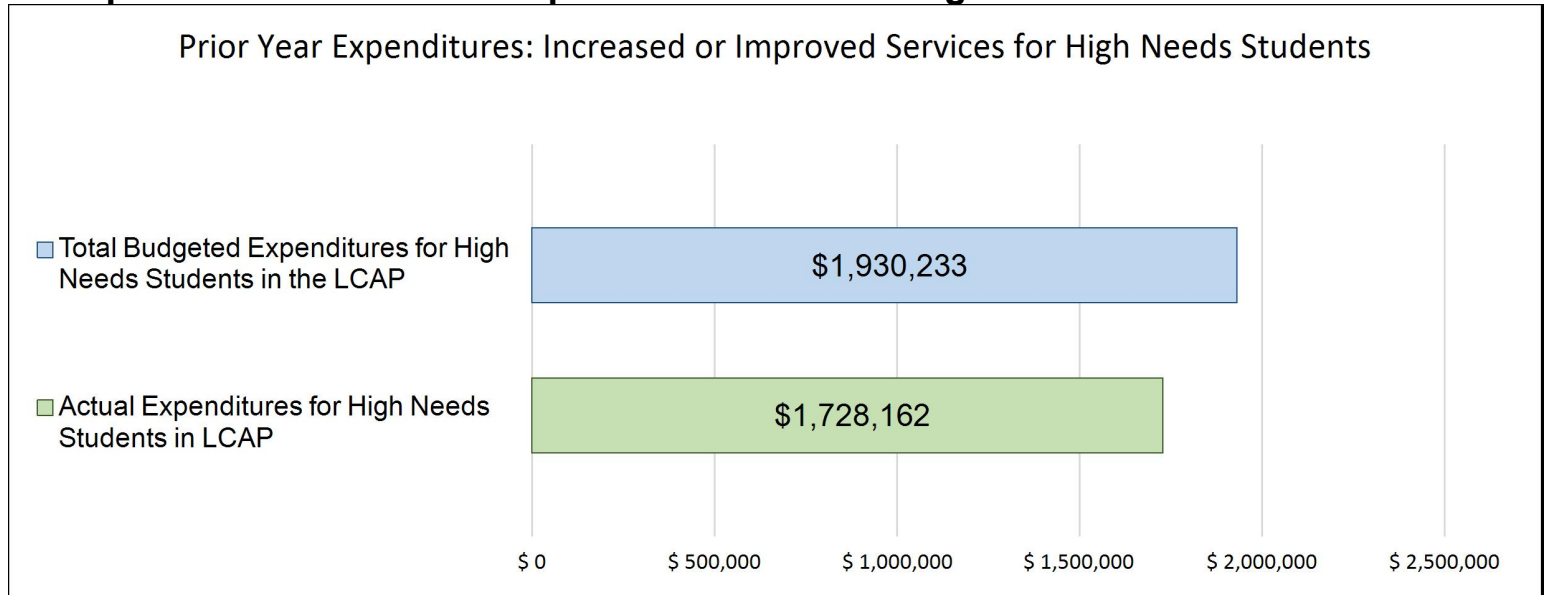

Plan Summary [2026-27]

General Information

Alpha: José Hernández School (AJH) is part of the Alpha Public Schools network, whose mission is: We believe that all children have a fundamental right to an excellent education. Alpha Public Schools will ensure that all of our scholars develop the academic skills and leadership habits required to succeed in college and live with integrity.

Led by principal Julianna Parra and staffed by a talented and energetic staff, AJH is a safe and tuition-free community school serving students in grades TK-8. The school is co-located with Alpha: Blanca Alvarado School and is authorized by the Santa Clara County Office of Education. AJH develops students into lifelong learners who will enter high school with the academic skills, strength of character, and passion for learning to succeed in and graduate from college.

In the 25-26 SY, AJH served approximately 439 students, 95.2% of which are socioeconomically disadvantaged. The school’s demographic profile was 95.7% Hispanic or Latino, 1.7% Filipino, and less than 1% White, Black, Asian, Pacific Islander, and Two or More Races. The school serves a student body that is 64.7% English Learner and 15% Students with Disabilities (Source: 25-26 Dataquest).

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

As we reflect on our annual performance using the California School Dashboard and local data, we recognize both areas of progress and areas requiring continued focus at Alpha: José Hernández (AJH). Notably, the 2025 Dashboard reflects that our school has exited Comprehensive Support and Improvement (CSI) status after two years of identification, demonstrating meaningful progress in key areas and the impact of targeted supports and interventions. The Dashboard results also show continued improvement in English Learner progress, Math, ELA, and student culture. At the same time, academic proficiency and subgroup performance, in particular for Long-Term English Learners, on school climate indicators remain areas requiring ongoing attention for our school.

- **Growth in English Learner Progress:** The English Learner Progress Indicator increased by 13.9%, with 47.0% of English Learners making progress toward English language proficiency, resulting in a Green performance level. AJH outperformed the State, where 46.4% of students made progress. In addition, 55.6% of AJH Long-Term English Learners (LTELs) made progress, compared to 49.1% of LTELs across the State. This growth reflects the impact of designated and integrated English Language Development support for AJH's significant population of English Learners.
- **Improvement in English Language Arts:** All Student results in ELA improved 10.5 points to 98.8 points below standard, resulting in an Orange performance level. Several student groups also demonstrated strong improvement, including English Learners increasing 9.7 points, Hispanic students increasing 10.9 points, and Students with Disabilities increasing 15.1 points, indicating strong positive progress towards improving student outcomes in ELA.
- **Improvement in Mathematics Performance:** All Student results in Mathematics improved 7.3 points to 120.0 points below standard, resulting in an Orange performance level. Student groups also demonstrated improvement, including Hispanic students increasing 7.8 points, English Learners increasing 5.9 points, and Students with Disabilities increasing 13.1 points, suggesting that AJH's instructional strategies are resulting in improvements in Math achievement.
- **Declining Chronic Absenteeism:** Chronic Absenteeism for All Students improved by 5.2 points, declining to 30.5% and receiving a Yellow performance level. Student groups also demonstrated improvement, including Students with Disabilities results improving by 10.5 points to 30.4%, English Learners improving by 4.3 points to 29.6%, Hispanic students improving by 5.5 points to 30.8%, and Socioeconomically Disadvantaged students improving by 4.8 points to 30.8%. This improvement reflects AJH's continued focus on fostering a healthy and thriving school environment for students.
- **Declining Suspension Rate:** The Suspension Rate for All Students improved by 1.2 points to 4.2%, resulting in a Yellow performance level. Student groups also demonstrated improvement, with results for Hispanic students improving by 1.5 points to 4.1% and Socioeconomically Disadvantaged students improving by 0.9 points to 4.5%, reflecting AJH's work in restorative justice practices, social-emotional learning, and building a positive student culture.

We are encouraged by the across the board improvement reflected in our 2025 CA School Dashboard results. We have also identified key areas of continued focus as we work to improve outcomes for all students and close achievement gaps among student groups.

- **Academic Achievement Gaps:** Despite improvement, ELA remains 98.8 points below standard and Mathematics remains 120.0 points below standard. In ELA, Students with Disabilities are 164.2 points below standard (Red), Long-Term English Learners are 148.2 points below standard (Orange), and English Learners are 119.6 points below standard (Orange). In Mathematics, Long-Term English Learners are 183.7 points below standard (Red) and Students with Disabilities are 179.2 points below standard (Orange). AJH is committed to continuing its work in providing rigorous instruction with access for all students in order to close achievement gaps that exist within our student population.

- Chronic Absenteeism for Long-Term English Learners: While the overall Chronic Absenteeism rate improved by 5.2 points to 30.5%, Long-Term English Learners saw a slight increase (2.2 points) in results to 34.9%. This year, AJH has been focused on providing proactive support to LTEL students when their average daily attendance begins to fall to 90-95%, which has led to projected improvement in LTEL chronic absenteeism rates.
- Suspension Rate for Long-Term English Learners and Students with Disabilities: While the overall Suspension Rate declined to 4.2% (Yellow), Long-Term English Learners saw their rate increase significantly to 26.1% (a 10.0-point increase), which resulted in a Red performance level. Students with Disabilities also received a Red performance level at 9.9%, increasing 2.3 points. AJH has been committed to monitoring and taking early action on student culture data, differentiated by subgroup, and training staff on restorative practices. LTEL and SWD suspension rate results in the 2025-2026 school year are projected to improve as a result of these actions.

Reflections: Technical Assistance

As applicable, a summary of the work underway as part of technical assistance.

Alpha: José Hernández (AJH) was identified for Differentiated Assistance (DA) based on the performance of Long-Term English Learners (LTELs) in the areas of chronic absenteeism and suspension on the 2025 California School Dashboard. While these indicators initially identified the school for DA support, the school and Placer County Office of Education (PCOE) recognized that improving long-term outcomes for LTEL students required a broader and comprehensive systems approach that also addressed academic achievement, language development, instructional quality, and early intervention practices.

Throughout the 2025–26 school year, AJH engaged in an ongoing cycle of collaboration, reflection, classroom observations, and systems analysis with the PCOE Differentiated Assistance team in order to strengthen instructional practices, improve student outcomes, and refine systems of support for LTELs. Meetings and support sessions took place throughout fall 2025 and winter/spring 2026. Early in the process, PCOE and school leadership identified several key areas of opportunity impacting LTEL student outcomes, including implementation inconsistencies of integrated and designated ELD practices, limited teacher clarity around explicit language objectives and academic language development, uneven coaching and monitoring systems, and a need for stronger structures to proactively identify and support students at risk of becoming LTELs. School leadership recognized that while systems and expectations existed, greater consistency in implementation, monitoring, and communication across teams was needed in order to improve outcomes for multilingual learners.

In response to these identified needs, the school began implementing more intentional systems and structures focused on both instructional improvement and student support. Leadership worked to strengthen walkthrough and coaching systems, clarify expectations for high-quality instruction and language development, and expand professional learning focused on integrated and designated ELD practices. The school also began restructuring intervention systems to focus more proactively on grades 3–5 and students identified as at-risk of becoming LTELs through ELPAC analysis, EL Achieve data, and ongoing progress monitoring. As part of this work, AJH developed a comprehensive intervention framework outlining the roles of instructional leaders, ELD specialists, interventionists, coaches, and administrators in monitoring

student progress, supporting teacher practice, and coordinating Tier 1, Tier 2, and Tier 3 interventions for multi-language learners and LTEL students.

The collaboration with PCOE also focused heavily on improving attendance and behavioral systems for LTEL students through more consistent attendance monitoring, family communication systems, student check-ins and attendance celebrations, counseling supports, restorative practices, and data meetings. As a result of these strengthened systems and targeted interventions, the school saw meaningful improvements in LTEL student outcomes during the 2025–26 school year. As of May 26, 2026, LTEL chronic absenteeism decreased significantly from 34% on the 2025 California School Dashboard to 23%, while LTEL suspension rates decreased from 26% to 12.8%. These improvements reflect the school’s growing capacity to build coordinated systems of support, strengthen instructional practices, and respond more proactively to the academic, behavioral, and engagement needs of LTEL students.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

Educational partner feedback gathered through surveys, community engagement, meetings, and data reflection processes played an important role in shaping the development of the 2026–27 LCAP. Overall, educational partners expressed satisfaction with the school’s current goals, actions, and the progress being made toward improving student outcomes, school culture, and family engagement. Feedback from students, families, and staff reflected a strong sense of community and support across the school.

Student and family survey results demonstrated positive perceptions of school climate and engagement. In the spring of the 2025–26 school year, 86.9% of students reported feeling safe at school, while 87.36% of students reported feeling a sense of belonging. Family feedback also reflected strong positive perceptions, with 96.88% of families reporting a sense of belonging within the school community, 93.55% reporting that the school values and uses family voice in decision-making processes, and 93.76% reporting that the school provides a safe environment for students and families.

Across stakeholder groups, educational partners highlighted the school's strong sense of community and supportive culture. Students shared positive feedback about expanded field trips, clubs, sports, and the afterschool program, noting that these opportunities increased engagement and connection to school. Students also expressed appreciation that school leaders actively listen to and respond to student feedback. Teachers provided positive feedback regarding the implementation of the new curriculum, sharing that it feels more integrated, aligned, and supportive of instruction.

While educational partners expressed overall satisfaction with the school's direction, feedback and data analysis also identified key areas for continued growth and refinement within the 2026–27 LCAP. As a result, several updates were incorporated into the adopted plan.

Under Goal 1, the school will sharpen its focus on Long-Term English Learners (LTELs) through Action 1.1, since LTELs continue to represent the greatest area of academic need and remain in the Red performance level on the California School Dashboard in key performance areas. In response, the school is shifting toward a more proactive model of support by focusing on students who are in their fourth or fifth year of English Learner status in order to prevent students from becoming Long-Term English Learners. The ELD Specialist will expand partnerships and instructional support within the 3-5 grade span, where there is an opportunity to provide more early intervention. Co-observations of the designated ELD Block have taken place in Spring 2026 to identify opportunities to strengthen instruction in these spaces for the 26-27 SY. In addition, Supports for Students with Disabilities (Action 1.3) will also remain a priority through the continued implementation of the Center for Learning Inclusion Pathways (CLIP) program, which provides a structured and supportive environment for students with extensive needs while maintaining integration within the broader school community.

Under Goal 2, the school will continue strengthening instructional quality through enhanced observation and coaching cycles focused on weekly lesson planning, lesson internalization, implementation of high-quality instructional materials with fidelity, and adherence to the school's assessment strategy. Action 2.2 (Assessment Strategy) was refined to include the use of DIBELS in the school's assessment strategy for grades K-3 to strengthen early literacy screening, foundational reading data collection three times per year, and progress monitoring practices. Educational partners emphasized the importance of early intervention and more actionable literacy data to support instructional planning and earlier identification of student needs.

Under Goal 3, the school will maintain and continue refining the systems and strategies that have contributed to positive outcomes in reducing chronic absenteeism and suspension rates. Ongoing focus will be placed on monitoring and addressing suspension rates among Long-Term English Learners (Action 3.4). Strong data tracking will allow the school to monitor early warning signals of LTEL students that are at risk for chronic absenteeism and take proactive action to avoid chronic absenteeism.

The rationale for establishing the academic goal focused on our subgroups, particularly in English Language Arts (ELA) and Math, is grounded in our commitment to equity and the urgent need to address the educational disparities exacerbated by the pandemic. The pandemic's impact on education has been profound and uneven. Our subgroups - English Learners, Students with Disabilities, Socio-Economically Disadvantaged students, and Hispanic students - have faced significant challenges that have resulted in disproportionate academic outcomes compared to statewide averages. As a result, on the 2023 CA Dashboard, our subgroups had the following results:

- English Learners: Red in ELA; Orange in Math
- Students with Disabilities: Red in ELA and Math
- Socio-Economically Disadvantaged: Red in ELA and Math
- Hispanic: Red in ELA and Math

Notably, AJH's performance on the English Learner Progress indicator was "Green" on the 2023 dashboard, with performance roughly in line with that of the state. Given our significant population of English Learners, we are proud of these results and are working to maintain and accelerate our progress on this indicator.

Our decision to prioritize this goal is in direct response to feedback from our educational partners, including teachers, staff, and parents, who have consistently emphasized the necessity of improving academic outcomes for these subgroups. The collective insights gathered through the LCAP engagement process highlighted a shared understanding that targeted efforts are needed to ensure all students have equitable opportunities to succeed.

To address these disparities, we are committed to implementing comprehensive strategies that include enhancing our Tier 1 instructional practices to ensure a strong foundation of quality teaching and learning for all students. We recognize the importance of specialized intervention programs that provide additional support to students who are not meeting standards. Our approach includes strengthening English Language Development (ELD) support to better assist English Learners in achieving proficiency in ELA, and enhancing academic and behavioral supports for students with special education needs. These targeted interventions are designed to address the specific learning gaps and challenges faced by these students.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

During the 2025–26 school year, the majority of actions under Goal 1 were implemented as planned, with some strategic adjustments made to better respond to student data, particularly to address the needs of Long-Term English Learners (LTELs) and Students with Disabilities (SWDs). Overall, the school maintained a strong focus on supporting student subgroup growth in English Language Arts and Mathematics through aligned systems of student supports, tiered intervention, and Tier 1 instruction with access.

A key shift in implementation this year was the prioritization of LTEL students in response to prior year Dashboard results. The school refined its English Learner supports (Actions 1.1 and 1.2) by strategically reallocating ELD Specialist capacity to focus more intensively on At-Risk LTEL students in grades 3-5. This shift included embedding a stronger emphasis on essential language development and integrated ELD strategies within grade-level team planning. In addition, the school strengthened monitoring systems in Spring 2026 through co-observations of designated ELD instruction across grade levels, led in partnership with network leadership. These observations focused on ensuring appropriate instructional time, clear routines and procedures, and improved systems for tracking mastery of ELD standards through unit assessments, and key takeaways will be implemented in the 26-27 SY. Collaboration between teachers and the ELD Specialist was also strengthened to support more consistent progress monitoring and instructional alignment.

Support for Students with Disabilities (Action 1.3) continues to be a high priority for AJH. As a result of an increased population of students with high needs, Alpha implemented the Center for Learning and Inclusive Pathways (CLIP) Program, which focuses on serving students with extensive needs by providing them with a structured, supportive, and specialized learning environment. This program has allowed AJH to better serve these students on-site, reducing the need for them to travel to other schools for services. The goal is to create a sense of belonging for all students and integrate them into the school community as much as possible. In addition, the AJH SPED team has implemented the Barton system to strengthen literacy pull out services for students struggling to decode words, as well as partnered with the network SPED team to pilot the Wilson Reading System. These programs demonstrate AJH's commitment to providing all students with access to a high quality education at our school.

Intervention systems (Actions 1.4 and 1.5) were implemented with a continued focus on providing targeted interventions to students based on student data and needs. The school continued to invest in high dosage tutoring programs: Ignite for early literacy, with a focus on grades K-3 and Littera for math, reading, and ELD, with a focus on grades 5-8. Moving forward, the school has made the strategic choice to continue to use Ignite for early literacy support, but will only utilize Littera as a summer tutoring program, instead of during the school year. In addition,

Academic Interventionists continued to provide small group support, with clearer role alignment established during the year. The Dean of Academic Interventions (Action 1.7) has overseen the implementation of high dosage tutoring programs and will take on coaching responsibilities for AIs and the ELD Specialist in the 26-27 SY, creating stronger alignment across the school's intervention systems.

Tier 1 instructional practices (Action 1.6) were implemented with increased strength and consistency. The Alpha Network Team strengthened the teacher observation cycle, which was used to regularly calibrate expectations, provide feedback, and ensure alignment to the school's instructional vision. These structures created more frequent and intentional opportunities for collaboration between site leadership and the network academic team. This reinforced strong messaging and focus on the implementation of adopted instructional materials with fidelity, particularly in the elementary grades.

Overall, implementation of Goal 1 actions was strong and consistent across the school as it works to continue to build systems that support improved outcomes for all student groups. Key successes include the implementation of the CLIP program for AJH students with extensive needs, continued strengthening of our ELD program and monitoring, and the ongoing investment in high dosage tutoring programs to provide targeted, individual support to students.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The actions implemented under Goal 1 have been largely effective in driving improved outcomes for student groups in English Language Arts (ELA), Mathematics, and English Learner Progress, as evidenced by 2025 California School Dashboard results. Most notably, the school demonstrated significant progress in English Learner Progress Indicator (ELPI), increasing to Green with 47.0% of English Learners making progress (+13.9%), reflecting strong growth and movement out of prior lower performance levels. In addition, 55.6% of Long-Term English Learners made progress on the English Learner Progress Indicator, outperforming the State of California results (49.1%). This improvement highlights the effectiveness of English Learner supports (Actions 1.1 and 1.2), including the focused work of the ELD Specialist, strengthened designated and integrated ELD practices, and increased monitoring of language development through co-observations and data tracking systems.

In ELA and Mathematics, nearly all student groups demonstrated growth in Distance From Standard, indicating that the intervention strategies, high dosage tutoring programs, and focus on strong Tier 1 instruction (Actions 1.3 - 1.6) are supporting improved student outcomes. In ELA, student groups including English Learners (9.7 point increase), Hispanic students (10.9 point increase), Socioeconomically Disadvantaged students (5.7 point increase), and Students with Disabilities (15.1 point increase) all showed meaningful gains and moved out of the Red performance level. Similarly, in Mathematics, these same student groups demonstrated improvement, including English Learners (+5.9 points), Hispanic students (+7.8 points), Socioeconomically Disadvantaged students (+4.4 points), and Students with Disabilities (+13.1 points). These gains reflect the effectiveness of targeted small group intervention and high dosage tutoring

programs (Actions 1.4 and 1.5), strengthened Tier 1 instructional practices (Action 1.6), and increased alignment between general education and specialized supports (Action 1.3).

A particularly notable success is the continued progress of Students with Disabilities, who demonstrated strong gains in both ELA and Math and are no longer in the Red performance level in either subject, marking the first time in multiple years this subgroup has exited Red status for ELA. This progress underscores the impact of strengthened inclusion supports, targeted intervention, and improved collaboration between general education and special education staff (Action 1.3). In addition, the introduction of the Center for Inclusive Learning Pathways (CLIP) program has enabled AJH to provide students with extensive needs a specialized learning environment that best supports them.

While overall subgroup trends are positive, Long-Term English Learners (LTELs) remain an area of need. LTELs remained in the Red performance level in both ELA (121.1 points below standard, minimal growth) and Mathematics (188.5 points below standard, decline of 11.1 points), indicating that current strategies have not yet fully accelerated outcomes for this group. In response, the school has focused on strengthening targeted LTEL strategies, including increased focus on language development in upper grades and earlier intervention for At-Risk LTEL students.

Overall, the data indicate that the majority of Goal 1 actions have been effective in improving outcomes for key student groups, particularly English Learners and Students with Disabilities. Continued focus on LTEL-specific strategies will be critical to ensuring that all student groups experience similar levels of growth moving forward.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Following a year of positive growth across English Language Arts and Mathematics for multiple student groups, as well as achieving a Green performance level on the English Learner Progress Indicator (ELPI), the school will maintain the overall Goal 1 focus, metrics, target outcomes, and actions for the coming year. The majority of student groups moved out of the Red performance level in both ELA and Math, indicating that current strategies are effectively supporting improved student outcomes and that the school is moving in the right direction. The school will continue to build on the progress made through its partnership with Placer County as part of Differentiated Assistance, which has supported stronger systems for data analysis, targeted instruction, and intervention for subgroups.

The only refinement for the upcoming year is a targeted update to Action 1.4, which will be renamed “Academic Intervention Model”. The updated action adds coaching, professional learning, and data-driven cycles of inquiry to improve the delivery of tiered interventions and inform targeted intervention plans across grade levels.

While the overall goal and actions will remain consistent, with the small adjustment named above, the school will sharpen its focus on Long-Term English Learners (LTELs), who continue to represent the greatest area of need and remain in the Red performance level. This includes strengthening targeted supports, differentiated instruction, and progress monitoring to better address the needs of this subgroup. This focus reflects a commitment to sustaining successful practices while intensifying efforts in key areas of need to ensure continued growth for all student groups.

Our 2023 CA School Dashboard ELA and Math outcomes for all students highlight the need to create this goal. In ELA, our overall performance was Red, and 93.3 pts below standard. In Math, our overall performance was Orange, and 125 pts below standard.

By focusing on strong instructional practices, we are committed to delivering a rigorous, standards-aligned curriculum. Our assessment and data strategy will give us a structured process to gather meaningful data about student learning, which informs instructional decision-making and allows for targeted interventions when necessary. This data-driven approach enables us to identify gaps in learning, monitor progress, and adjust our teaching strategies to better meet the needs of each student.

Lastly, offering a broad course of study is fundamental to providing a holistic academic experience that prepares students for future success. This means going beyond the core subjects to include subjects such as the arts, sciences, technology, and other areas of study that foster a well-rounded education. By providing a diverse range of learning opportunities, we not only cater to the varied interests and talents of our students but also help them develop critical thinking, creativity, and other essential skills that are vital in today’s world.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

During the 2025–26 school year, the actions outlined under Goal 2 were implemented largely as planned, with a few minor adjustments made in response to staffing and instructional needs. Overall, the school successfully strengthened execution of this goal compared to the prior year, driven by more coherent Alpha-wide systems, clearer instructional expectations, and increased consistency in the cycle of lesson planning, observations, and feedback for teacher practice.

A key area of success was the refinement and consistency of instructional coaching and observation systems to support the use of high quality instructional materials with fidelity (Actions 2.1 and 2.3). Teachers engaged in differentiated professional learning aligned to Alpha’s Teacher Rubric and Vision of Excellent Teaching, with a strong emphasis on lesson planning, assessment alignment, and meeting the needs of diverse student groups. This work was reinforced through a structured observation and coaching cycle, in which each teacher participated in biweekly coaching cycles across core content areas. Teachers submitted lesson plans, received targeted feedback, were observed in practice, and then engaged in follow-up coaching conversations. This cycle allowed instructional leaders to closely monitor implementation of our high quality instructional materials and provide highly specific, actionable feedback, representing a key success in strengthening instructional quality. AJH had strong compliance and implementation fidelity with the observation cycle, resulting in noticeable growth in teacher practice. With a strong foundation in practice, moving forward AJH is focused on continuing to strengthen the quality of Tier 1 instruction and differentiation to student needs.

The assessment and data strategy (Actions 2.2 and 2.4) was also a strength this year. The school set tiered growth goals for students using Fall NWEA MAP data and implemented systems for ongoing student goal-setting and progress monitoring. These efforts were reinforced through student check-ins, schoolwide MAP “Pump-Up” events, family engagement sessions, and celebrations of student achievement. As a result, 57% of students met their Fall to Winter Reading NWEA growth goals and 55% met their Fall to Winter Math NWEA growth goals, demonstrating the impact of a more intentional and student-centered data culture.

There were minor implementation challenges related to staffing and program delivery. The site did not maintain an Associate Teacher for the full school year (Action 2.6), and there have historically been challenges in staffing an array of electives positions (Action 2.7), which limited the range of offerings during the school day. In response, the school has expanded after-school opportunities to ensure students have access to enrichment beyond core academics, and they have built strong relationships with long-term substitute teachers to provide classroom coverage as needed.

Finally, the 2025-2026 school year was the first year of Math and Literacy Specialist roles at AJH (Action 2.8). These roles evolved throughout the year to align with instructional priorities and student data. Specialists worked with specific classrooms and teachers in cycles to provide targeted supports to students based on proficiency scores and unit assessment data. Moving forward, AJH will continue to strengthen the structure and implementation of the specialist roles by assigning specialists to specific grade bands and having them serve as dedicated coaches for a longer time frame, allowing for deeper, more impactful support.

Overall, implementation of Goal 2 actions was strong, with key successes in accountability around the observation cycle and the use of our high quality instructional materials with fidelity. With these systems in place, AJH will focus on continuing to deepen the quality of implementation to ensure these efforts translate into sharp increases in student academic achievement.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The actions implemented under Goal 2 have been effective in improving overall student outcomes in both English Language Arts and Mathematics, as evidenced by 2025 California School Dashboard results. For All Students, the school demonstrated growth in both ELA and Math and successfully moved out of the Red performance level in both indicators, reflecting meaningful progress toward meeting state standards. These improvements indicate that the school's focus on strengthening instructional practices, implementing high-quality instructional materials with fidelity, and administering and responding to assessment data, is having a positive impact on student achievement.

The observed growth in ELA and Math is closely tied to the strengthened implementation of instructional coaching and observation systems (Action 2.1), which provided teachers with consistent, actionable feedback aligned to standards-based instruction. The clarity and consistency of weekly walkthroughs, structured coaching cycles, and aligned professional development contributed to improved instructional quality across classrooms. Additionally, the emphasis on data-informed instruction (Actions 2.2 and 2.4), including the use of curricular assessments and NWEA MAP results to set student growth goals and monitor progress, has supported responsive and targeted instructional practices.

The school's commitment to the implementation of its high quality instructional materials with fidelity (Action 2.3) also contributed to improved outcomes, ensuring that all students had access to rigorous, standards-aligned instruction. This is further reflected in the metric that 100% of students had sufficient access to standards-aligned instructional materials, supporting equitable learning opportunities across all classrooms.

Finally, the Math and Literacy Specialist roles (Action 2.8) have provided targeted student support and teacher coaching. By taking a data-informed approach to where these specialists have focused, AJH has been able to effectively use this additional staff capacity to support student academic growth in ELA and Math.

Overall, the data indicate that Goal 2 actions have been effective in driving improved academic outcomes for All Students, with clear evidence of growth and movement out of the lowest performance level. AJH will continue to focus on strengthening the implementation of the school's academic model in order to turn gains in student growth into meaningful improvements in academic proficiency.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Following a year of measurable improvement in both English Language Arts and Mathematics, the school will maintain the overall Goal 2 focus, metrics, target outcomes, and actions for the coming year. While student performance remains below standard, the data reflects positive movement in the right direction. In ELA, All Students improved from Red (-109.3) to Orange (-120, +7.3 points), and in Math from Red (-127.3) to Orange (-98.8, +10.5 points). These gains indicate that current instructional practices, assessment systems, and data-driven strategies are beginning to accelerate student learning. Educational partner input and internal reflection confirm that this current focus on implementing high quality instructional materials with fidelity remains the right focus to support student academic outcomes.

One refinement for the upcoming year is an enhancement to Action 2.2 (Assessment Strategy). The school will incorporate the DIBELS assessment for grades K-3, three times per year, to strengthen early literacy data collection and progress monitoring. This addition will provide more granular insight into foundational reading skills, allowing for more targeted instructional adjustments and earlier identification of student needs.

In addition, Action 2.6 has been revised from 'Associate Teachers' to 'Additional Classroom Support and Coverage' to better reflect the evolving staffing model and operational needs of the school. AJH will leverage external partner organizations to provide classroom support and substitute coverage as needed. This adjustment is intended to maintain continuity of instruction, minimize disruptions to student learning, and ensure classrooms continue to receive consistent support throughout the school year.

An explanation of why the LEA has developed this goal.

In light of the lingering effects of the pandemic, our commitment to cultivating a healthy and thriving school environment is critical. The pandemic and its aftermath have highlighted the need for robust support systems that cater to the holistic needs of our students, encompassing their academic, social, and emotional well-being. Our approach must include evidence-based interventions and proactive strategies to reduce absenteeism and suspensions, thereby ensuring every student feels a sense of belonging and safety in our school community. This is evident as the 2023 CA School Dashboard was Red for Chronic Absenteeism, both overall (37.3%), and for our subgroups: EL (38.8%), Hispanic (37.8%), SED (37.3%), SWD (39.3%). In addition, our Suspension Rate was Red for all students (6.2%) and for our subgroups: EL (6.1%), Hispanic (6.5%), SED (6.3%), SWD (13.8%).

By focusing on these areas, we not only adhere to our educational mission but also lay the groundwork for our students to succeed in a post-pandemic world. This goal encapsulates our dedication to creating a resilient, supportive, and inclusive school environment that empowers every student to achieve their fullest potential.

Our educational partners continue to emphasize the importance of the work toward maintaining a school environment where students feel safe and a sense of belonging. Throughout this new LCAP cycle, we will put resources, time, and development toward key initiatives, including restorative justice practices, positive behavioral interventions and supports (PBIS) systems, response to student culture and behavioral data, an SEL curriculum, and a robust attendance tracking system, among other actions highlighted throughout this goal.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

During the 2025–26 school year, the actions under Goal 3 were implemented largely as planned, with a continued focus on strengthening systems that support a safe, inclusive, and supportive school environment. The school made intentional refinements to address student needs, in particular for Students with Disabilities and Long-Term English Learners (LTELs), while maintaining core structures for behavior, social-emotional learning, and attendance.

A key area of implementation was the strengthening of behavior systems and supports (Actions 3.1, 3.3, and 3.10), with an increased focus on Students with Disabilities. The school worked to streamline partnerships between general education, special education, and network support teams to ensure greater alignment in behavior expectations and interventions. Significant effort was dedicated to building clarity and consistency in behavior intervention practices, particularly through collaboration between the lead Education Specialist and paraprofessionals. This included defining clear expectations for behavior support and improving systems for tracking and monitoring student behavior data. As a result of these efforts, the school observed a decrease in the number of unsafe behaviors over the course of the year, and suspension rates for Students with Disabilities are projected to decline in the 2025-2026 school year.

Social-emotional learning (SEL) and restorative practices (Actions 3.2 and 3.3) were implemented with fidelity, with the Dean of Students leading work to respond to data and student needs. The school observed an increase in behavioral challenges in the lower grades in Fall 2025, which led to a renewed focus on consistent implementation of the SEL curriculum, Sown to Grow, and reinforcement of classroom routines. Additionally, LTEL students were identified as a focus area based on 2024-2025 SY data, leading to school leadership focusing on intentional analysis of data and response for this specific student group. Overall, suspension rates are projected to decline due to this continued focus on restorative practices and support for student social-emotional needs.

Systems for culture and behavior (Action 3.1) continue to be strengthened this year with a focus on collecting and responding to student data. The school used the Healthy & Thriving dashboard to track all student culture data and conducted regular Health Rounds, led by the Dean of Students, to monitor student culture and ensure the school was upholding a healthy & thriving school environment. Looking ahead, the school is preparing to onboard a new Dean of Students for the 26-27 school year, creating an opportunity to reflect on and codify systems and procedures in preparation for the upcoming school year.

Attendance systems (Action 3.4) were implemented with continued intentionality, with strong planning and division of roles and responsibilities by the School Operations Manager and office team. The school focused on implementing the Attendance Playbook with fidelity, which contributed to stronger early-year implementation and improvements in attendance practices. The school also emphasized a more proactive approach to addressing attendance concerns before students became chronically absent, with a particular focus on data for Long-Term English Learner students whose chronic absenteeism rates in the 24-25 SY were elevated. As a result of this focus on early attendance interventions, chronic absenteeism is projected to decline for the 2025-2026 school year.

The school continued to ensure that facilities remained clean, safe, and conducive to learning (Action 3.5), while also expanding opportunities for positive student experiences (Action 3.6), including events, sports, theatre, field trips, and student leadership opportunities that contributed to a strong sense of community and belonging. Expanded learning opportunities (Action 3.8), including partnerships, clubs, and extracurricular programming, were maintained to support student engagement beyond the core instructional day. The Community Schools Coordinator (Action 3.7) contributed to audit and support the school's expanded learning program offerings, such as the Boys & Girls Club, in order to create a stronger connection between students' experiences at AJH and in expanded learning programs.

Overall, implementation of Goal 3 actions at AJH was strong, with key successes in strengthening behavior systems, increasing the fidelity of execution of culture and attendance systems, and continuing to foster a healthy & thriving school environment.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between Budgeted Expenditures and Estimated Actual Expenditures.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The actions implemented under Goal 3 have been overall effective in improving school climate, safety, and student engagement, as evidenced by reductions in both chronic absenteeism and suspension rates. At the same time, the data highlight continued areas for growth for specific student groups, particularly Long-Term English Learners (LTELs) and Students with Disabilities.

Chronic absenteeism has shown meaningful improvement, with All Students declining by 5.2 points to 30.5% (Yellow) . This reflects the impact of strengthened attendance systems (Action 3.4), including earlier intervention, clear staff roles, and focused monitoring of attendance data. Notably, Students with Disabilities demonstrated significant improvement, declining 10.5 points to 30.4% (Orange), indicating that targeted supports and coordination between general education and special education teams are contributing to improved outcomes. However, Long-Term English Learners remain an area of concern, increasing to 34.9% (Red), reinforcing the need for continued focus on this subgroup. Early intervention with this subgroup has been a focus in the 25-26 SY, leading to a projected decline in chronic absenteeism rates for this subgroup.

Suspension data similarly reflects overall effectiveness of the actions in this area. The overall suspension rate declined to 4.2% (Yellow), a decrease of 1.2 points, demonstrating the positive impact of restorative practices (Action 3.3), behavior monitoring systems (Action 3.1), and strong SEL curriculum implementation and response to data (Action 3.2). At the same time, Students with Disabilities (9.9%, Red) and Long-Term English Learners (26.1%, Red) continue to experience disproportionately high suspension rates, indicating that further refinement of behavior interventions and alignment between general education and special education teams is necessary to ensure equitable outcomes.

Additional indicators further reinforce the effectiveness of Goal 3 actions, including 86.34% of students responding favorably to the survey question measuring student safety and 86.81% students responding favorably to the question “I feel that there is at least 1 adult who cares about me”. Additionally, the school maintained a 0% expulsion rate and 0% middle school dropout rate, demonstrating a strong commitment to keeping students engaged (Action 3.6) and supported in school. Finally, facilities (Action 3.5) were reported as meeting standards with access to instructional materials and safe, functional conditions, ensuring students are learning in a stable and supportive environment.

Overall, while the data demonstrate that Goal 3 actions are contributing to improved attendance and reduced suspensions, Red performance level outcomes for specific student groups, Long-Term English Learners and Students with Disabilities, points to a continued area of focus for AJH moving forward.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Based on reflection of implementation and effectiveness data from the 2025–26 school year, no significant changes will be made to the goals, actions, metrics, or expected outcomes for Goal 3 in the coming year. The school has observed positive outcomes, including reductions in chronic absenteeism and suspension rates, indicating that current systems and strategies are effectively supporting a safe and inclusive school environment. As the final year of the current LCAP cycle approaches, the school will maintain continuity of these actions while continuing to refine implementation. Ongoing focus will be placed on monitoring and addressing suspension rates among Students with Disabilities and our Long-Term English Learners, as well as reducing chronic absenteeism for LTEL students as well, to ensure continued progress and equitable outcomes for all students.

Additionally, the school will continue to strengthen its Community Schools programming as it moves beyond its initial launch year. This includes building a clear throughline across Community Schools initiatives to ensure all stakeholders understand the role of the Community Schools Coordinator and team. The school will focus on increasing family engagement in programs by refining outreach strategies, ensuring offerings are well-attended, and determining the optimal number and structure of parent meetings to maximize family participation. The

Community Schools Coordinator will play a key role in aligning services, strengthening partnerships, and enhancing communication to ensure that supports are effectively reaching students and families.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

During the 2025–26 school year, all actions under Goal 4 were implemented as planned, with no substantive differences between intended and actual implementation. The school continued to strengthen systems and structures to build authentic partnerships with families and increase engagement in ways that support student achievement and wellness.

Parent communication systems (Action 4.1) were consistently utilized throughout the year. The school continued to use Konstella as its primary family communication platform, ensuring timely and accessible communication with families. To address the linguistic needs of the community, all key communications were provided in both English and Spanish, and translation support was available for meetings,

conferences, and ongoing outreach. These efforts supported increased accessibility and strengthened relationships between families and school staff. Additionally, the school maintained regular family surveys and conferences, continuing to prioritize two-way communication and family voice.

School community events and celebrations (Action 4.2) were implemented with increased intentionality and structure. For the first time, the school developed systems to track attendance at family events, establishing a baseline to better understand participation trends and inform future planning. This data-driven approach allowed the school to refine outreach and improve engagement, resulting in increased attendance, particularly among families of students in grades 7 and 8. The school successfully hosted a range of events, including Back to School Night, cafecitos, award ceremonies, and family workshops, such as STEM-focused sessions, which further strengthened community connections.

Programs and services through the Alpha Parent Learning Center (Action 4.3) continued to be offered and expanded, providing families with access to educational, wellness, and community-based resources. The school also introduced and supported targeted programming, including initiatives like Girls Who Code, which provided meaningful opportunities for student engagement while also increasing family involvement and awareness of school programming.

Parent partnership opportunities (Action 4.4) remained a strong area of implementation. The school continued to offer volunteer opportunities and programs such as Los Dichos, creating space for families to actively participate in their child's education and celebrate cultural identity and literacy. These efforts contributed to a stronger sense of belonging and partnership within the school community.

Finally, the school maintained and strengthened structures to build parent leadership (Action 4.5), including School Site Council (SSC), English Learner Advisory Committee (ELAC), and other parent leadership groups. These spaces provided families with meaningful opportunities to share input, collaborate with school leadership, and contribute to decision-making processes. The school also focused on ensuring that family programming and meeting frequency were intentional and responsive to maximize participation and avoid over-scheduling, reflecting a more strategic approach to engagement.

Overall, implementation of Goal 4 actions was strong and cohesive, with notable successes in increasing family participation, improving communication systems, and creating more structured opportunities for family voice and leadership.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no material differences between Budgeted Expenditures and Estimated Actual Expenditures.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The actions implemented under Goal 4 have been effective in strengthening family engagement, communication, and overall connection between the school and its community. Through consistent implementation of multilingual communication systems, expanded family events,

and increased opportunities for parent leadership, the school has continued to build a strong sense of partnership with families in support of student achievement and wellness.

Family survey data indicates high levels of satisfaction and engagement across key measures. Specifically, 96.88% of families report feeling a strong sense of belonging and connectedness to the school community, reflecting the impact of consistent communication practices and inclusive community events (Actions 4.1 and 4.2). Additionally, 93.55% of families agree that the school listens to family voice and input when making decisions, demonstrating the effectiveness of leadership structures such as SSC, ELAC, and parent committees in elevating family perspectives (Action 4.5).

The school has also been effective in providing meaningful opportunities for family participation. 96.88% of families report satisfaction with the amount of opportunities to engage in school activities and programs (including by subgroup), indicating that events such as Culture Day, STEM parent workshop, Girls Who Code, and family conferences are successfully fostering engagement across diverse groups (Actions 4.2 and 4.4). Furthermore, 93.76% of families report satisfaction with the level of physical and emotional safety at the school, reflecting the broader impact of a positive school culture and strong communication systems (Actions 4.1 and 3.1–3.3).

These outcomes are directly connected to the school's intentional focus on accessible, multilingual communication, regular feedback collection through surveys, and the creation of inclusive spaces for families to engage and lead. The continued use of both digital and paper-based communication, along with translation support, has ensured that all families, particularly those from historically underserved communities, can participate meaningfully in the school community.

Overall, the data indicate that Goal 4 actions have been effective in building strong family-school partnerships, increasing engagement, and fostering a sense of belonging and trust within the school community. These efforts have created a solid foundation for continued collaboration with families in support of student success.

Based on reflections from the 2025–26 school year, no significant changes will be made to the planned goal, metrics, target outcomes, or actions for Goal 4 in the 2026–27 school year. Implementation data and family feedback indicate that current strategies are effectively supporting strong family engagement, communication, and community partnership. As the school enters the final year of the current LCAP cycle, the focus will remain on maintaining and refining existing practices to ensure continued high levels of family participation, satisfaction, and connection to the school community.

State Priorities addressed by this goal.

Priority 1: Basic (Conditions of Learning)

An explanation of why the LEA has developed this goal.

It is critical for our school to develop and maintain fully credentialed and high-quality educators. However, given the teacher shortage that we are experiencing in the Bay Area, it is challenging to hire and retain strong educators for our school. Over the past two years at AJH, we have experienced transitions among our Senior Leadership Team (SLT). Four of the six SLT members (Dean, Principal, 2 Assistant Principals) were new in the 22-23 SY, as three SLT members transitioned into Alpha Network Team roles. In addition to SLT transitions, we have experienced lower staff retention rates and a lighter talent pool of high quality applicants as educators exited the profession post-pandemic. The lighter talent pool, coupled with changing CTC requirements, has resulted in hiring educators that are newer to teaching and require more support, alignment, and coaching.

To address these underlying causes, we have established the following theory of change at Alpha: If we develop excellent coaches, then they will develop excellent educators, which will result in improved student outcomes. Therefore, we are focused on continuing to invest heavily in internal and external professional development and coaching of our leaders, teachers, and instructional staff. We are creating leadership pathways for staff members to grow and stay at Alpha, we regularly review our compensation and benefits packages, and we are using a variety of recruitment strategies to attract high-quality talent to our AJH.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

During the 2025–26 school year, all actions identified under Goal 5 were implemented as planned, with no substantive differences between planned and actual implementation. The school maintained a strong focus on hiring, developing, and retaining high-quality staff through aligned professional development systems, robust coaching structures, and intentional efforts to foster a positive and supportive adult culture.

A central component of implementation was the continued investment in teacher development through coaching and professional learning (Action 5.1). School Leadership Team (SLT) members conducted regular observations and 1:1 coaching meetings with teachers, aligned to Alpha’s Vision of Excellent Teaching and Teacher Rubric. These coaching cycles were closely connected to professional development sessions and grade-level or department meetings, creating a cohesive system for continuous improvement. Teachers received frequent, actionable feedback on instructional practices, and the alignment between coaching and PD was a key strength in implementation.

The school also successfully implemented onboarding and training systems for new staff (Action 5.2), providing a comprehensive summer experience that introduced instructional expectations and foundational teaching practices. Ongoing development for instructional support staff (Action 5.3) ensured that all staff members working directly with students received coaching and professional learning aligned to schoolwide instructional priorities.

Leadership development (Action 5.4) was a notable area of strength this year. Leaders participated in differentiated coaching development sessions, focused on strengthening skills in coaching, professional development design, and facilitation. These efforts were reinforced through cycles of feedback and practice, and were closely aligned to the school’s coaching model, ensuring consistency and coherence across instructional leadership practices. Opportunities for teacher leadership were also maintained through lead team structures.

Efforts to foster a positive school culture among staff (Action 5.5) were implemented through proactive planning and ongoing responsiveness to staff needs. The school hosted regular celebrations, team-building events, and recognition programs, including shout-outs and peer-nominated awards, to build a strong sense of community and appreciation among staff. Regular staff surveys were conducted to gather feedback and inform continuous improvement of adult culture.

Credential and certification support (Action 5.6) was strengthened this year, with the school providing earlier and more proactive communication to teachers regarding their credential status. Ongoing credential reviews and support from Alpha's network Credential Specialist ensured that teachers remained on track for compliance, and staff reported feeling well-supported throughout the process.

Hiring strategies (Action 5.7) and compensation and benefits structures (Action 5.8) were implemented as planned, with the school utilizing network-supported recruitment processes, inclusive hiring practices, and ongoing staff feedback to inform compensation and benefits. These systems supported the recruitment and retention of a diverse and highly qualified staff.

Overall, implementation of Goal 5 actions was strong and cohesive. Key successes included the alignment of coaching and professional development, differentiated leadership training, strengthened credential support systems, and a positive adult culture. These efforts contributed to a supportive and high-functioning staff environment, positioning the school to continue attracting, developing, and retaining high-quality educators.

There were no material differences between Budgeted Expenditures and Estimated Actual Expenditures.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The actions implemented under Goal 5 have been effective in maintaining a high-quality, well-supported faculty and staff, as evidenced by strong outcomes in teacher credentialing and staff perception data. The school successfully sustained high levels of fully credentialed teachers, reflecting the effectiveness of hiring strategies, credential monitoring systems, and proactive support provided to staff (Actions 5.6 and 5.7). Early communication around credential status and ongoing support throughout the year ensured that teachers remained on track and felt supported in meeting certification requirements.

In addition, staff perception data from the Spring TNTP survey indicates strong results in the area of Learning Environment, with teachers reporting positive experiences related to school culture, collaboration, and support. These outcomes demonstrate the effectiveness of the school's investment in professional development and coaching systems (Actions 5.1 and 5.4), which provided consistent, actionable feedback and aligned support for instructional improvement. The coherence between coaching cycles, professional development, and leadership support contributed to a strong instructional culture and a sense of shared purpose among staff.

Efforts to foster a positive adult culture (Action 5.5), including recognition systems, team-building events, and regular opportunities for feedback, further supported teacher satisfaction and retention. Additionally, differentiated leadership development and targeted onboarding and support for new and returning staff (Actions 5.2 and 5.4) ensured that all staff members received development aligned to their experience and role.

Overall, the data indicate that Goal 5 actions have been effective in supporting teacher development, maintaining a highly qualified staff, and fostering a positive and collaborative professional environment. These systems position the school to continue retaining strong educators and sustaining high-quality instruction for students.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

A review of implementation and outcome data from the 2025–26 school year indicates that no significant changes are necessary to the planned goal, metrics, target outcomes, or actions for Goal 5 in the 2026–27 school year. Current data demonstrate that existing systems for hiring, developing, and retaining staff are effective in maintaining a highly qualified workforce and a positive professional culture. As the school enters the final year of the LCAP cycle, the focus will remain on sustaining and refining these practices to ensure continued staff development, retention, and strong instructional outcomes for students.

Building on the success of this year’s robust observation and coaching cycles, the school will continue to prioritize teacher and leadership development with a focused emphasis on the consistent implementation of adopted instructional materials with fidelity. This includes deepening instructional practices related to assessment, learning design, delivery of content, checks for understanding, and the use of effective scaffolds to support all learners. Additionally, there will be an increased focus on classroom management strategies that utilize least invasive redirections to maximize student engagement and maintain a healthy and thriving learning environment.

Leadership development will further prioritize strengthening capacity in data analysis and responsive instructional decision-making, as well as deepening content and curriculum expertise. Leaders will continue to refine their ability to support teachers in implementing high-quality instructional methodologies and using assessment data to drive continuous improvement. These refinements are intended to enhance the effectiveness of existing systems while maintaining alignment with the overall goal.

- **Estimated Actual Percentage of Improved Services:** For any action identified as contributing, being provided on a Limited basis only to unduplicated students, and that does not have funding associated with the action, enter the total estimated actual quality improvement anticipated for the action as a percentage rounded to the nearest hundredth (0.00%).

- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

- **5. Total Planned Percentage of Improved Services (%)**
 - This amount is the total of the Planned Percentage of Improved Services column.
- **8. Total Estimated Actual Percentage of Improved Services (%)**
 - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
