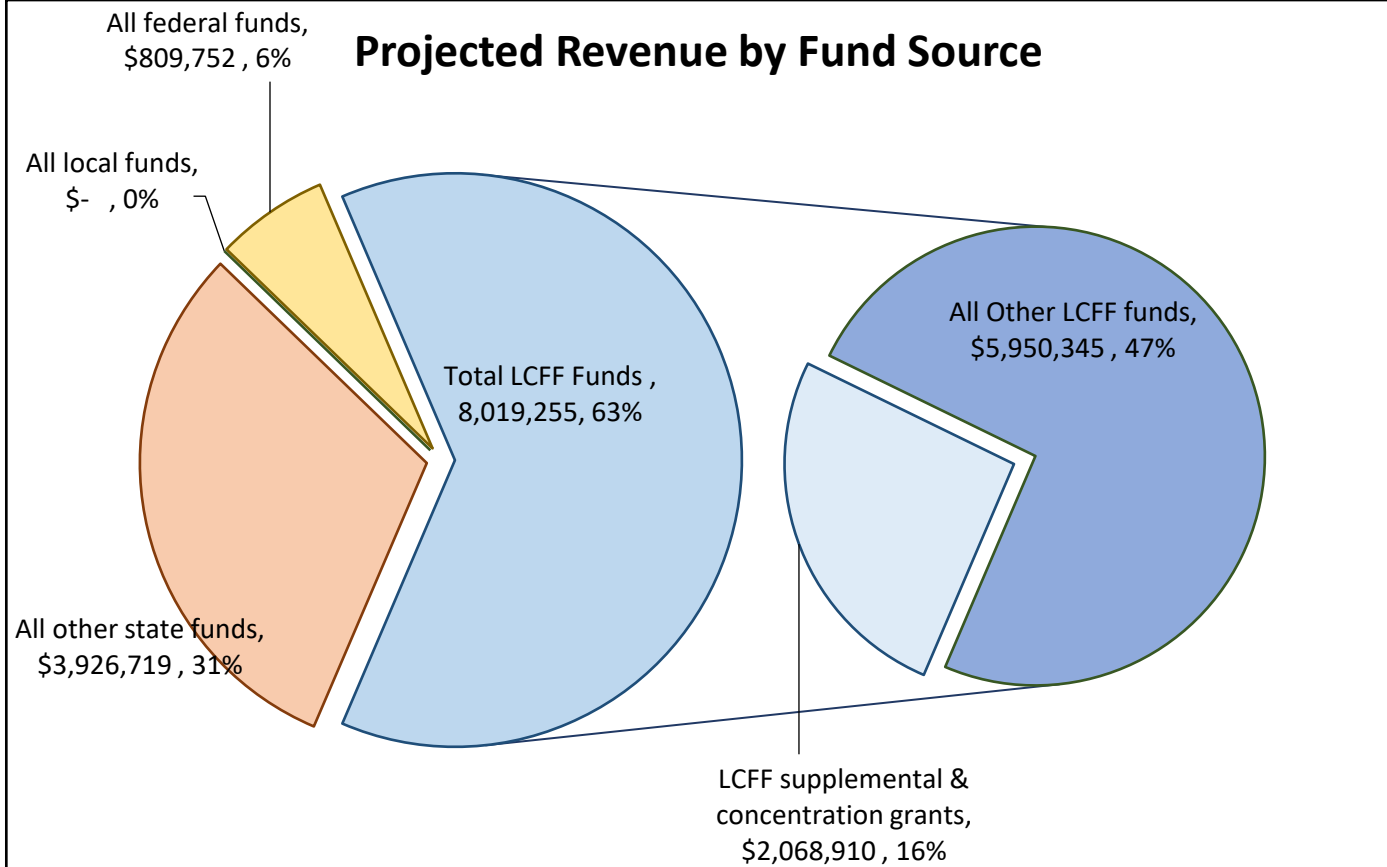

Projected Revenue by Fund Source

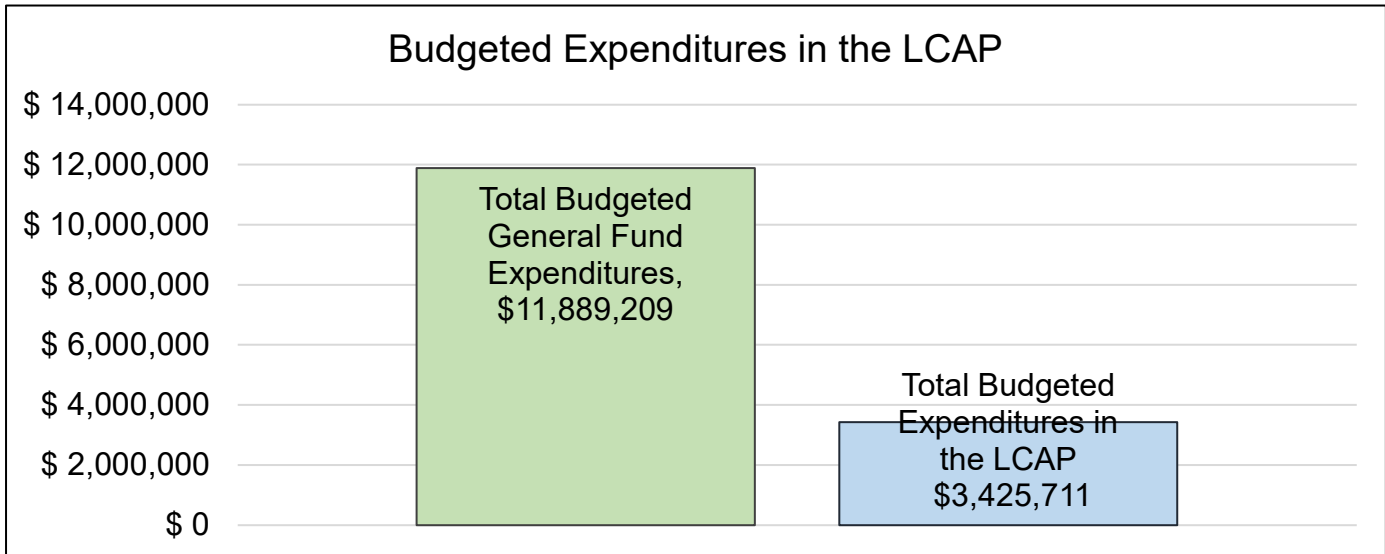


This chart shows the total general purpose revenue Rocketship Fuerza Community Prep expects to receive in the coming year from all sources.

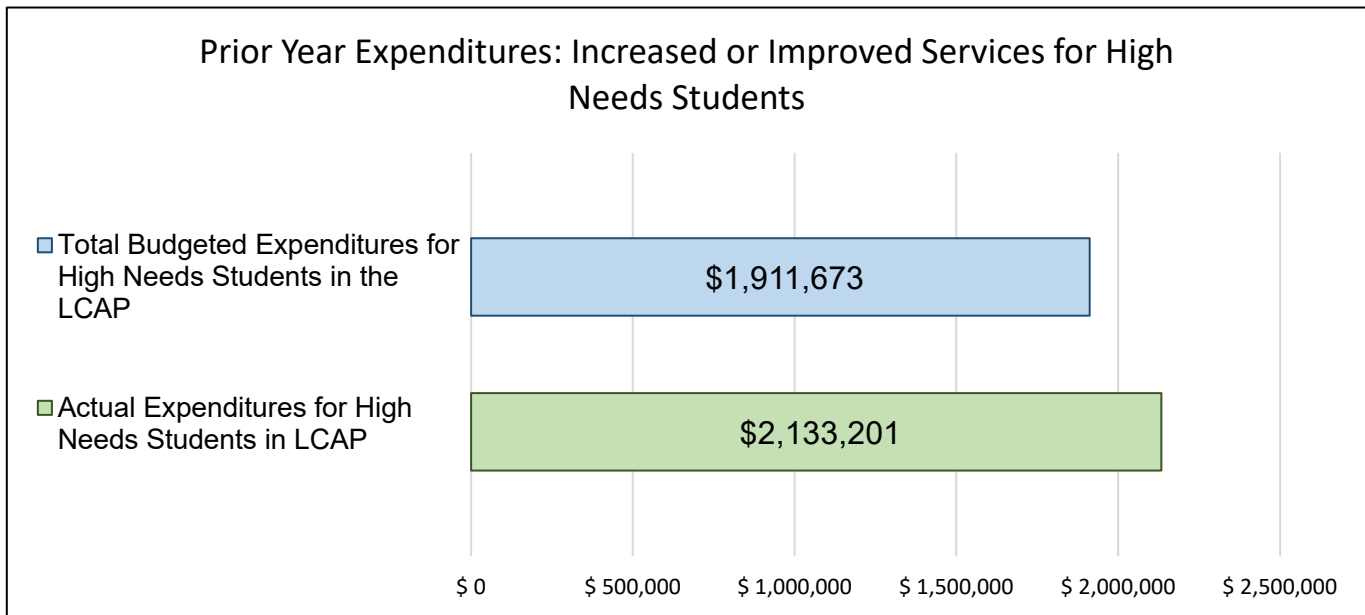

Plan Summary 2025-26

General Information

Rocketship Fuerza Community Prep (RFZ) opened in August 2014 as TK-4th grade campus, the ninth Rocketship campus to open in San Jose. The campus now serves approximately 506 TK-5th grade students. Approximately 77% of the students are socioeconomically disadvantaged, 10% are Homeless, 59% are English learners, 85% are Hispanic/Latinx and 8% are Asian. Additionally, 10% of students qualify to receive special education services.

Rocketship Fuerza operates a highly personalized educational model to serve the unique needs of our students. At Rocketship, personalized learning is about reaching each student with the right content at the right time using the right method of instruction. Our teachers lead the learning process for every single student we serve in both whole group grade level instruction and differentiated instruction that meets students at their individual level. We use tutors and adaptive online learning programs to augment teacher-led instruction and provide valuable time for students to practice new concepts and develop the mastery they need to advance. Given the majority FRL and EL population, Rocketship Fuerza’s instructional program is built around ELD principles and recognizes incoming students may be several grade levels behind. As a result, all teachers are trained in Guided Language Acquisition Design, small group instruction and differentiation to meet the needs of all students in their classrooms.

Rocketship Fuerza also operates under the principles that excellent teachers and leaders create transformational schools and engaged parents are essential in eliminating the achievement gap. To these ends, Rocketship invests deeply in training and development to ensure teachers and leaders have a profound impact on students and communities and Rocketship parents are actively engaged in our schools, from reading in the classroom to chaperoning field trips. We also develop parent leaders in our schools and communities to become powerful advocates for their children. More details regarding how we implement personalized learning, teacher development and parent engagement follow.

All Rocketship campuses share four core values-- respect, responsibility, empathy and persistence—and develop a fifth core value as a community. At Rocketship Fuerza this fifth core value is *ganas*. *Ganas* is the fuel that makes the core values of respect, persistence, empathy, and responsibility come to life and ignites students' desires and zest to achieve their best. Cultivating *ganas* means that students will find joy and meaning in a challenge and push themselves to overcome it. It means that students will not just work persistently towards achievement but deeply desire it. Students with *ganas* will also encourage and motivate their peers to be better students, friends, sons, daughters, and community members. Rocketeers fueled by *ganas* are expected to face challenges head on with intelligence, resolve, and pride. They will create solutions instead of making excuses and push beyond expectations of themselves and their community. This core

value reminds our Rocketeers that success comes not only through hard work but also through a deep desire to reach one's goals and help others achieve theirs.

The purpose of this Local Control Accountability Plan (LCAP) is to address the School Plan for Student Achievement (SPSA) for Rocketship Fuerza Community Prep which is the Schoolwide Program; herein referred to as the LCAP. The plans included in the LCAP address these requirements compliant to include focusing on five goals: Improve Rocketeers’ proficiency in key content areas, overall and for key subgroups; Rocketeers will be taught by highly qualified teachers and educators with robust training and development on common core standards aligned curriculum; School environment will be safe, welcoming, joyful, and efficient for all students and families; Rocketship students will have access to opportunities that support them to become well-rounded, self motivated, engaged community members; Rocketship families are engaged in their students' education and advocate for their communities. The Charter School completed a comprehensive needs assessment of the entire school which included an analysis of verifiable state data as well as local performance data used to measure student outcomes as evidenced in the annual update portion of the LCAP. The needs assessment process included meeting parents, classified staff, teachers and administrators to identify areas of opportunity for the students and groups of students who are not achieving standard mastery and to identify strategies which will be implemented in the LCAP to address those areas of opportunity.

The identification of the process for evaluating and monitoring the implementation of the LCAP and the progress toward accomplishing the established goals will include discussing the actions and services with the use of supplemental funds at the school level through the Parent Advisory Council which will include parents of English Learners. The Parent Advisory Council will meet four times per year to inform the process. Parents, classified staff, certificated staff and an administrator will make up the council. The number of parents will exceed or be equal to the number of total staff members. The council will discuss academic performance, supplemental services and areas to make improvements with Title funds as part of the School Plan included in the LCAP conversations at the meeting in the fall and at the meeting in the spring. The teachers, staff, students and parents also participate in an annual survey which provides feedback on the goals and services. The teachers, staff and administrators actively participate in the decision making process throughout the year and during LCAP workshops. The decisions will take into account the needs of Rocketship Fuerza Community Prep based on student achievement data to include SBAC, ELPAC, and interim assessment data such as NWEA MAP, cumulative assessments, and attendance and student demographic data to include the significant subgroups of Latino, Black or African American, White, socioeconomically disadvantaged, students with disabilities, and English Learners. This student achievement data and student demographic data will be used as a basis for making decisions about the use of supplemental federal funds and the development of policies on basic core services.

Each goal includes actions and services that address the needs of all students and significant subgroups which include evidence-based strategies that provide opportunities for all children, methods and instructional strategies, and particular focus on students at risk of not meeting the State academic standards.

2023 Dashboard Reflections for Red Indicators (required to remain in plan for 3-Year LCAP cycle)

RFZ has identified a need in English Learner Progress (Red, 27.7%). We will address this need by implementing Action 1.3 Services to Support Multilingual Students Required Action. We began in 23-24 to have specific P.D. for Designated ELD in the classroom. We hope to have all our teachers certified in GLAD training to ensure they know the strategies for Integrated ELD.

2025 Dashboard Reflections

English Learner Progress continues to be an area of need. In 2024, the percentage of English learners (ELs) making progress or maintaining at the highest level on the ELPAC increased to 51.6% (Green), but in 2025 decreased to 23.7% (Red). In 2025-26 teachers are using ELPAC and EL Progress Monitoring data to ensure their instruction is meeting the current language acquisition needs of the students in front of them. Teachers are specializing in teaching Designated ELD to one level of students to allow them to gain expertise in the instructional needs and most effective instructional strategies for that group of students. Our ML Specialists continue their support with newcomer interventions as needed and will provide them with more content knowledge development to be able to push into content classes to increase access for English learners.

English Language Arts achievement has maintained at a similar level (+0.5) from 2024-25, while math achievement increased (+5.4) driven primarily by large gains from the Hispanic (+16.1) and Students with Disabilities (+30.5) subgroups. We attribute this success to a strong group of teachers and assistant principal who has provided coaching support. Additionally, the math curriculum was in its third year of implementation allowing teachers to master the pacing and best practices for adjusting instruction to meet student needs. We also had strong Family Partnership practices with communications provided to teach families how to practice the skills at home. For Students with Disabilities, we attribute their growth to strong co-teaching practices that have been strategically scheduled at the times when students need the most support from an additional teacher in the room.

The school continues to maintain a very low Suspension rate (Blue, 0.2%) by implementing restorative practices and providing students the opportunity to reflect on actions and fix the situation instead of excluding them. We will build on this success by continuing to implement Action 4.3 Social Emotional Learning.

Chronic Absenteeism is also a continuing area of need, increasing in 2025-26 for all students (Red, 24.8%) and for all numerically significant subgroups except English Learners. Actions 4.4 Care Corps and 5.5 Attendance Initiatives will continue to be strengthened to address this need. This year attendance has been highly incentivized with raffles and free dress awarded for regular attendance. Additionally, the school started holding meetings with families of students in danger of becoming chronically absent earlier in the year to educate families about the importance of regular attendance and create plans to support the family.. As a result of these efforts chronic absenteeism has decreased.

Learning Recovery Emergency Block Grant (LREBG)

RFZ has \$51,331 in unexpended LREBG funds for the 2026-27 school year.

RFZ students need tailored supports to remove barriers to success.

Although RFZ runs an inclusion model, we realize that our students with disabilities (SWD) may require additional academic, social-emotional, and adaptive skills support to be successful learners. These additional supports include additional assessments, such as psycho-educational assessments, speech-language assessments and occupational therapy assessments; additional staffing supports, such

as adaptive PE instructors, physical therapists, mental health supports and assistive technology specialists; additional materials, including instructional supplies for speech lessons, counseling materials for school psychologists and occupational therapy materials; and adaptive technology.

This falls under the allowable uses of the LREBG funding by providing additional staffing to reduce teacher:student ratios. Metrics 1.1 and 1.2 CAASPP ELA and Math: % Met or Exceeded Standard for students with disabilities will be used to monitor the effectiveness of this action.

Various	The School Site Council, which fulfills the LCAP Parent Advisory Committee role, is composed of parents and staff. The SSC and English Learner Advisory Council (ELAC) met quarterly throughout the year to reflect on data and provide input on plan development. Our School Site Council participated in a needs analysis process and identified the key successes and challenges for RFZ based on the CA School Dashboard for 2025 (See Reflections: Annual Performance) and more recent data aligned to Dashboard indicators. Our SSC and ELAC committees met for LCAP consultation on 10/8/25, 11/19/25, 2/4/26, 4/22/26. Community Members are invited to participate in any and all open community engagement, including Regional Community Advisory Board Meetings. Advocates are invited to participate in any and all open community engagement. Tribes are not applicable. We consulted our SELPA for LCAP input in May of 2026. Parents have the opportunity to provide feedback on services and supports for students with disabilities via the El Dorado Charter SELPA's Community Advisory Committee (CAC) either as participants or as board-approved voting members. Our board meets quarterly as a public hearing with the opportunity for public comment. We promoted parent participation in public meetings and public hearings through website and agenda posting. Virtual meetings conducted via video conference had telephone call-in access. We provided translation as needed. The LCAP Public hearing was held on May 27, 2026. The LCAP was adopted on June 11, 2026.
Parents	Parents provided LCAP feedback throughout the year through various parent engagement opportunities. These opportunities include, but are not limited to, monthly coffee chats with the principal–Cafecitos (8/13/25, 9/3/25, 10/1/25, 11/5/25, 2/4/26, 3/4/26, 4/1/26, 5/6/26), community meetings, and 1:1 meetings with the school leadership team. They also provided feedback through surveys (network and informal school-specific), including the Annual Parent Survey (March 2026).
Teachers, School Staff, Administrators	Teachers, school staff, and school administrators provided LCAP feedback throughout the year in a variety of ways--during regular staff meetings, 1:1 meetings, a Brown Bag feedback meeting (9/24/26), monthly Cafecitos and staff surveys, Data Day and P.D. reflections, plus informal surveys such as our weekly feedback survey that goes out in the launcher.
Students	Teachers held Community Meetings with students regarding their experience, perspectives, and needs. Teachers shared student feedback from these discussions with school leadership to inform plans. Students also provided input on the Student Survey (Winter 2025).

Action 1.3 was modified based on teacher and administrator feedback that the ELPAC Interim Assessment should be discontinued due to time demands, limited instructional usefulness of the data, and overall assessment burden on students. An English Language Development Progress Monitoring (ELD PM) tool was implemented to monitor student progress during instruction in place of it.

Action 1.4 Special Education Supports: Input was gathered during IEP meetings, parent conferences, and School Site Council and English Learner Advisory Committee (SSC/ELAC) meetings throughout the school year. Families and staff emphasized the importance of increased access to specialized services, improved communication between home and school, and expanded mental health supports. This input will guide continued investment in staffing, improved scheduling of services, and enhanced family communication systems moving forward.

Goal 2 Analysis: Teacher feedback is overall positive regarding the goal and actions. They would like more flexibility, planning time, and less afternoon meeting time.

Goal 4 Analysis: Students love the activities provided as part of the Enrichment action. Going outside for athletics and dance classes is a favorite part of their day.

Goal 5 Analysis: Parents appreciate the consistency of school events and communication. They would like additional events and celebrations added. The SSC council wants to get as many families involved in the school community as possible.

In order to achieve our academic growth and achievement goals, we know that families are critical partners in the endeavor. Family involvement is a cornerstone of our school model. Actions in this goal are key components of student and family engagement. We will monitor progress toward this goal through key indicators of engagement--attendance and absenteeism rates and measures of family outreach, parent involvement, and parent perceptions of satisfaction and connectedness. Specifically, we will measure the effectiveness of 5.1 Family Engagement, 5.2 Family Advocacy and Leadership, 5.3 School-Family Partnership, and 5.4 Los Dichos through % of parents who are involved, % of home visits completed, parent satisfaction and connectedness survey results, and parent input into decision making metrics. We plan to measure the effectiveness of 5.5 Attendance Initiatives through Attendance rate and Chronic Absenteeism rates.

Goal Analysis for 2025-26

An analysis of how this goal was carried out in the previous year.

All Goal 1 actions were implemented as planned, with the exception of Action 1.3 (Services to Support Multilingual Learners), where adjustments were made.

1.1 Personalized Learning

Small group instruction improved, resulting in more students receiving instruction at their appropriate level with targeted support to advance. Progress monitoring systems were strengthened using multiple measures to better inform instruction. A key challenge was addressing a wide range of student needs within classrooms. Variability in student levels made it difficult to consistently group students and deploy staff strategically.

1.2 Special Education Supports

Additional assessments and expanded services improved timely identification of student needs and allowed for more targeted interventions. Increased collaboration among staff strengthened implementation of the inclusion model. Students showed improved access to grade-level curriculum, and use of assistive technology increased to support learning and independence. A key challenge was staffing for special education. Scheduling constraints required prioritizing co-teaching support during the highest-need instructional times, limiting broader access across the day.

1.3 Services to Support Multilingual Learners

The ELPAC Interim Assessment was discontinued due to time demands, limited instructional usefulness of the data, and overall assessment

burden on students. An English Language Development Progress Monitoring (ELD PM) tool was implemented to monitor student progress during instruction. Teachers used the tool biweekly to identify focus skills and inform grouping for Designated ELD.

Implementation improved clarity around high-quality ELD instruction and supported identification of students and skills for re-teaching. Over 80% of newcomer students receiving targeted support demonstrated growth on post-assessments. As a first-year implementation, challenges included inconsistent data collection, limited clarity on the rubric, and varying teacher capacity to use the tool effectively. Despite this, available data was used to guide instruction.

1.4 Rocketship Reads

Rocketship Reads was implemented successfully at the start of the year, with strong student engagement driven by incentives and opportunities to earn and purchase books. A key challenge was maintaining momentum and consistent participation throughout the year. Despite this, students demonstrated growth in reading levels on NWEA, likely supported by increased reading practice and improved test access through stronger reading skills.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 1.2 Special Education Supports budgeted expenditures \$ 358,876 and estimated actuals \$ 646,248 difference was due to the increased need for special education contracted staff due to open roles and higher than anticipated special education support needs. Contracted staff are more expensive than hiring internal staff.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The 1.1 Personalized Learning and 1.5 Rocketship Reads actions have been somewhat effective overall with increased scores on both the CAASPP ELA and Math assessments. Also, the NWEA MAP data for K-2, shows students exceeding our targets for both Math and Reading. These actions are showing less effectiveness with regard to Science achievement, which has decreased this year.

Our tier 2 supports during Learning Lab are showing effectiveness with 53% of students provided Tier 2 support by a tutor Tier 2 during Learning Lab time meeting their Dibels Reading growth target for Fall to Winter. Although we see growth, there is still work to be done to achieve greater growth overall and among student groups that we will continue working to address.

1.2 Special Education Supports were effective in making progress toward the goal. RFZ demonstrated mixed results in CAASPP outcomes for students with disabilities. Implementation of inclusive practices and support services improved access to instruction; however, results indicate some variability, and continued refinement is needed to further accelerate student outcomes.

The 1.3 Services to Support Multilingual Students action was somewhat effective. In 2025, we had 24% of students making progress in the English Learner Progress Indicator. In 2025-26, we had a reclassification rate of 0.7%.

Action 1.1 was modified from a “more than 1:1 student to Chromebook ratio” to “maintain a 1:1 student to Chromebook ratio”. Also, the description was modified to include what will be added to the action in 2026-27.

Action 1.3 was modified to remove the ELPAC interim and add the ELD progress monitoring tool (as discussed in the first prompt).

The specific investments for intervention include Intervention curriculum and tutors. Our objective every day is to get the right lesson to the right child at the right time. We assume that every child, especially the children in the neighborhoods we serve, will have unique learning needs that must be addressed individually. The Rocketship model combines traditional classroom instruction with blended learning, which enables online learning programs technology, small group instruction and tutoring. All students, including our Special Education students, access and benefit from this instructional model as our school operates an inclusion model. Additionally, we provide robust technological supports to ensure that our students have consistent access to the full curriculum. 1.2	Special Education Supports (LREBG)	Although RFZ runs an inclusion model, we recognize that our students with disabilities (SWD) require additional academic, social-emotional, and adaptive supports to be successful. For 2026–27, the school will deepen its commitment to inclusive practices by strengthening co-teaching models, increasing professional development on Universal Design for Learning (UDL), differentiation, and accommodations, and ensuring students have greater access to grade-level curriculum within the general education setting. Strategic staffing decisions will be prioritized to better align services to student needs, including more intentional scheduling of special education staff, related service providers, and support personnel to maximize push-in services and minimize instructional disruption. 1.3	Services to Support Multilingual Students	Our continued goal is that emerging bilingual students make steady progress towards English language proficiency, by growing at least one level on the ELPAC assessment and reach proficiency prior to 5th grade. This will also benefit students in their access to content instruction, as students who have been reclassified have sustained academic achievement each year. Last year 25-26, we continued to focus on EL Roadmap Principle 2 by explicitly teaching ELD during protected time of the day and focusing on higher quality Tier 1 instruction through the use of stronger integrated ELD strategies. We focused on comprehensible input such as vocabulary building, sentence frames for oral language development, and language level prompting to engage students in content. This focus was elevated by GLAD strategies through professional development and coaching support. We invested in an internal English Language Development Progress Monitoring Tool (ELD PM) that requires teachers to use a rubric aligned to the CA ELD Stands Proficiency Level Descriptors to assess student's language abilities. Newcomer supports were amplified through Multilingual Learner Specialists who provided additional direct services to students, where students engage in lessons that addressed not only their English language acquisition needs, but also their social emotional needs. Students also received foundational skills development to improve their reading skills in English. With bilingual Multilingual Learner Specialists, students received home language supports to accelerate English language acquisition. We also continue to elect ELAC Ambassadors to increase family voice in the program implementation and family partnership, and at home supports. In 26-27, we will continue to have strong DELD instruction through coaching, clear look fors, and data analysis of the ELD PM. For integrated ELD strategies, we will continue to use comprehensible input and GLAD strategies so that students move along the language continuum. Goal Analysis for 2025-26

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

All Goal 2 actions were implemented as planned.

2.1 High-Quality, Research-Based Curriculum: CKLA Integrated and Knowledge was successfully adopted across campuses, with aligned unit launches and bi-weekly coaching cycles supporting implementation. Key challenges included differentiating instruction for

below-grade-level readers while maintaining access to grade-level content, as well as the learning curve associated with a new curriculum. Initial differentiation resources have been developed and will continue to be refined.

2.2 Professional Development: Expanding new educator orientation into a three-day experience strengthened alignment and collaboration. The primary challenge was differentiating support for new and returning teachers implementing the same curriculum, which will be refined moving forward. Teacher feedback is overall positive regarding professional development. However, they would like more flexibility, planning time, and less afternoon meeting time.

2.3 Data-Driven Instructional Practices: Progress monitoring for English Learners and adoption of Amira improved efficiency and data use. The main area for growth is building teacher capacity to analyze data and take effective instructional action.

2.4 Instructional Coaching: New coaching tools strengthened coaches' ability to diagnose and develop teacher practice. Coaching in the moment has helped teachers to better understand their data. A key challenge is accelerating the development of first-year coaches.

2.5 Teacher Credentialing

Rocketship Public Schools has significantly expanded educator development pathways through strengthened university partnerships, increasing access to degree, intern, and residency programs. Through partnerships with Reach University and Rivet School, 10 staff members have earned bachelor's degrees and 15 are currently enrolled, creating a pipeline into credential programs and teaching roles. Rocketship currently supports over 75 educators across credentialing pathways, including Multiple Subject, Education Specialist, and PK–3 programs through Reach University, San José State University, Santa Clara County, and Loyola Marymount University. For the 2025–2026 school year, this includes 44 participants in the Reach Intern Program, 18 enrolled at SJSU (with 15 additional projected), 1 participant in the PK–3 pathway, and 5 residents in LMU's program. The Credentialing & Compliance Team partners closely with universities to streamline program implementation, allowing educators to focus on instructional practice and student outcomes. This expansion reflects significant growth from prior years when Reach was the sole partner. Looking ahead, Rocketship aims to enroll over 50 staff members in intern programs for the 2026–2027 school year.

2.6 Culturally Responsive Pedagogy: The school successfully implemented the Kimochis SEL curriculum in TK–2. The next step is refining a stronger SEL approach for grades 3–5 in 2026–2027.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 2.1 High Quality, Research-based Curriculum budgeted expenditures \$ 43,808 and estimated actuals \$ 37,811 difference was due to Core curriculum expenses being lower than budgeted.

Action 2.4 Instructional Coaching budgeted expenditures \$ 224,248 and estimated actuals \$ 194,930 difference was due to Instructional coaching being primarily conducted by Assistant Principals. This school had fewer AP's on staff this year vs. budget, resulting in lower instructional coaching expenses.

Action 2.5 Teacher Credentialing budgeted expenditures \$ 8,845 and estimated actuals \$ 14,956 difference was due to more credentialing support needed for teachers than initially expected, and higher than anticipated costs from external partnership with Reach University.

The High Quality, Research Based Curriculum, Professional Development, Assessments, Data Days, Coaching, and Culturally Responsive Pedagogy actions were highly effective as evidenced by our strong implementation of adopted standards including ELD standards, combined with excellent instructional materials provided to all students, and by our assessment results (see Goal 1) which show growth and progress toward our targets. The Teacher Credentialing action was highly effective as evidenced by the Number/% of total and EL teachers credentialed & properly assigned: 100%.

Action 2.1 has been modified to describe the Rocketship approach as grounded in the “Science of Reading” instead of “Balanced Literacy.” Additionally, language was modified to indicate that the school will be in the second year of CKLA implementation and is adding Tools of the Mind to support our youngest students in the development of self-regulation skills.

Action 2.5 has been modified to describe the expanded opportunities available for teachers and staff to progress towards earning a teaching credential.

For 26-27, we will be refining our approach to CK Integrated for grades 3-5, CKLA Knowledge for K-2 in the second year of implementation to pair with CKLA Skills which has already been in place. 2.2	Professional Development	Professional Development is a critical component of the RFZ program. We will continue to implement a comprehensive program of professional development informed by data and best practices in order to continually improve and progress toward our goals. We will continue to build on the increased differentiation of professional development for teachers and leaders to better meet the adults where they are at. We will adapt the content of professional development as needed, based on the needs of our students, and we will adjust summer professional development for each subsequent year to better prepare teachers and leaders to meet the needs. Summer PD Each summer, RFZ hosts an intensive three week summer training for all teachers that emphasizes foundational knowledge in culture and classroom. We provide training in classroom management and effective planning, including daily lessons, units, and yearlong plans. We also introduce foundational components of the Rocketship program, including the use of data, instructional techniques, and the scope and sequence of curricula, and family engagement. Sessions are differentiated by subject and grade and focus on skill-building to maximize teacher time. New teachers attend an additional three days of orientation. Thursday PD Rocketship schools dedicate at least 200 hours throughout the school year for staff PD. We dismiss students two and a half hours early one day a week to allow for an afternoon of purposeful and customized PD and culture building for staff. The Principals and Assistant Principals at each school facilitate and organize sessions at each school, targeting the areas of development they see as most beneficial to the staff, personalizing supports for teachers. Professional Development Fund RFZ has a number of veteran Rocketship teachers who express a strong desire to continue honing their craft and developing as professionals. Goal Analysis for 2025-26

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

All Goal 3 actions were implemented as planned. Successes and Challenges: In 3.1 Operations Staffing & Development, additional training provided for operations specialists at the start of the year led to improved implementation of recess protocols, ultimately enhancing student engagement and joy. In 3.2 Facilities Maintenance, training operations staff on space-management systems has streamlined teacher access to materials and resulted in higher internal scores for physical space utilization. In 3.3 Safety Training, it has been difficult for the BOMs to

conduct the weekly safety walkthroughs, where they check all security systems on campus at random times to ensure they are being implemented as planned. Additional attention is being placed on conducting these safety walkthroughs each week to ensure regularity.

Regarding 3.4 School-wide Operational Systems & Routines, high student support needs earlier this year led to less frequent one-on-one meetings between the Business Operations Manager (BOM) and Operations Specialists. Schedules have since been adjusted to ensure all specialists receive their planned support moving forward. Survey feedback indicates that 90% of BOMs are very satisfied or satisfied with the monthly professional development provided. Operations staff also had positive feedback about the training provided during the summer and wished a similar training could occur in the middle of the year.

Action 3.1 Operations Staffing & Development budgeted expenditures \$ 568,270 and estimated actuals \$ 701,467 difference was due to additional operations support being needed, and hourly rates being higher than planned

Action 3.3 Safety Training budgeted expenditures \$ 14,077 and estimated actuals \$ 12,300 difference was due to cost of safety materials being lower than expected and Business Operations Manager (BOM) compensation costs being lower than planned.

This may include projector replacements, phasing out older models with better ones, and introducing different technology according to the needs of the site Teachers will be given a budget for purchases related to decorating their room, and/or outfitting their classroom with additional materials not covered under the instructional supply budget. 3.3	Safety Training	We annually update our school safety plan, including feedback from the police and fire departments. In alignment with these plans, we provide a full program of safety training and information to be shared with staff, students and parents. We conduct three annual safety audits to ensure that all safety procedures are being followed, and this feedback is provided to the BOM so they can act on it to ensure all protocols are being followed on campus, including streamlined sign-in procedures for all staff and visitors that provide for a timely understanding of who is entering our school. 3.4	School-wide Operational Systems & Routines	Our operations team receives feedback on their operations systems and routines three times per year. An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

All Goal 4 actions were implemented as planned.

Implementation of **4.1 Enrichment** has been challenging this year due to staffing shortages, but using tutors to support implementation has been helpful. Students love the activities provided as part of the Enrichment action. Dance class at RFZ is always a success with students really enjoying the entire experience.

In **4.2 Outdoor Education and Community Experiences**, we held successful science camp trips for grades 4 and 5, as indicated by positive student and family feedback. A challenge in 4.2 is the scheduling of the trips in the effort to balance availability and competing calendar events.

Through the **4.4 Care Corps** action, the schools are providing support to thousands of families across the network. Our Care Closet provides free clothing to 50-100 families each month and our food distribution program serves 800 families each month. Vision to Learn is screening and testing all students and those that require additional care get free glasses and/or a referral to a specialist and support throughout that process from our Care Corps Coordinators.

Additionally, 225 families graduated from Rocketship Parent University, and we added a new set of sessions this fall with the same topics but added more mental health, parenting, grieving, and financial literacy workshops. We also partnered with a technology high school in Palo Alto who donated 25 Mac laptops to our families.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

4.1 Enrichment budgeted expenditures \$ 194,340 and estimated actuals \$ 165,414 difference was due to fewer enrichment center coordinators due to shifts in staffing.

4.2 Outdoor Education and Community Experiences budgeted expenditures \$ 56,349 and estimated actuals \$ 75,591 difference was due to Science camp expenses being higher than expected.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Social Emotional Learning action was effective, as evidenced by % of student feel connected to at least one staff member (As measured by student survey) (85%), by Suspension rate for all students and all significant subgroups (0%), and by Expulsion rate for all students and all significant subgroups (0%). While we are pleased with the progress made, we plan to continue to grow our practices in SEL and school mental health, in order to address the increased needs of our students. The Enrichment and Outdoor Education and Community Experiences actions were effective as evidenced by 100% of students with access to a broad course of study. Students shared that they love the dance class offering. The Care Corps action was effective as evidenced by 93% of parents who report feeling connected (As measured by parent survey question, "My Rocketship school has a strong and committed community that actively encourages family participation"), and the portion of parents with input into decision making (Parent survey participation rate–100%).

Action 4.2 has been modified to better describe the current camp programs.

Action 4.4 service offerings have been modified in response to feedback from families regarding their needs. The Care Corps program now devotes the majority of their efforts to combatting chronic absenteeism.

4.3	Social Emotional Learning	At Rocketship Fuerza Community Prep we look to the Collaborative for Academic, Social, and Emotional Learning (CASEL) to define and describe our intentions when developing programs and measuring students' social-emotional development, the CASEL Framework identifies 5 competencies: self-awareness, self-management, social awareness, relationship skills, and responsible decision-making. Our daily schedule reflects our value of SEL as every student begins their day with a Community Meeting that blends relationship-building elements with an SEL lesson that includes prosocial skills instruction and highlights our Rocketship core values. Our Tier 1 SEL Curriculum is designed with consideration for the CASEL framework, our Rocketship core values, and culturally responsive pedagogy. Along with our SEL lessons, we have developed a community meeting framework for teachers to ensure there are relationship building opportunities for students to connect, disengage stress, make commitments, and unite as a community. In addition to the classroom level community meeting, each Rocketship campus begins the school day with Launch, which is a period of time for the whole school to come together as a community. This usually includes one of the core values being emphasized and celebrated (i.e., a "core value of the month"). During Launch, the school may also promote a particular successful student habit, such as preparedness, going above and beyond, or kindness/bullying prevention. Schools may also teach a new feature of an incentive or behavior management system. Launch is also a time to promote school-wide academic progress. School leaders may teach everyone a word or idiom of the day or celebrate progress toward achievement goals. Finally, schools may use Launch time to foster school culture and pride, and student engagement. The whole school, including the staff, may learn a song or a dance together or celebrate a particular student or classroom's recent accomplishment. Positive Behavioral Interventions and Supports (PBIS) is a framework for creating learning environments that are consistent, predictable, positive, and safe. Our school has a PBIS Team comprised of a cross-section of staff members, including teachers, school leaders, and operational and support staff members, who work to support positive behavior and behavior interventions at the school. We screen students for behavioral and social concerns using a universal screener and provide Tier 2 and Tier 3 social and behavioral support, as needed. We also utilize Wellness Counselors for individual student support and providing small group support working with the SEL curriculum and other evidenced-based and trauma-informed curriculum.	\$ 71,039	No

4.4	Care Corps	In order for our students to have the capacity to learn and grow--and the space to become life-long learners--they need to have their basic needs (e.g., food, shelter, safety) met. Our Care Corps staff regularly check in with families and teachers throughout the school year to identify families who may benefit from community support in making sure that their students' needs are all met. Care Corps staff are familiar with community resources, including those available to Rocketship families due to partnerships with community organizations, and can refer families to resources that will meet their needs. Care Corps staff follow up with families to make sure that they are successful in accessing those resources and that their students are able to come to school ready to learn. We have expanded our Care Corps program to be an internal wrap-around Community Schools program supporting families with accessing medical, dental, mental, financial, immigration, and other various services at each of our 13 Bay Area school sites. This program is an integrated student support program working to address out-of-school barriers to learning through partnerships with social and health service agencies and providers. We have four main initiatives: Food Distribution: We service 800 families every month across San Jose and East Bay. Care Closet: Free clothing families can access either at food distribution sites or on campus Rocketship Parent University: Parent workshops in evenings throughout week on topics such as parenting, digital literacy, and Know Your Rights workshops (immigration, college access, housing, for example). Health Screenings: Conduct health screenings for all students, including vision, hearing, and dental through the Healthy Kids Foundation. Partner with Bay Area Community Health Clinics to provide Rocketeers with the CA required school immunizations. Chronic Absenteeism Support and Family Engagement Our Coordinators now partner with families, coordinating and escalating attendance protocols in close collaboration with Operations Managers, Assistant Principals, Principals, and other onsite stakeholders. By actively participating in MTSS meetings, Coordinators provide a critical community-centered perspective, ensuring that family and community needs are integrated into student support planning. Goal Analysis for 2025-26

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

All Goal 5 actions were implemented as planned.

In **5.1 Family Engagement**, RFZ provided families with a calendar of school events at the beginning of the school year and as a result, there has been increased attendance at school events because families had added it to their calendars well in advance. The school also has a large number of parent volunteers, and it has been helpful to have projects prepped in advance for parents to work on when they come to the school or for them to take home and work on at their leisure. Parents appreciate the consistency of school events and communication. They would like additional events and celebrations added. The SSC council wants to get as many families involved in the school community as possible.

In **5.3 School-Family Partnership and 5.4 Los Dichos**, each of our 13 California schools now host a Family Literacy Night at a local library. This shift is inspired by the success of last year’s event with Rocketship Redwood City Prep—featuring a storytime, interactive activities, the Five Finger Rule reading strategy, and community tables. We even enrolled five new students by the end of the night! Parent survey feedback indicates that parents were very satisfied with this event, especially those families who are not often able to attend the Los Dichos events that occur during school hours.

The partnerships with the majority of libraries have been amazing with overall very strong communication and support with providing space and book giveaways for students.

There is a need to strengthen School-Family Partnerships by providing more regular communication with families about student progress using the reports provided by the various assessment systems.

In **5.5 Attendance Initiatives**, we saw success in having Coordinators and Office Managers work closely to identify chronically absent students with the highest needs. Over the past year, our work has shifted from a traditional case management model—supporting 15–20 individual cases each quarter—to a focused, systemic approach targeting Chronic Absenteeism.

Our Coordinators now partner with 40–50 families per site, coordinating and escalating attendance protocols in close collaboration with Operations Managers, Assistant Principals, Principals, and other onsite stakeholders. By actively participating in MTSS meetings, Coordinators provide a critical community-centered perspective, ensuring that family and community needs are integrated into student support planning. All Care Corps Coordinators play an essential role in maintaining Chronic Absenteeism rates low while supporting ADA increases.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 5.5 Attendance Initiatives budgeted expenditures \$ 16,758 and estimated actuals \$ 20,063 difference was due to higher personnel costs than originally budgeted.

Parent engagement, Parent Advocacy and Leadership, and Los Dichos were effective as evidenced by % of parents are involved (% parents on track to complete participation hours) (98%). Parent Advocacy and Leadership was effective as evidenced by % Home visits completed

(99%) School Family Partnership was effective as evidenced by % of parents who are satisfied with their school (reporting as agree or strongly agree on the parent survey) (94%). Parents also shared that the events calendar shared at the beginning of the year was helpful. They love our use of Parentsquare plus physical papers/stickers. 5.6 Attendance Initiatives was effective Average Daily Attendance (94%), by Chronic Absenteeism rate for all students and all significant subgroups (17% overall).

In 5.5 Attendance Initiatives, the action description has been updated to provide more detail on our program to address chronic absenteeism. We have moved away from 9 weeks of case managing 15 families to now doing outreach and support to all chronically absent families.

We also want our students to feel seen and know their whole identity is celebrated. These are meaningful experiences for the entire community to celebrate diverse cultures and build relationships in fun and engaging ways. Examples include: Día del Niño, Tet, Día de los Muertos, Lunar New Year, Black History Cultural Events, Holi, Diwali, Winter Showcase/Wonderland, Talent Show, Movie Nights, or Middle School Expo. We hold summer events, such as Family Orientation and Back to School BBQ. We also hold Rocketeer Recognition Ceremonies to celebrate student growth and achievement. 5.3	School-Family Partnership	Rocketship's school leadership team, consisting of the principal, assistant principal, and the business operations manager (BOM) and the office manager (OM), serves as the leaders of the school community. They are responsible for ensuring that a culture where parents are partners in student achievement is realized. To this end, they train and develop staff members in the practices that ensure successful parent engagement. It is their collective responsibility to ensure that home visits are completed, parent teacher conference goals are met, and that the school is on track with all parent engagement goals and responsive to parent input. 5.4	Los Dichos	Los Dichos is a parent, family, and community engagement activity where family members read stories that represent cultural and linguistic diversity of students. The books read are multilingual and teach students about various cultures and values. Each book has a dicho, or saying, that teaches a lesson to the students and reflects the story. After reading the book, parents and program facilitators lead activities and discussion on various topics such as family pride, peaceful conflict resolution, and other values. The Los Dichos program includes outreach to families, inviting them to be a part of what is happening in their students' learning. The program helps families, especially those families who speak Spanish or Vietnamese as their primary language, find pathways to help their children to improve their academic achievement and become active participants in the education of their children. The family members begin by taking an introductory course on developmental assets by a Rocketship's Los Dichos staff. Every Rocketship Fuerza student is provided personalized learning. Personalized learning is about reaching each student with the right content at the right time using the right method of instruction. - **Goal #:** Enter the LCAP Goal number for the action.
- **Action #:** Enter the action's number as indicated in the LCAP Goal.
- **Action Title:** Provide a title of the action.
- **Student Group(s):** Indicate the student group or groups who will be the primary beneficiary of the action by entering "All," or by entering a specific student group or groups.
- **Contributing to Increased or Improved Services?:** Type "Yes" if the action **is** included as contributing to meeting the increased or improved services requirement; OR, type "No" if the action is **not** included as contributing to meeting the increased or improved services requirement.
- If "Yes" is entered into the Contributing column, then complete the following columns:
 - **Scope:** The scope of an action may be LEA-wide (i.e., districtwide, countywide, or charterwide), schoolwide, or limited. An action that is LEA-wide in scope upgrades the entire educational program of the LEA. An action that is schoolwide in scope upgrades the entire educational program of a single school.  - o This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**

- o This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

Pursuant to *EC* Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - **8. Total Estimated Actual Percentage of Improved Services (%)**

- o This amount is the total of the Estimated Actual Percentage of Improved Services column.

- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**

- o This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

Local Control and Accountability Plan Instructions

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
 - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
