In the matter of Closed Session item 3A, an Interdistrict Transfer Appeal filed on behalf of a student, a motion (#2187-2) was made by Trustee Rossi and seconded by Trustee Mah to deny the appeal based on Factor 8 "The financial impact of educating

the pupil (district of desired attendance) or of losing the pupil (district of residency)," Factor 10 "Lack of space for the pupil in the receiving district" and Factor 12 "Other exceptional or extraordinary circumstances which would weigh heavily in favor of the affected school district." Motion carried 5-0-2 with President Song and member Kamei absent.

In the matter of Closed Session item 3B, an Interdistrict Transfer Appeal filed on behalf of a student, a motion (#2187-3) as made by Trustee Rossi and seconded by Trustee Di Salvo to approve the appeal for two (2) school years based on Factor 3 "A specialized and specific academic program or service, unavailable in the district of residence, but necessary to the pupil's career or academic objective," and Factor 12 "Other exceptional or extraordinary circumstances which would weigh heavily in favor of the appellate pupil." Motion carried 4-2-1 with Trustee Green and Mah voting no and President Song absent.

In the matter of Closed Session item 3C, an Interdistrict Transfer Appeal filed on behalf of a student, a motion (#2187-4) was made by Trustee Mah and seconded by Trustee Kamei to deny the appeal based on Factor 12 "Other exceptional or extraordinary circumstances which would weigh heavily in favor of the affected school district. Motion failed 3-3-1 with members Di Salvo, Rossi and Green voting no and President Song absent. A second motion (#2187-5) was made by Trustee Kamei and seconded by Trustee Mah to deny the appeal based on Factor 12. Motion carried 4-2-1 with Trustees Di Salvo and Green voting no and President Song absent.

In the matter of Closed Session item 3D, an Interdistrict Appeal filed on behalf of a student, a motion (#2187-6) was made by Trustee Di Salvo and seconded by Trustee Rossi to deny the appeal based on Factor 10 "Lack of space for the pupil in the receiving district." Motion carried 6-0-1 with President Song abstaining.

In the matter of Closed Session item 3E, an Interdistrict Appeal filed on behalf of a student, a motion (#2187-7 was made by Trustee Di Salvo and seconded by Trustee Rossi to approve the appeal for grades 9 to 12 based on Factor 12 "Other exceptional or extraordinary circumstances which would weigh heavily in favor of the appellate pupil." Motion carried 7-0.

In the matter of Closed Session item 3F, an Interdistrict Appeal filed on behalf of a student, a motion (#2187-8) was made by Trustee Rossi and seconded by Vice President Chang to deny the appeal based on Factor 8 "The financial impact of educating the pupil (district of desired attendance) or of losing the pupil (district of residency)" and Factor 10 "Lack of space for the pupil in the receiving district." Motion carried 7-0.

In the matter of Closed Session item 3G, an Interdistrict Transfer Appeal filed on behalf of a student, a motion (#2187-9) was made by Trustee Di Salvo and seconded by Trustee Rossi to approve the appeal for 5th to 8th grade based on Factor 5 "A severe and demonstrated hardship to parents or guardians which could affect the pupil's success in school," and Factor 12 "Other exceptional or extraordinary circumstances which would weigh heavily in favor of the appellate pupil." Motion carried 7-0.
