


## Key Findings from the Arts Education Data Project For Santa Clara County Public Schools

This brief report was compiled using information on the <u>California Arts Ed Data Project</u>. 2014 to 2018 data derived from CALPADS has been included. All data shared here reflects Santa Clara County. The California Arts Ed Data Project offers insight into county, district, and school arts enrollment. The information below represent just some of the data points available.

• In 2018, 43% of all students participated in arts education courses. This represents more than 60,067 students. This has lowered from 44% in 2014 and contrary to student enrollment increasing. The state average is 39%.

 Although most students (95%) have access to arts instruction, only 10% of students have access to the four arts disciplines as required by state education code.



 Participation in Art (17%) and Music (16%) were highest among the five artistic disciplines. Music and Art are also the most widely available of the arts disciplines.







There were 6,697 students, or 8.97%, who did not have access to any arts instruction.
 Between 2014 and 2018 there has been over a 63% decline in the number of students not enrolled in an arts class.

 The proportion of students not enrolled in arts courses was greater where the majority of students in the school were Hispanic when compared to the distribution of the total student enrollment. In 2018, Hispanic students are enrolled at 37% compared to Caucasian at 53%, and Asian at 48%.




The proportion of students not enrolled in arts courses was greater where the majority of students in the school had high designation of Free & Reduced Lunch Program (FRLP).
 32% of high concentration of FRLP schools enrolled in arts courses compared to low concentration enrollment is at 48%.






• Arts enrollment at the high school level increased 1.7% from 2014 to 2018 while arts enrollment at the middle school level declined by 2.9%.




 When looking at students in the Free and Reduced Lunch Program, High Schools with low FRLP had arts enrollment at 49% compared to high FRLP arts enrollment at 44%. In middle schools, low FRLP had arts enrollment at 46% versus high FRLP arts enrollment at 25%.
