A. SELPA Executive Director's Updates

Director Leo Mapagu reported on the following:

SELPA AU Agreement renewal:

The agreement that establishes the SCCOE as the SELPA's administrative unit (AU) will be updated to reflect the consolidation of SELPAs I, II, III, IV, & VII into NW SELPA. The new agreement will be presented to council for review/approval at the next meeting in February.

SELPA Consolidation:

 SELPA Local Plan Section B: Governance and Administration - Director Leo Mapagu presented the current governance structure of SELPAs I, II, III, IV, VII, having the Executive Council and the Representative Council of Superintendents. He asked council what their vision is regarding the governance structure for the consolidated NW SELPA. Dr. Mary Ann Dewan expressed there is consensus that all superintendents from member LEAs be represented and so there would be no need to have two sets of governing bodies. Dr. Michael Gallagher and Dr. Gary Waddell suggested

that we could perhaps start with each district being represented and adjust in the future if a subcommittee is needed. Dr. Robert Bravo inquired about the structure of similarly sized SELPAs in the state. Director Mapagu will conduct research and will present it to council at the next meeting.

- Budget Allocation Planning meetings are underway with SpEd program and fiscal administrators.
- CAC representatives have been meeting under the facilitation of Dr. Anna Marie Villalobos to work on creating consolidated Bylaws for NW SELPA CAC.

High-Quality IEP:

Our SELPA, in partnership with East San Diego County SELPA, has been identified as Special Education Content Lead in the state to help build capacity for LEAs to develop high quality IEPs utilizing best practices.
