RESOLUTION APPROVING THE CHARTER PETITION OF ROCKETSHIP TWO CHARTER SCHOOL

SANTA CLARA COUNTY BOARD OF EDUCATION RESOLUTION NO: 2026-1

RESOLVED by the Santa Clara County Board of Education, County of Santa Clara, State of California, that:

WHEREAS, pursuant to the procedures set forth in Education Code Section 47605 and its implementing regulations, petitioners for the Rocketship Two Charter School presented their Petition to establish a charter school to the County Office of Education on July 24, 2008, having been denied by the Alum Rock Union School District Board of Education on July 23, 2008; and the County Board of Education held a public hearing on this matter on August 21, 2008; and

WHEREAS, the County Board of Education reviewed the Petition taking into consideration the testimony and documents submitted, including the Rocketship Two Charter Petition to the County Board of Education; the testimony presented at the public hearing; additional materials received from petitioners, the Alum Rock Union School District and the public; and the review of County Office of Education staff; and

WHEREAS, the County Board of Education finds that the proposed charter school will offer services to pupils, and that such pupils will benefit from those services; and

WHEREAS, the County Board of Education finds that the deficiencies identified by staff review can be corrected and incorporated into a contract with the petitioner;

NOW, THEREFORE, the County Board of Education does hereby approve the petition, and does hereby grant the charter, with the stipulation that the charter granted by the County Board of Education differs from the original petition document in the following respects:

- 1. The charter document approved is the document entitled *ROCKETSHIP TWO ELEMENTARY SCHOOL CHARTER PETITION* document presented to the County Board of Education dated July 24, 2008 to the extent consistent with the MOU.
- 2. The charter is approved for an initial period of three years of school operation, commencing July 1, 2009 and continuing through June 30, 2012.
- 3. The County Board of Education directs the County Superintendent of Schools to negotiate a contract with Rocketship Two Charter School consistent with the Santa Clara County Office of Education Administrative Regulation 6234. Failure to successfully negotiate such a contract by December 17, 2008, shall be considered grounds for revocation of the charter.

RESOLUTION NO: 2026-2

WHEREAS, Berryessa Union School District has not been funded adequately by the State to provide a quality educational program, and the District is committed to maintaining a balanced budget; and

WHEREAS, Berryessa Union School District is facing severe budget cuts due to state reductions in education funding and is 30th of 32 districts in our County in funding; and

WHEREAS, Berryessa Union School District has already cut district administration by 40%, eliminated teaching positions, reduced counseling, reduced library hours, reduced after school tutoring, reduced support for students learning English – and even with these cuts, Berryessa schools face a \$1.3 million deficit.

WHEREAS, the Berryessa Union School District has exhausted all feasible means of generating funds and without a parcel tax the District would be forced to significantly reduce basic educational services with an direct impact on the quality of instruction available to local students; and

WHEREAS, the Berryessa Union School District Board of Education has determined, in its best judgment, that in order to maintain quality education in Berryessa, stable locally-controlled revenue from a parcel tax is necessary; and

WHEREAS, the Berryessa Union School District Board of Education voted to place Measure W on the ballot to retain qualified teachers and avoid layoffs, maintain reading and math specialists, keep school libraries open, provide hands-on science instruction, update and expand classroom technology, and fund programs that enhance student achievement; and

WHEREAS, Measure W will cost homeowners \$79 per year and last five years with an exemption available for seniors to ensure this measure is not a burden to those living on fixed incomes; and

WHEREAS, every penny raised by Measure W will stay in Berryessa to benefit our children and No money can be taken by the State or used for administrator salaries; and

WHEREAS, an independent citizens' oversight committee and annual audits will ensure Measure W funds are spent properly; and

WHEREAS, good schools protect property values, which is more important now than ever;

NOW, THEREFORE, BE IT RESOLVED, that the Santa Clara County Board of Education endorses Measure W and encourages voters to support it on Election Day, thus continues their strong support of Berryessa Union School District's school funding.

WHEREAS, Measure P will be a reduction in taxes to homeowners in Gilroy Unified School District from \$70.50 to \$60.00 per \$100,000; and

WHEREAS, Measure P will not be assess until 2012; and

WHEREAS, every penny raised by Measure P will stay in Gilroy Unified School District to benefit our children and no money can be taken by the State; and

WHEREAS, an independent citizens' oversight committee and annual audits will ensure Measure P funds are spent properly; and
