3. Report of actions taken in Closed Session

Dr. De La Torre introduced the annual board compensation increase per California Education Code 1090. Board members deliberated on a compensation increase. Member Green inquired if she could give her stipend to some department in the district or program within the district. Dr. De La Torre replied saying that yes this could be arranged.

MOTION #2110-10 by Vice President Chang to approve a 5% stipend increase to the Board effective January 1, 2013. Member Di Salvo seconded the motion and it carried unanimously.
