The Board asked clarifying questions and deliberated.

John Yeh, from the law firm of Burke Williams & Sorenson LLP, and legal counsel for San Jose Unified School District, raised concerns about the proposed Memorandum of Understanding, stating that the County Board of Education was legally required to take action on the Petition before it that evening. The Board's General Counsel Maribel Medina clarified for the records, that the SCCOE Board had determined that Sunrise Middle School charter met at least one of the required criteria in the Education Code, specifically that Sunrise Middle School's academic performance was at least equal to the academic performance of San Jose Unified School District. The MOU, agreed to by the charter was above and beyond the statutory requirements and therefore was permissible.

MOTION #2135-5 by member Di Salvo to approve the charter petition from Sunrise Middle School to renew the charter for a five-year term on July 1, 2014, and as agreed to by Sunrise Middle School, requiring an MOU with the SCCOE, which will include a presentation before the SCCOE Board of Education in two (2) years. Member Hover-Smoot seconded the motion and the vote carried 5-2 with Vice President Green and member Song voting no.
