RESOLUTION APPROVING THE CHARTER PETITION OF UNIVERSITY PREPARATORY ACADEMY

SANTA CLARA COUNTY BOARD OF EDUCATION RESOLUTION NO 1084-1

RESOLVED by the Santa Clara County Board of Education, County of Santa Clara, State of California, that:

WHEREAS, pursuant to the procedures set forth in Education Code Section 47605.6 and its implementing regulations, petitioners for the University Preparatory Academy Charter School presented their Petition to establish a charter school to the County Office of Education on June 5, 2006; and a public hearing on this matter was held on July 12, 2006; and

WHEREAS, the County Board of Education reviewed the Petition taking into consideration the testimony and documents submitted, including the University Preparatory Academy Charter Petition to the County Board of Education, received June 5, 2006; the testimony presented at the public hearing held on July 12, 2006; additional materials received from petitioners and the public; and the review and recommendations of County Office of Education staff; and

WHEREAS, the County Board of Education finds that the proposed charter school will offer services to pupils who have performed at an average or below average level, and that such pupils will benefit from those services; and

WHEREAS, the County Board of Education finds that, due to the unique location and provisions of the proposed school facility, and the desire of petitioners to serve students from multiple districts, the pupil population of the proposed school cannot be served as well by a charter school that operates in only one school district in the county; and

WHEREAS, the County Board of Education finds that the deficiencies identified by staff review can be addressed by corrections and additions to the charter petition materials and incorporated into the standard County Office of Education Memorandum of Understanding;

NOW, THEREFORE, the County Board of Education does hereby approve the petition, and does hereby grant the charter, with the stipulation that the charter granted by the County Board of Education differs from the original petition document in the following respects:

- 1. The charter document approved is that found on pages 4 through 50 of the charter petition received on June 5, 2006.
- 2. The charter is approved for an initial period of three years of school operation, commencing July 1, 2007 and continuing through June 30, 2010.
- 3. Petitioners must revise the school's Plan for Student Academic Performance, Recruitment and Enrollment Plan, Personnel Policies, Safety and Facility Plan and Plan for English Language Learners to address the issues raised by SCCOE staff, and must submit the revised plans and policies to the County Superintendent of School, and obtain the approval of the County Superintendent of Schools in the form of a signed Memorandum of Agreement (MOU) that incorporates the revised plans. The County

Board of Education directs the County Superintendent of Schools to negotiate such a MOU with University Preparatory Academy Charter School consistent with the standard MOU established by Santa Clara County Office of Education Administrative Regulation 6234. Failure to

successfully negotiate such a MOU by December 1, 2006 shall be considered grounds for revocation of the charter.

RESOLUTION

CALLING ON THE LEGISLATURE TO SUPPORT SENATE BILL 1193 WHICH ENCOURAGES STUDENTS TO EXPERIENCE DEMOCRACY FIRST-HAND BY VOLUNTEERING AT POLLING PLACES ON ELECTION DAY WHILE STILL ALLOWING SCHOOLS TO RECEIVE AVERAGE DAILY ATTENDANCE (ADA) FUNDING.

RESOLUTION No. 1084-2

WHEREAS, existing law authorizes a pupil to be excused from school for specified reasons, including for the purpose of serving as a member of a precinct board for an election, and

WHEREAS, existing law provides that excused absences for those specified reasons are, nevertheless, absences for the purpose of computing Average Daily Attendance (ADA) and do not generate state apportionment payments, and

WHEREAS, Senate Bill 1193, for purposes of computing the average daily attendance generated by a pupil enrolled in a history or social science course required by a school district as a condition of receipt of a high school diploma, deems a pupil serving as member of a precinct board for an election to be under the immediate supervision of the certificated teacher of the history or social science course as defined in Education Code Section 46300, and thus would exempt that absence from the computation of average daily attendance, and

WHEREAS, Senate Bill 1193 encourages high school students to experience democracy first-hand by volunteering at polling places on Election Day.

THEREFORE BE IT RESOLVED that the Santa Clara County Board of Education call on the Legislature to support Senate Bill 1193.
